#### Medical Treatment

I give permission to the BGCSLC to seek emergency medical treatment for my minor child if I cannot be reached. I will be responsible for any/all costs of medical attention & treatment.

#### Data Collection

### **COMPUTER LAB & SAFETY ON THE INTERNET**

Our Club has excellent technology resources for our members. We strive to maintain and promote the positive usage of the hardware, software and access to the internet. As a member and as a parent, please take the time necessary to review these guidelines. It is important that these rules be understood and followed for the good of each member and the good of the Club. If you have any questions about this agreement, please contact us.

- I will use my Club's computers, associated hardware and software with care to help prevent damage. I understand that food and/or drink are not permitted in the computer lab.
- I will respect the Club's staff. They are here to provide a safe and positive place for me and my fellow members to have fun and to learn.
- I will participate in orientation or internet safety classes as required.
- I agree that the Boys & Girls Club of South Logan County has the right to monitor how I use the Internet to help keep me safe. The Club may limit access to computer games at times in order to promote more educational alternatives. The Club may limit access to games that we deem to be inappropriate for any reason.
- I will not hide or keep any private information on Club computers or devices.
- I will not create personal user profiles that are password protected on Club Computers.
- I will not bring any personal media, CD's, DVD's, game discs, etc. to use on Club computers. If you need to
  use a club computer for homework, you may use a USB drive to save documents or information with the
  approval of the staff person in the program area.
- I will not access another Club member's work, files, or personal accounts.
- I will not download or install any software on a computer without first discussing it with the proper staff. I understand that there is a risk of computer viruses or inappropriate content with many websites.
- I will not use personal email, instant chat, social media services, messaging services, chat rooms, game chat, etc. to communicate with anyone outside the Club facility, including my friends. There are no exceptions to this rule.
- I will not access social media sites on Club computers.

- I will keep my identity private by never sharing personal information such as my full name, my mailing address, my telephone number, my picture, the name of my Club or school, or any other information that could help someone determine my actual identity. I will never reveal any personal information about my friends or family. I will not meet with anyone in person that may have contacted me online. I will inform my parents or staff if someone tries to contact me in this way.
- I will tell a staff member if I see or read anything that makes me feel scared, uncomfortable, or confused. I will not try to access any website that is inappropriate contains profanity or rude language, indecent pictures, dirty jokes, depicts death or killing, and even some cartoons that are not meant for children.
- I will respect other people's rights, including copyright laws that prohibit downloading music, videos, pictures, games, movies or other media that have not been given to the public for free.
- Our Club recommends adherence to age limitations for games or websites.
