Media Release from the Hernando County Sheriff's Office

Royal Highlands Appliance Thief Caught on March 18, 2010

Detectives from the Hernando County Sheriff's Office have apprehended a subject who is believed to be responsible for committing numerous burglaries and thefts of appliances in the Royal Highlands area of Hernando County.

In a proactive initiative to catch the person (s) responsible for the burglaries and thefts, Hernando Deputies placed bright green **WARNING** stickers on houses that were under foreclosure or vacant telling would be thieves that the property may be monitored by GPS tracking devices. As warned, at some of the houses Detectives installed an undetectable tracking device on the appliances. This innovative investigative method paid off on March 16, 2010 when the above listed subject broke into a vacant home at 12080 Sandpiper Ave and removed a refrigerator and stove complete with a GPS tracker.

The device was tracked to **LANDER**'s home at 4051 Longbranch Ct. in Spring Hill. Unbeknown to Detectives, **LANDER** had listed the appliances for sale on Craigslist and on March 17th a person showed up **LANDER**'s residence, purchased a refrigerator and drove away. Detectives were able to confirm that it was the same refrigerator that was stolen from the Sandpiper house because the tracking device lead them to the home of the purchaser, identified as Arthur Craig of 1324 Carlton St. in Spring Hill. Mr. Arthur Craig confirmed that he found the ad for the refrigerator on Craigslist and paid **LANDER** \$225.00 for it. Mr. Craig did not know the refrigerator was stolen and is not involved in any crime. The Detectives removed the stolen refrigerator from Mr. Arthur Craig's property.

On March 17th, Detectives made contact with **LANDER** at his residence and discovered the stove stolen from the house on Sandpiper Ave in **LAN-DER's** garage. The serial number tag had been taken off the stove which interestingly enough had been recorded by the Detectives when the GPS device was placed in the refrigerator.

LANDER admitted to burglarizing approximately 14 residences within the Royal Highland area of Hernando County and specifically targeted kitchen appliances. According to Detectives, **LANDER** said that he was posting and selling the appliances on Craigslist; an online web site used to list items for sale. Detectives said they were told that he solely supported his family by selling appliances for at least the past year. **LANDER** is reportedly cooperating with Detectives and showing them some of the homes he remembers burglarizing.

According to Detective Sergeant Jeff Craft along with Detectives Ignacio Velez and Mike Little, who has been working on this case, checks of Craigslist lead them to 35 appliances that **LANDER** has listed and sold on the website in just this month alone. The investigation into **LANDER's** involvement in burglaries and thefts in the Royal Highland area is continuing.

The Deputies will continue to tag the vacant and foreclosed home with the **WARNING** stickers and randomly employing the use of the GPS device in appliances. The **WARNING** stickers were supplied by Hernando County Crime Stoppers, Inc in a joint effort to stop the burglaries and thefts in Hernando County.



Materials Recycled at local Convenience Centers

Aluminum Cans

Clothing and Textiles

Cardboard - All types, flattened, corrugated. Can be placed in newspaper bin if separate bin is not available.

Foam - Re-bond or Prime foam carpet padding, polyurethane foam pillows or cushions.

Newspaper - Newspaper and paper bags.

Mixed Paper - Office Paper, magazines, telephone books and junk mail.

Plastic - Milk, water, soda, and detergent bottles (#1 & #2)

Scrap Metal & Steel Cans

What can be recycled in Hernando County?

Newspaper – Please take it out of the plastic bag before placing in the recycling bin. The bags are not recyclable with the newspaper, but can be recycled with the plastic shopping bags at your local grocery store.

Cardboard – Please flatten boxes. Remove any packing material inside the box. Large boxes must be cut down to the dimensions no larger than 3' x 3'. Cereal, cracker, pizza (without food), and similar boxes are also acceptable.

Plastic #1 and #2 bottles - (No motor oil containers). This includes food containers such as cooking oil and salad dressings; personal care products like shampoo or lotion; cleaning products such as window cleaner, laundry detergent, floor cleaner; and, of course, soda, milk and water bottles. If unsure whether the plastic bottle is recyclable, look on the bottom for a triangle. If the number inside of it is a #1 or #2, then it is recyclable.

Aluminum cans

Steel cans - Labels do NOT have to be removed.

We do ask that all containers be rinsed. For those concerned with using excess water to rinse containers, a simple solution to rinsing peanut butter jars is to put it in your dishwasher when you wash your next load of dishes - No extra water expended.

Minutes Board Meeting— February 11, 2010

-Report given that all minutes from previous meeting have been placed on line for the residents of WW to view

Beautification Committee Report

-Dave J reported the following:

-shrubs on left side of blvd have been removed as they are dying/dead

-clean up of the front entrance at US 19 has been going well and many plants/trees/greenery has been removed which was needed due to years of abuse and overgrowth

-air potatoes and stink weed is now coming under control as the lawn maintenance crew is thinning out areas and is able to adequately spread and spray killer -current work is being done to the south side of the entrance off US19 as most of the shrubbery is over 15 yrs old – some will need to be replaced -new street light is being erected at the front mail boxes

ARC Committee none to report

Treasurer Report:

-we are taking the most conservative approach as related to non construct fees

-non construct assessments were mailed out

-currently have 37 of these accounts

-all money has been pro-rated based on a calendar year change to Jan 1 to Dec 31 – pro-rated fees go up to Dec 2010.

-change to assessment structure – we are now sending out both annual assessment and non construct fees at the same time per legal advice of WW HOA Lawyer \$71,440.56 in outstanding HOA invoices - \$16,084.52 is outstanding HOA dues.

General Discussion:

- WW HOA is currently having issues with getting access codes for the Enclave
- Motion made to pursue gate code access via legal avenue with WW HOA lawyer In Favor all Against none
- Motion made to have the previous WW HOA lawyer send the current WW HOA lawyer \$5000.00 to be put into a Trust Fund
- WW HOA wants to see a copy of the current liability insurance being held for roadways/common areas by the Enclave
- A letter is to be sent to our WW HOA lawyer to immediately send out a cease and desist on having Al Garcia or any other Enclave representative collect non construct fees
- WW HOA to send out revised invoices and a copy of the legal letters stating that fees/dues are due to WW and not Enclave. Residents are responsible to pay WW HOA and can take this up with Enclave board if they feel they are being duped.
- Motion made to send out and combine both annual dues and non construct fees on the same schedule In Favor all Against none
- Motion made to follow up with 45 day letters and start immediate Liens on peoples property/homes In Favor all Against none
- Concern over possible dog breeder in WW and that he/she may have 8+ dogs
- Deed restrictions will be addressed and if required a visit will be made to inform the resident of the rule
- Motion Made to have the entire board act as the Deed Restriction committee for the next 2 years In Favor all Against none
- Board decided that it may be best to have a lawn service company come in to give a talk about how people can save their lawns, shrubs etc. as well maybe get a bargain rate on mass quantities of sod if many of the residents are going to be needing it.
- Board will contact the Brooksville Co-Op for possible assistance
- WW Decals (reflective) stickers designed to be able to make out who/what cars are part of the WW environment. Prices to print 1000 stickers 3x4 = .39 each and 2000 stickers 3x4 = .29 each
- Stickers will be available free of charge at the Spring Fling and at all meetings thereafter. Stickers will not be available at board members homes Meetings Only!!
- Motion made to purchase 2000 stickers In Favor all Against none
- WW is hosting a SPRING FLING

Who Needs your Financial Passwords................Most people know they should not give out their financial passwords. But it is a good idea to let the person who will serve as executor or to whom you gave power of attorney, have ahead of time, all the passwords needed to manage your affairs. As a backup, make a list of your financial passwords (along with the names of the institutions, contact names and phone numbers) and leave it in a safe-deposit box, telling your executor or whoever has your power of attorney where the key is located. Notify the bank ahead of time for them to be allowed access to the box. They should also know the common identity questions such as your mother's maiden name, the town where you were born and any other pertinent information you would have used in setting up accounts—for example, the name of your favorite pet. This info makes it easier for the person handling your affairs.

Protection for you and your home: A few safety tips for you from a Burglar !!

13 Things Your Burglar Won't Tell You:

- 1. Of course I look familiar. I was here just last week cleaning your carpets, painting your shutters, or delivering your new refrigerator.
- 2. Hey, thanks for letting me use the bathroom when I was working in your yard last week. While I was in there, I unlatched the back window to make my return a little easier.
- 3. Love those flowers. That tells me you have taste and taste means there are nice things inside. Those yard toys your kids leave out always make me wonder what type of gaming system they have.
- 4. Yes, I really do look for newspapers piled up on the driveway, and I might leave a pizza flyer in your front door to see how long it takes you to remove it.
- 5. If it snows while you're out of town, get a neighbor to create car and foot tracks into the house. Virgin drifts in the driveway are a dead give-away. (We don't have to worry about this one, but maybe you have a relative that lives in the cold snowy weather).
- 6. If decorative glass is part of your front entrance, don't let your alarm company install the control pad where I can see if it's set. That makes it too easy.
- 7. A good security company alarms the window over the sink, and the windows on the second floor, which often access the master bedroom, and your jewelry. It's not a bad idea to put motion detectors up there too.
- 8. It's raining, you're fumbling with your umbrella, and you forget to lock your door, that's understandable. But understand this: I don't take a day off because of bad weather.
- 9. I always knock first. If you answer, I'll ask for directions somewhere or offer to clean your gutters. (Don't take me up on it.)
- 10. Do you really think I won't look in your sock drawer? I always check dresser drawers, the bedside table, and the medicine cabinet.
- 11. Helpful hint: I almost never go into kids' rooms.
- 12. You're right: I won't have enough time to break into that safe where you keep your valuables. But if it's not bolted down, I'll take it with me.
- 13. A loud TV or radio can be a better deterrent than the best alarm system. If you're reluctant to leave your TV on while you're out of town, you can buy a \$35 device that works on a timer and simulates the flickering glow of a real television. (**Find it at fakety.com**)

8 MORE THINGS A BURGLAR WON'T TELL YOU:

- 1. Sometimes, I carry a clipboard. Sometimes, I dress like a lawn guy and carry a rake. I do my best to never, ever look like a crook.
- 2. The two things I hate most: loud dogs and nosy neighbors.
- 3. I'll break a window to get in, even if it makes a little noise. If your neighbor hears one loud sound, he'll stop what he's doing and wait to hear it again. If he doesn't hear it again, he'll just go back to what he was doing. It's human nature.
- 4. I'm not complaining, but why would you pay all that money for a fancy alarm system and leave your house without setting it?
- 5. I love looking in your windows. I'm looking for signs that you're home, and for flat screen TVs or gaming systems I'd like. I'll drive or walk through your neighborhood at night, before you close the blinds, just to pick my targets.
- 6. Avoid announcing your vacation on your Face book page. It's easier than you think to look up your address.
- 7. To you, leaving that window open just a crack during the day is a way to let in a little fresh air. To me, it's an invitation.
- 8. If you don't answer when I knock, I try the door. Occasionally, I hit the jackpot and walk right in.

Here is another suggestion: Wasp Spray

A receptionist in a church in a high risk area was concerned about someone coming into the office on Monday to rob them when they were counting the collection. She asked the local police department about using pepper spray and they recommended to her that she get a can of wasp spray instead.

The wasp spray, they told her, can shoot up to twenty feet away and is a lot more accurate, while with the pepper spray, the assailant has to get too close to you and could overpower you. The wasp spray temporarily blinds an attacker until they get to the hospital for an antidote. She keeps a can on her desk in the office and it doesn't attract attention from people like a can of pepper spray would. She also keeps one nearby at home for home protection.

Money Saving Cleaning Tips.....

Sparkling Clean Mirrors: Your bathroom mirror won't fog up if you clean it with canned shaving cream and it will be streak free!

Remove Hard Water Buildup: Pour some white distilled vinegar in a plastic bag and place the bag around the shower head so the head is completely submerged. Tie the bag around the pipe and let the shower head soak overnight. Come morning the shower head will spray like new.

Sticky Situations: Remove sticky price tags and stickers from glass by spraying the surface with WD40 that you likely have in the garage. It comes right off!

Stainless Steel Appliances: Bring back the shine to your stainless steel appliances and clean them at the same time by using a soft cloth sprayed with a little WD40, and then buff to a like-new shine.

Cleaner Sponges: Each time you run your dishwasher, toss the sponge on the top rack and let it go along for the ride. Or you can rinse the sponge and (while it is still wet) zap it in the microwave for 1 minute. (Be sure there aren't any metal fibers in the sponge.)

Donato's Dishes: **Beef and Bulgur Pilaf with Mint**

Ingredients:

4 tablespoons extra virgin olive oil

1/4 cup pine nuts

8oz lean ground beef

- 1 1/2cups medium grain bulgur
- 3 1/2 cups chicken broth
- 1 medium zucchini diced
- 1 1/2 teaspoon salt

Fresh ground pepper

2 cups cherry or grape tomatoes

2 scallions, green and white part

1/4 cup chopped fresh dill

1/4 cup fresh mint coarsely chopped

1 clove garlic

Finely grated zest of lemon and squeeze lemon for 2 table spoons juice

Prepare tomatoes, scallions, and the rest of salad while bulgur cooks. Heat olive oil and pine nuts in a pot over medium heat, stirring occasionally until pine nuts are toasted (about 2 minutes). Add ground beef; shred it and stir until beef is no longer pink. Sprinkle some All Spice while stirring. Stir in bulgur and cook until lightly toasted, about 3 minutes. Add chicken broth, bring to boil, maintain gentle simmer. Then add zucchini on top, do not stir - it will steam on top. Add salt and pepper to taste. Cook uncovered until bulgur is tender (about 10 to 12 minutes). Meanwhile, half the tomatoes and thinly slice the scallions toss them with the dill, zest, lemon juice, garlic, and mint. Add 2 tablespoons of olive oil and touch of salt and pepper. Mound the pilaf and spoon salad over evenly. Serve warm. Enjoy!
