HOW TO JOIN THE E.F.L.

Teams interested in joining the Eastern Football League can obtain the necessary information by contacting George E. Murphy, Commissioner, at (617) 729-4840

Teams joining the EFL must have a home field with lights for night games. Locker and shower facilities must also be available for both the home & visiting team.

New franchises must pay a new franchise fee of \$3,000 and post a \$1,500 performance bond. After completing one successful season a partial refund of the performance bond will be returned to the franchise.

The EFL holds its winter/weekend meeting in January or February at which time prospective new teams will be accepted into the league based on the franchise committee screening report.
