

# RESTAURANT KEVIEW

### "ALL ABOARD" For Great Dining



We recently had lunch with a friend we had not seen for a few years. He suggested we meet at the Frisco Bar and Pub in Webster Groves. It was a marvelous choice.

The Frisco started life as a general store decades ago for Webster Groves and the Old Orchard Station on the Frisco Rail line. It is now a perfect example of a neighborhood corner bar that is also a great restaurant. The layout includes the bar room, the dining hall, an upstairs area with casual seating, and a beer garden and a rooftop patio.

The menu reflects the familiar Midwestern dishes of kitchens from Missouri to Michigan so there are a lot of familiar items. You will also find some delicious international items as well. Most dishes are made from scratch with in-house fresh baked breads and roasted meats.

We felt right at home as soon as we walked in the door. We were quickly seated and our friend said our waiter has been there since they opened over five years ago. All of the staff seemed to enjoy working there.

The menu is extensive. It is loaded with regular items like burgers, salads, wings, a few vegetarian items, BUT, there are a large number of very unique items as well. Many dishes made me think we might be in Minnesota or North Dakota. Potato pierogi, potato and mushroom pasty, smoked whitefish dip, a perch sandwich, pretzels with beer cheese and more.

There are a few items that give a nod out to European heritage such as kielbasa, salsiccia, a reuben sandwich, a pastrami sandwich, and gnocchi with seasonal veggies, charcuterie boards, and a Canadian favorite, poutine, comes in two different varieties. The list goes on and on.



### Jake's Steaks **Blackened Chicken Linguini**

Source: St. Louis Post-Dispatch, May 29, 2002

Yield: 4 servings

Ingredients

1/2 lb dry linguine or 3/4 lb fresh

1 1/2 lb skinless, boneless chicken breasts

**Blackening Spice (see recipe)** 

3/4 poblano pepper, seeded & thinly sliced (about 1 cup)

2 tsp olive oil

### **Roasted Red-Pepper Cream (see recipe)**

Shredded Parmesan cheese, for garnish Chopped parsley, for garnish

### Preparation

Cook linguine according to package directions; drain and set aside.

Rinse chicken and pat dry; season heavily with Blackening Spice. Grill until cooked through. Slice thinly; set aside.

In a very large skillet, saute poblano strips in olive oil over high heat for about 2 minutes. Add Roasted Red-Pepper Cream and chicken slices; cook about 5 minutes, until sauce is slightly reduced and thickened. Add cooked linguine; toss well. Top each serving with shredded Parmesan and parsley.

### **Roasted Red-Pepper Cream**

3 cups heavy (40 percent) cream

- 3 Tbsp half-and-half
- 1 (7- to 8-oz) jar roasted red peppers, drained (about 1 cup)
- 1/3 cup grated Parmesan cheese
- 2 1/2 Tbsp chicken base (concentrated soup sold near broth and bouillon)
- 2 1/2 Tbsp Blackening Spice (see recipe)
- 3/4 tsp dried basil
- 3/4 tsp granulated garlic

Combine cream, half-and-half, roasted peppers, cheese, chicken base, Blackening Spice, basil and garlic in blender; process until smooth. (If your blender isn't big enough, process 1 1/2 cups cream with the other ingredients, then transfer to bowl and stir in remaining  $1 \ 1/2 \ \text{cups cream.}$

- 1 1/8 tsp ground white pepper
- 1 1/8 tsp ground black pepper
- 3/4 tsp dried thyme

3/4 tsp dried oregano



## **Brentwood Board of Aldermen Minutes**

### **PUBLIC HEARING**

Mayor Dimmitt gavel opened the public hearing and read the statement "The Board of Aldermen of the City of Brentwood, Missouri, will hold a public hearing pursuant to Chapter 353 of the Revised Statutes of Missouri and Ordinance No. 4302 of the City, as amended, to consider the approval of the proposed Manchester Road Corridor Redevelopment Area Development Plan." The mayor then invited Joel Oliver (Greenstreet) to the podium for his presentation.

Joel shared the same presentation that was given at the June 21, 2023, Brentwood Redevelopment Corp. Meeting (353 Board). He stated that the real estate market is changing, and Greenstreet heard and understood from comments that we want to maximize the entrance to the park, so they have presented a slightly adjusted plan with a destination entertainment complex for that section.

He showed a 2-minute animation (available in BoardDocs) with all the buildings and uses, with an internal road that parallels Manchester to pull cars off of that street. With the small changes made, they feel this is a great executable plan that is very similar to the first one. He shared a timeline and some concepts for destination entertainment with pictures of possible beer gardens.

Lindsey Evans (PGAV) was then invited to share a synopsis of her presentation from the June 21st Redevelopment meeting regarding the Tax Impact Analysis and incentive Package. (Information also available in BoardDocs). She shared that the incentive package for property tax abatement and the tax impact analysis estimates the overall impact on each real property and commercial surcharge taxing district (analysis does not include impact on personal property tax revenue, sales tax or other tax types). It compares a build vs. no build scenario and looks at what would be abated on new builds and what would still be collected if no change and analyzes net new revenue to each of the taxing districts as part of the analysis.

The larger incentive package also includes a 1% CID and a 1% TDD sales tax in addition to taxes in the area (2% total). It also includes a CID special assessment, a Chapter 100 sales tax exemption on construction materials and a \$1Million public land acquisition for all developable parcels owned or to be conveyed to the city, and a "claw back" provision at year 5 as a checks and balances.

The 20-year property tax abatement for the developer is to pay for residential property at 25% for years 1-10 and 50% for years 11-20. For commercial property it is 50% for year 1-20. This is the full package.

PGAV looked at whether incentives were needed. They looked at developer risks which were land acquisition, timeline and cost, environmental remediation of buildings and land after acquisition, and the public infrastructure (development of roads, sidewalks and utilities). The value of incentives and timeline associated with the incentives is also important. The requests are still within standard range even though this is a large and ambitious project.

The project is estimated at \$425 Million with an 18% value of incentive package, and taxing districts will not receive less revenue than what is currently received. The incentive package increases the project feasibility, spreads the cost impact to those visiting the community, and minimizes the cost for residents and the local taxing districts, and provides a cohesive/balanced approach for developer and stakeholders.

Mark Grimm (Gilmore Bell) then reviewed the Development plan and detailed blight study analysis and how that led to the Redevelopment agreement. The blight study and map showed which parcels meet the criteria with 48 of 75 parcels or 63% blighted. (43 of the 49 privately owned parcels meet definition of blight under the statutes)

developer. The city then put together a negotiation team on behalf of the city (Bola Akande, Whitney Kelly, Kevin O'Keefe, Mark Grimm, and Brandon Wegge). The City's attorney's and negotiation team took extensive time to get to this point with the contract for the agreement.

Ward 4

July 5, 2023 - Tonight is the first of two readings of the Bill for this Redevelopment plan and agreement. The plan was moved up on the timeline calling for this Special Meeting due to the loss of both Ward 4 Alderpersons, who will be leaving their positions on July 17th. (Kathy O'Neill moving out of state, and Jack Shelton moving out of Ward 4) It is important to have their representation for Ward 4 as they have been involved with this project, whereas a new alderperson will not have the same level of knowledge and understanding of this project. The mayor made the decision to have the first and second readings as noted.

July 17, 2023 – will be the second reading of the Bill.

The floor was opened up to the Aldermen for comments and questions,

Alderman Plufka asked Lindsey Evans (PGAV) two questions: 1) Were the combined CID, TDD and Abatements the reason we could do the incentives for 20 years instead of the 25 years which is allowed? Lindsey responded there were several ways to look at the incentives and based upon several considerations, this seemed to be best balance for everyone. 2) Is it correct that the abatement and payments that come in the first years of the development have a floor that is set, and the tax can 't go down. Lindsey responded, "yes", that it will not be less or go down over the 20 years per the agreement.

Alderman Gould asked if there is a sunset clause on the CID and TDD, when the contract terminates, does it end? Mark Grimm responded that no CID can be longer than 27 years, so it could be longer, but the agreement states that once the project costs have been paid, they have to terminate.

Alderman Wegge when does the CID and TDD get created/or started? Mark Grimm responded that it can be created for that property or based on phases and there can be multiple ones (not one big one). It was noted that only when sales tax starts being collected is when it really begins.

Alderwoman Sims (was virtual) asked multiple questions: 1) What is the interplay between the developer and the sub- developer – Can a sub-developer abandoned this agreement to leave us dealing with someone else? Mark Grimm gave example and stated that we would expect to have a separate parcel development agreement with a sub-developer who would be responsible for that portion of the project. Greenstreet would have the parcel development agreement on every parcel, and some developments may have two- & three-party agreements with sub-developers. Kevin O'Keefe added that the sub-developer does not get relief from the obligations of the master developer (Greenstreet). They would have no different deal than Greenstreet and Greenstreet would have to see to it that all terms of the agreement are fulfilled.

Asked why a new Redevelopment Corp. is being formed (Manchester Corridor 353) instead of using the existing Brentwood Redevelopment Corp? Mark Grimm responded it is customary to set one up that is project specific, but they could have used the existing Brentwood Redevelopment Corp. Under the statute a title has to pass through a Redevelopment Corporation before any abatement can happen, so it's set up for ease, and has no long-term effect in the development. The Brentwood Redevelopment Corp. has reviewed the project and approved it to the Board of Aldermen and has no further obligation on this project.

What control, input, monitoring does the city have with regard to the properties in this area. Mark Grimm responded that the city does have control. Under the statute, the Developer cannot initiate condemnation on its own - this has to be done in the name of the city. Greenstreet also has to meet certain conditions before they can do anything,

Alderman Gould inquired about Chapter 100, asking if this means it only applies to each

The Agreement states the incentives, but there are no incentives without performance within the timeline described. It states that Greenstreet is required to offer option agreements to property owners in phase 1 within 60 days of execution of agreement, and other property owners within 18 months of the agreement, and to use its best efforts with property owners to negotiate an agreement before any condemnation is pursued. Greenstreet must acquire all property in Phase 1 by January 2025, and additional phases by July 2028. Site plan exhibit will be conceptually consistent with development. Greenstreet is required to set aside space for a police substation and UTV storage.

The "claw back" at the 5-year mark for a building that has been sold, takes the sale price of building against the total project cost and if it exceeds 20%, then there is a reduction in the tax abatement. This is the same process followed by the City of St. Louis. Again, if the developer does not perform, there are no incentives.

Mayor Dimmitt asked how long Mark has been an attorney, and if this was his first redevelopment agreement. Mark answered that he has been an attorney for over 30 years and spends most of his time on economic development incentives in many cities and this is not his first time negotiating redevelopment agreements or his first negotiation of a redevelopment agreement for Brentwood. He was involved in Brentwood Square, Dierbergs, Hanley/ Eager Road, Promenade, Hanley station and others. The record shows that Mr. Grimm has extensive experience.

For context, Mayor Dimmitt took a moment to share an abbreviated timeline for this project:

\*August 15, 2022 – a Resolution was presented to the Board of Aldermen for Greenstreet to be the preferred Master Developer of the project. The Board held off on the decision and hosted a workshop and Ward Meetings to present the information to the public and receive citizen comments.

September 2022 - the Board of Aldermen voted to appoint Greenstreet as the preferred Master

parcel and improvement during the initial construction or can it be done after building is done. Mark responded that this is on initial construction per parcel-by-parcel basis, and once a building is done, nothing else can be done.

Lois Truman (8710 Rosalie) – asked that when the city does inspections on new buildings, etc., if there is a non- compliance, who do they go to? The city attorney confirmed that it is the normal process, and they would go to the holder of the building permit.

Chris Thornton (9421 Tilles Dr) – addressed several things stating:

\*The project has changed from a financial point of view (not physical structure or square footage view) since the project was posted in June and September. He shared:

In June 2022 – Proposal was 3 Phases for \$425 Million at 90% abatement for 10 years for \$29.08M, CID for \$15.5 M for total of about \$45M in incentives. It discussed TDD as well.

In June 2023 – Proposed 3 Phases for \$425 Million at 50% abatement with pilots for 20 years – total cost of tax abatement is \$58.3 M. CID also proposed at \$15.5 and assumes the TDD is at same rate.

PGAV states that total incentives are 18% of the \$425M – which is about \$76.5 M (of which \$58M in abated taxes - that is what impacts the school district the most).

Now Mr. Thornton sees that when you add up the costs (\$58.3M abatement, 15.5M CID and \$15.5 M TDD- you get

\$89.3 Million or 21% of project cost.

\* We said we needed to take a hard line with developers, as they have gone from \$45M to \$89M in tax incentives in one year and how that is a good deal. In addition, the money we spent on flood control property is being given up for this project as well, for free. He feels this is not the best deal going for the city.

Karen Smith (Harrison) - stated she is opposed to eminent domain. The threat of this use of eminent domain, means it will be used. She also feels that the buildings that are presented are not part of the comprehensive pan. More were supposed to be interests that were supportive of the park.

She also asked who makes up the new redevelopment board, and will that board have meetings - what will they be doing? Why are we using this new board and not the 353 Redevelopment Board already established?

Laurel Ziehl - 2646 Ruth Ave. stated she has come to the conclusion this going ahead, no matter what. She does not see any compromise but knows nothing is set in stone - as many things still need to happen - FEMA has to approve flood plain, MSD has to approve plans, MoDOT has to approve traffic. She is concerned for traffic. Suggestion she has for developer - the hotel is currently across the street from her house, but there is a parcel of land empty on the NE corner of development. They should put the hotel there, instead, as it is currently slated for office space.

Mayor Dimmitt closed the Public Hearing.

### **CITIZEN COMMENTS**

Chris Thornton (9421 Tilles Dr.) stated he appreciates Alderpersons O'Neill and Shelton and noted that the Mayor appoints new members with the Board of Aldermen. He also asked the Board to please take time to thoroughly review this plan and consider other alternate strategies. He feels that long-term decisions need long-term consideration.

Lois Truman (8710 Rosalie) stated that "Timing is everything". She commends everyone for all that has been done. Her involvement and her perspective is that the alderpersons do come forward with information from their constituents and believe now is the time. This has been an ongoing project for years. Things have been diminishing and school is declining, and we now have leadership trying to maintain this and take action. She appreciates this.

Carol Jantzen (2446 Cecilia) 72 yr. resident - she thinks this project is too big. Feels Manchester Rd. is not equipped to handle all this, and it is hard to see this happening. Area is residential and should stay residential.

Anthony George- Business owner in Brentwood - stated business has been here 40 years and it is a thriving community. Thinks taking action to improve community is good. Feels that if Board is so confident of plan, then there should be a survey of citizens to confirm this confidence. Feels if recommendations of 5-years ago had fewer apartment building, limited traffic, then plan should stand true to that. Stated that while this is only developer who agreed, they were the only developer who bent rules to adjust RFP to include eminent domain. Would other developers have bid if given this same option. Asked Board to give this plan thoughtful consideration, give people a voice and time to respond and not rush.

He noted the value of the road going in - \$23 Million invested in electrical, sewer, etc. for roadway that is a corridor to move traffic, not a value to community. It's an outlet. He hopes traffic study will show that we need a turn lane, and that area cannot handle this development. He does not understand how this is an investment in the community.

He has asked for help for a year – needs help. What can be done to help residents- What is the path forward for people who live here. What is the benefit to them?

Karen Smith (Harrison) - If surveying residents and businesses - then explain the tools and the options that go along with it. She gave an example stating if you don't like the bush and want it to come out (blighted), then are you willing to have the other things that go along with taking that out - like taking out a business in area next to it as well.

Martin George (2E2A Carrot Bay, US Virgin Islands) - he is a business owner along the corridor. Spoke regarding timing and reaching out to residents. (Used to live on Helen). He did his own survey on Brentwood Facebook asking residents: Question 1) As a residential taxpayer or voter, how informed are you about Greenstreet? If you have not heard of Greenstreet and their 30-acre plot, respond with "uninformed". Of 100 votes - 70% swayed to "uninformed."

Question 2) As a resident, would you want the 40-acre floodway to be park land, etc. or additional residential units?

Of 98 votes, 85% said more park space. He stated he was kicked off the Facebook group, but the essence is timing. Time has huge value, and we need to be careful.

Amy Stanford (8506 Manchester - Time for Dinner) Asked that the board members become aware of how upset people and businesses in this area are. They have come to many meetings. Wants members to listen to them. The thought of eminent domain is crazy, and people are appalled. She is concerned that if they keep their business in the redevelopment area rent would be four times what they are paying now, and they can't make that work. They are trying to figure out how to survive. They need a parking lot near them. Feels their needs are not being taken into consideration. She asked what are the plans for the businesses to keep them in area and help keep them viable?

### **MAYOR AND ALDERMEN REPORTS**

Mayor David Dimmitt – Made a few comments in response to comments: School District - Mayor did reach out to President of School Board and let them know



there was a request for abatement, and he wanted to know their position on this. Have brought them in with the changes and they are overwhelmingly in support of this project. It is a way to generate more revenue and possibly more students.

Regarding use of eminent domain - there were no changes to RFP. Eminent domain is legal in a blighted area.

Spot redeveloping/Organic redevelopment - this does not work, which is why we are excited about having a master developer. This change is good for the city. He gave example of past area (Brentwood Blvd from Pine to Moritz) and how this is better today. He sympathizes with the uncertainty as he also experienced that during that redevelopment project, as he had to move his law building.

Trash service is being pushed back a day due to holiday. Also storm debris is being picked up free until July 11th.

Alderman David Plufka - Announced there will be Ward 1 meeting next week and then commented that the former mayor presented information during public comment that was factually incorrect. The city will not give away land to the developer for free. The developer will in fact pay a Million dollars for land that will not be used from the flood abatement plan. It was also suggested that there would be a diminishment of tax revenue that would be harmful to the school district. Lindsey at PGAV (contract consultant) has said on several occasions there will be no reduction in the base-line taxes generated by this property for the life of the abatement. But because of the abatement, the school district may see an increase over the life of the abatement. And finally, every RFP had the same mention of eminent domain. This was not the reason other developers did not bid. They did not present plans because the city did not control the property in the area, and they would have to negotiate with all the individual property owners. They did not want to take that on.

STLCC Partnership Saves Students \$36,000 in College Tuition

Brentwood High School students saved more than \$36,000 in future college tuition costs during the 2022-23 school year as part of the St. Louis Community College Dual Credit program. This collaborative effort with STLCC provides students with a variety of opportunities to earn college credit, including:

Dual Credit: Students earn college credit for classes taught by high school instructors

Dual Enrollment: Students earn college credit for classes taught by STLCC instructors

**Early College:** Students take classes with STLCC full time for two years, graduating with a high school diploma and an STLCC associate degree

Make It Count: Seniors take classes with STLCC full time during their final semester of high school and graduate with a full semester of college credit

**Career and Industry Tracks:** Dual credit and dual enrollment pathways that enable students to earn a college credential and satisfy prerequisites for admission into selective career and academic programs

"Our partnership with the STLCC dual credit program allows students who are already doing rigorous, college-level learning to also get a jump-start on a college degree and save thousands of dollars in college tuition," said Dr. Alex Tripamer, assistant superintendent of curriculum and instruction. "This program is extremely valuable to our students and we are excited to watch the program continue to grow at Brentwood."

During the 2022-23 school year, 30 BHS students were enrolled in at least one dual credit class for an estimated savings of \$36,494 in future college tuition costs. BHS offered 12 classes in the dual credit program, and students earned a total of 138 dual credit hours.



We will continue to keep you updated throughout the project as we work to create safe, accessible and future-ready learning spaces at Mark Twain.


















## Dairy Up to the Table with Family Meals

What can you do to get your kids to eat more nutritious foods, get better grades in school and have a larger vocabulary? The answer may be easier than you think. Start by enjoying family meals on a regular basis. While family dinners may seem like a burdensome chore at the end of a tiring day, the benefits of time together cannot be measured by calories alone. Family meals offer a unique opportunity to teach children valuable lessons and to influence their health positively.

"Pulling together a nutritious meal does not have to be time-consuming or hard," said Maggie Cimarolli, registered dietitian and nutrition educator with St. Louis District Dairy Council. "Parents can look to dairy foods such as milk, cheese and yogurt to pack a nutritional punch and to add flavor to a meal. These are easy foods to add because they complement many other foods, such as vegetables and fruit."

In today's world, work schedules, extracurricular activities and other interests may put family meals on the back burner. Fast food and drive-through meals have become standard dinners for many busy families. However, making shared meals a priority is important in this fast-paced society. Many families are starved for time together, and a family dinner or breakfast can allow them to reconnect, leave behind individual pursuits and really be present. Family meals provide a time to relax, recharge, laugh, tell stories and catch up on events. Plus, family mealtimes are a great opportunity to gain crucial knowledge and nutrition skills.

Better nutrition is a key benefit of enjoying meals as a family. Research shows family meals influence and improve food choices. "Dairy foods, for example, contain calcium, protein and an array of essential nutrients, and are easily incorporated into breakfast, lunch or dinner, ensuring a nutrition-packed meal to serve to your family," Cimarolli said. "Grate and sprinkle a new flavor of cheese over vegetables or stir yogurt into a fruit dip. These simple options expose children to new foods and help ensure they are getting the recommended three servings of dairy every day."

Family meals foster children's healthy growth and development, both physically and emotionally. Studies show that with regular family meals, kids are less likely to engage in unhealthy and risky behaviors, such as smoking. Parents and health professionals also note improved communication as an additional benefit. Shared family meals may also improve vocabulary and social skills, self-esteem and grade-point averages.



Making family meals a priority does not require a professional chef in the household. Focusing more on being together rather than making an elaborate meal is a good start. Additional steps include increasing the number of family meals by one meal each week. Weekly menu plans and grocery lists allow everyone to be involved in the plan. Encouraging children to make suggestions, help prepare food or set the table can also help. "Pouring milk into a measuring cup, discussing why cheese melts on a casserole, tasting different yogurt textures, or explaining that milk is a local food can help build skills and knowledge. Plus, they're great ways to get kids excited about dairy," Cimarolli said. "Last, but not least, turn off all devices including televisions, tablets and phones, and enjoy time as a family. It's worth a try, as sharing more meals together could mean large rewards for the family."





Family meals don't have to be difficult or time-consuming. Try Tuscan Chicken Mac and Cheese, a one-pan dinner made on the stovetop in less than 30 minutes! The recipe requires minimal work, simple ingredients and can help ensure your family is getting great nutrition.

Servings: 6

Ingredients:

- 4 boneless skinless chicken thigh filets
- Salt and pepper, to season
- ½ tsp. paprika
- <sup>1</sup>/<sub>2</sub> tsp. dried parsley
- 1 Tbsp. oil, divided
- 2 Tbsp. butter
- 1 small yellow onion, chopped
- 6 cloves garlic, finely diced
- 9-ounce jar sun-dried tomato strips in oil
- (reserve 2 tablespoons of oil and drain the rest)
- 3 Tbsp. flour
- 2<sup>1</sup>/<sub>2</sub> cups chicken broth
- 3 cups milk
- 2 tsp. dried Italian herbs
- 10 oz. elbow macaroni, uncooked
- 3 cups baby spinach leaves
- 1 cup fresh grated Parmesan cheese
- <sup>3</sup>⁄<sub>4</sub> cup mozzarella cheese shredded
- 1/2 cup grated cheese Cheddar or Gruyere
- 2 Tbsp. fresh parsley chopped

#### Directions

Season chicken with salt, pepper, paprika, dried parsley and 2 tsp. of the oil. Heat remaining oil in a large (12-inch) pot or pan over medium-high heat. Add chicken and sear on both sides until golden brown, cooked through and no longer pink in the middle. Transfer chicken to a warm plate, tent with foil and set aside.

To the same pan, add butter, onion and garlic and fry until onion becomes transparent, stirring occasionally (about 2 minutes). Add ½ cup of chicken broth to pan and allow to simmer for 5 minutes, or until liquid reduces down.

Add sun-dried tomatoes with the 2 Tbsp. of oil from the jar; cook for 1 to 2 minutes to release as much flavor as possible.

Stir flour into the pan and cook for one minute. Add remaining broth, 2 1/2 cups of the milk, herbs, salt and pepper. Bring mixture to a very low simmer (reduce heat, if needed). Add dry macaroni and stir occasionally; bring to a simmer. Reduce heat to medium low and stir regularly for 9 to 10 minutes, or until sauce thickens and macaroni is cooked al dente, tender but still firm. Add spinach and stir until wilted. Remove pan from stove and quickly stir in all cheeses. Add salt and pepper to taste. If sauce becomes too thick, add remaining <sup>1</sup>/<sub>2</sub> cup milk in <sup>1</sup>/<sub>4</sub>-cup increments, until reaching desired thickness. Sauce will continue to thicken as it cools. Slice cooked chicken into strips, add to pan and stir mixture thoroughly. Add any leftover juices from the chicken to the pan. Sprinkle with parsley, and stir through. Serve immediately.

## How much have you saved for a down payment?

In many cases, if you put down less than 20 percent, you'll likely be required to pay for private mortgage insurance, which can cost .15 to .25 percent of the loan amount.

If you plan to sell one home and buy another, you may be able to apply any equity in your current home toward a down payment on the new home. If you're a first-time homebuyer, taking time to aggressively save a down payment will pay off — a larger down payment will let you buy more house or make smaller monthly payments.

### What monthly payment can you afford?

Most lenders recommend that borrowers spend no more than 28 percent of their monthly income on a mortgage payment. Keep in mind that just because a lender is willing to loan you a certain amount doesn't mean that you should borrow to the limit. Write out a

budget and keep in mind that you'll need funds for home repairs, maintenance, and updates, as well as whatever else you want to spend your money on — vacations, savings, gifts, food, gas, etc. For help determining the right number for you, use an online mortgage affordability calculator (located on our website).

### What is your credit history?

Your credit score will determine whether you qualify for a mortgage and what terms you'll get if you do. Different lenders have different credit score requirements. For instance, FHA requires applicants to have a credit score of 580 or better to obtain maximum financing on typical new-home purchases, and offers some products with lesser financing for those with credit scores between 500 and 579.







PICTORIAL ST. LOUIS: The Great Metropolis of the Mississippi Valley A Topographical Survey, Drawn From Perspective 1875.

Illustrations by Camille N. Dry and designed & edited by Rich. J. Compton.

Over 220 pages of illustrations and descriptions of life in St. Louis in the late 1800's. The preliminary drawings for this work were made early in the spring of 1874. After a careful consideration of the subject, it was determined to locate the point of view so that the city would be seen from the southeast, believing that to be the most advantageous in all respects. Accordingly, the point of site was established on the Illinois side of the river, looking to the northwest, and at sufficient altitude to overlook the roofs of ordinary houses into the streets.

A careful perspective, which required a surface of three hundred square feet, was then erected from a correct survey of the city, extending northward from Arsenal Island to the Water Works, a distance of about ten miles, on the river front; and from the Insane Asylum on the southwest to the Cemeteries on the northwest.

Every foot of the vast territory within these limits has been carefully examined and topographically drawn in perspective, by Mr. C. N. Dry and his assistants, and the faithfulness and accuracy with which this work has been done an examination of the pages will attest. Absolute truth and accuracy in the representation of the territory has been the standard and in no cases have additions or alterations been made unless the same were actually in course of construction. In a few cases, important public and private edifices that are not yet finished are shown completed, and as they will appear when done.

All the buildings within the limits of the survey in July, 1875, are shown; and a very large number of those executed or commenced since that date have been also introduced, the pages having been constantly corrected up to the last possible moment before publication.







Bevin owns a hangar and a small, sleek Katana airplane. His background was being involved with TWA and Ozark airlines. This plane is not a WAR BIRD.

We spent an enjoyable day watching the WAR BIRDS taking off and landing. You can choose which plane you want to have a ride in and, of course, pay for it.\*

But, first a history of the WAR BIRDS. It started with one plane. .. then there were two planes. Lloyd Nolan and more ex-service pilots from Texas combined their money and experiences and in 1957 purchased a P-51 Mustang. Next, they added a pair of F8F Bearcats and a B29 – Superfortress "FIFIthe ";the type of plane used to drop the atomic bomb on Hiroshima. The group decided to save an example of every aircraft that flew during World War II. It wasn't just a hobby, but it became a mission to preserve them.

They named themselves the Commemorative Air Force (Ghost Squadron) with over 75 units in the United States and other countries. The CAF maintains and flies over 180 historical aircraft.
