## Sowing Gesneriad Seeds Donna Beverin

Gesneriad seeds are super small and dust like.

- •Use any soil mix you prefer. I use combination of potting soil and fine vermiculite with milled sphagnum moss lightly dusted on top of the soil mix which aids to prevent damping off. Jiffy makes a good mix for about \$5.00.
- •Moisten the soil and I let the container sit for at least 1/2 hour to be sure all the soil is moist. (not wet)
- •Many growers sterilize their soil in the microwave for 5 minutes and let it cool completely which I do occasionally.
- •Take a piece of plain white paper and divide in 1/2 twice to make a crease in the center of the paper.
- •Open the seed container very carefully over the white paper and let the seeds fall into the center crease. I like to use part of the seeds and not plant them all at the same time if there are plenty of seeds. National sometimes only sends a few.
- •Holding the white paper over the seed container I gently let the seeds roll into the soil mix as I move the paper around to spread the seeds, tapping lightly with a finger. Do not cover the seeds with soil as they need light to germinate.
- •Cover the container with a clear lid or plastic wrap. Do not allow the lid or plastic wrap to touch the soil. Label the container in any manner you prefer so you remember what variety of seed you planted.
- •Place container on your light stand. A warm area with bottom heat will aid germination. If I have a florescent light ballast I put containers on top of that where it gets bottom heat. I also use a normal heating pad sometimes.
- •Many of the seeds germinate within two weeks but some may take longer. I keep my seed containers for a long time. I have had seedling emerge months after planting. If I have a container without germination I usually turn the container into a prop box and plant cuttings. Sometimes wayward seeds germinate to surprise me. That is how I grew a tuber of Sinningia 'Anne Crowley 'x self which is one of my favorite sinningias! Some seeds grow tubers and you can see the baby tubers below.
- •Watch out for algae or fungus that can grow on the soil. Do not fertilize the soil as it is supposed to encourage algae growth.
- •Once the babies are large enough to handle with a toothpick or other tool, transplant to another container or small pot. Keep them covered depending on the plant for added humidity especially as they adjust to their new pot.

Since it is time to nominate and vote on officers for next year 2019, Donna has inserted the By-laws information to explain the duties of the various offices. The nominating committee consists of Dave Anderson, Brian Connor and Donna Beverin. A few notes in red.

#### Article V. Duties of Officers, Board of Directors, and Committees

Section 1. President. The President shall act as general executive officer of the Chapter and shall preside at all meetings of the membership and the Board of Directors; shall appoint the chairmen of all committees; shall be ex-officio a member of all committees except the Nominating Committee; and shall keep informed of all work of the Chapter and report there on to the membership.

#### Barb Stewart had offered to continue as President.

Section 2. Vice-President. The Vice-President shall perform the duties of the President in the absence of the President. The Vice-President shall schedule and prepare interesting and stimulating programs for the regular membership meetings.

#### We need a Vice President

Section 3. Secretary. The Secretary shall record the minutes of all meetings; prepare official correspondence; and compile, maintain, and have custody of the Chapter's historical records. The Secretary shall file with the Recording Secretary of the parent organization a copy of the Chapter's bylaws and all subsequent amendments; the names and addresses of all Chapter members, and of all new members; and the names and addresses of all Chapter officers immediately following their election.

Section 4. Treasurer. The Treasurer shall be responsible for the receipts and deposits of all monies of the Chapter and shall make authorized disbursements to cover the expenses of the Chapter. The Treasurer shall keep an accurate record of all monies that are received or disbursed and shall render financial reports when required.

#### Sharon has offered to stay on as Treasurer

Section 5. Directors. The Directors shall serve in an advisory capacity, shall serve as committee chairmen, and shall perform other duties requested by the President.

#### We need a few directors.

Section 6. Board of Directors. The Board of Directors shall plan Chapter activities, shall make recommendations for action to the membership, and shall transact Chapter business between regular membership meetings. The Board shall be subject to the orders of the Chapter and none of its acts shall be in conflict with actions of the Chapter.

Section 7. Hospitality Committee. This committee shall make arrangements for refreshments at the membership meetings.

#### Need a hospitality chairman as Irene cannot attend many meetings

Section 8. Membership Committee. This committee shall handle membership applications, collect dues, introduce new members and guests, provide name tags, and compile an annual roster of officers and members. There is no committee at this time.

Section 9. Publications Committee. The chairman of this committee shall be the Editor of the Chapter's newsletter, Petal Tones, and shall be responsible for editing and publishing Petal Tones in accordance with the policies of the club.

Donna will continue as Petal Tones editor. There is no committee at this time.

Section 10. Propagation Committee. This committee shall propagate gesneriads and have them available for distribution to the members.

#### Barb and Donna will continue. Anyone wanting to help is most welcome

**Section 11. Ways and Means Committee.** This committee shall be responsible for fund raising, including the sale of plants and supplies at Chapter meetings.

Brian chairs the Ways & Means.
