2. You will comply fully and completely with all rules and instructions which BGCD and Grandpappy Point Marina establishes for participation.
3. You for yourself, your heirs, executors, administrators, personal representatives and next of kin waive, release and forever discharge and hold harmless BGCD and Grandpappy Point Marina, its volunteers, officers, trustees, directors, employees, agents, successors and assigns (therein after collectively "BGCD and Host Facility") from any and all claims, actions, liability, causes of action, demands, judgments, rights, costs and expenses of whatever nature and kind you may have or may hereafter have or acquire including, but not limited to, personal injury, death, property damage or loss arising out of or in any way related to or connected with this Event and your participation therein.

You should hold BGCD and Host Facility harmless and indemnify them from all claims, actions, liability, causes of action, demands, judgments, rights, costs and expenses of whatever nature and kind brought against BGCD and Host Facility arising out of or in any way related to or connected with your negligence in your participation at this Event.
