5.04 (D) Proposal - New (D) then old (D) will follow down line to (E) and continue.

For each candidate, any fundraising done during campaigning will count toward prospective Reign responsibilities, therefore these funds must be held in account for the upcoming Reign.
5.06 (K) Proposal - (New K)

When there are multiple candidates for each category of Co-President, each category would be its own race (as outlined in general elections). When there are candidates or all 3 categories, those 2 individuals that received the highest number of votes are considered elected to the 2 available positions (Refer to Bylaws Section 5.02 A).
5.06 (K) In any category with only one candidate, they must secure majority of the vote in order to be considered elected to that position.
5.06 (O) Proposal - New (O)

Should tabulator find any tie-breaking ballot not in compliance with the guideline stated above, they must immediately bring this to the attention of the PoB, who will then contact the individual(s) not in compliance and direct them to immediately contact the tabulator to register their vote. This tabulator must alert the PoB when all tie-breaking votes are in compliance and must also make written note of the contacts/votes. The written notes are to be included with the tie-breaking folder(s).

At the close of voting, the ballot box is presented to the third-party tabulator along with the keys to the ballot box. A copy of the voting regulations are to be provided and explained, with the applicable sections highlighted.
