VIII. REPORTS OF OFFICERS AND ACTION ITEMS

A. Clerk's Report – Patti Engstrom

Clerk Engstrom stated the Village website has been updated to include a simpler way to find forms. The front page says Forms & Links, providing several different categories such as Historic Sites, Building & Zoning, FOIA, and Applications.

Clerk Engstrom provided election results for the April 4, 2023 Consolidated Election. Results in Kane County have been certified, DuPage County has finished counting but results will not be certified until April 25th. For Village President Eileen Phipps 482, Peter Mourousias 344. For Village Trustee Ed Hull 521; Pete Connolly 505; Gaetano Bevente 377; Anna Cunanan 290; Jessica Ewald 261; Ron Bowers 234; Dan Beach 127. The new Board will be sworn in at the May 2 meeting. The Village commends all the candidates for their willingness to serve our community by placing their names on the ballot. The election turnout reflected our residents' strong interest in the community.

B. Treasurer's Report – Howard Levine

1. Financial Statements as of March 31, 2023 and the Eleven Months Then Ended Treasurer Levine said finances are ahead of operating funds and \$300K ahead of budget. Revenues have increased with the exception of personnel costs.

Trustee Hull made the motion to approve the Financial Statements as of March 31, 2023 and the Eleven Months Then Ended. Seconded by Trustee Dimitroff and passed by unanimous Voice Vote.

2. Approval Disbursements March 2023

A. Public Safety – Pete Connolly

1. Closed Session – Item C. Purchase or Lease of Real Property

Trustee Connolly had one item for Closed Session.

Chief Roberts reported the following: 1) Community Clean Up Day turned up lots of trash and a gun that looked real but wasn't. 2) New speed signs have been installed at the curve on Powis. 3) The Police Dept. is returning to Wayne Elementary School to continue to interact and establish relationships with the children. 4) A poster regarding Prescription Drug Drop Off has been posted on the PD Facebook page. 5) Chief offered special thanks to Trustee Amadei for his contributions to the community and the Police Dept.

PW Tommy King said he installed car side markers on Powis Road. The new John Deere mower and flail were delivered and will quickly be put to use.

Trustee Hull said he and Trustee Connolly are working with certain neighborhoods and subdivisions regarding SSA's (Special Service Areas.) On a separate matter, Trustee Hull reported a possible property donation to the Village is back on the table.

F. Building & Zoning – Howard Levine

1. Village Code Section 10-7-5 A. Permits for Hens, Coops, Pens

Attorney Wilson recapped Code 10-7-5 A, saying the code had a sunset clause which expired March 2023 for permitted accessory use on residential lots of 8,000 sq. ft. or more, with no more than one coop and pen, and limited to six hens per lot or four hens per acre. Lots less than 8,000 sq. ft, or adjoining lots less than 8,000 sq. ft. are not permitted to build, keep or maintain coops, pens or hens. He confirmed the coop is an accessory structure. He stated that a draft Ordinance extending the provisions for another two years has been prepared and will be on the May 2 agenda for consideration.

G. Parks – Emily Miller
