Some of the homes did not have late fees put on them, and we would

suggest that either we put the late fees on these homes or we removed from the other homes. Since we cannot verify the violations and fines on these units, I would also suggest that these be removed.

All of the late fees/interest on the fines have to be removed since this is not allowed to be charged per Florida Statute.

The homes that are either in Mortgage Forclosure or with the Attorney, I would leave alone until the Attorney's instruct us otherwise.
