# 07 Section 7: Handling and Storage

## 7.1. Precautions for safe handling

Instructions for Safe Handling

Prevent the creation of flammable or explosive concentrations of vapour in air and avoid vapour concentration higher than the occupational exposure limits.

Avoid skin and eye contact. Avoid inhalation of vapour and spray mist. Avoid

inhalation of dust from sanding.

Smoking, eating and drinking are forbidden in application area. For personal protection see section 8. Comply with the health and safety at work laws.

Isolate from sources of heat, sparks and open flame. Do not use any sparking tools.

Product may charge electrostatically: always use earthing leads when transferring from one container to another and earth containers. It is recommended that operators should wear

antistatic clothing and footwear.

When operators, whether spraying or not, have to work inside the spray booth, ventilation is unlikely to be sufficient to control particulates and solvent vapour in all cases. In such circumstances they should wear a compressed air-fed respirator during the spraying process and until such time as the particulates and solvent vapour concentration has fallen below the exposure limits.
