Isolate from sources of heat, sparks and open flame. Do not use any sparking tools.

Product may charge electrostatically: always use earthing leads when transferring from one container to another and earth containers. It is recommended that operators should wear

antistatic clothing and footwear.

When operators, whether spraying or not, have to work inside the spray booth, ventilation is unlikely to be sufficient to control particulates and solvent vapour in all cases. # Appropriate engineering controls
