Ribbons & Prizes

Qualifiers will receive a flat ribbon for successful pass of test. Placements will be awarded for first through third place for jump heights 4, 8, 12, 16, 20 & 24. A "New Title" rosette for any dog finishing their title. All dogs will compete against their jump height.

Schedule

Trial Hours: Each Day – 10am until completed

Day-of-Trial Entries will not close unless trial is over

All dogs that do not have a permanent jump height card for any agility venue will have to be measured. Inspection: All dogs will be inspected for soundness and measured prior to running each run. Multiple dogs will be spaced. Electronic timers will be used.

Course will be completely fenced in.

Bunny Dash is a timed straight race of 120 feet or 40-yard dash. Dogs run singularly.

Rumble Run is a time straight race of 120 feet or 40 yards with "rumble strips" every 10 feet consisting of displaceable soft, foam pool noodles.

Dog's time to complete the 40-yard dash is converted into mph. Formula is 81.9 divided by dog's time.

Double digit dogs = handicap is 10 points

Points = MPH plus dog's handicap

Bunny Dash and Rumble Run suffix titles are earned at designated milestones.

Please see rulebook for points needed for individual titles.

Timing Device: The time to complete the 40-yard dash is recorded to the nearest 1/100th of a second. The break-the-beam equipment will be used. An individual at the start line shall signal with ready, set, go at the start line.

GENERAL RULES

All Entries must be six month of age or older on the day of the test.

Each entry will be examined and may be measured with a wicket at inspection. Inspection shall take place before any wraps are applied to the dog. Any entry found to be lame, unfit to compete, or female in season, shall not be allowed to enter and their entry fees shall be refunded. The decision of the committee is final

Muzzles are permitted. Dogs may wear any type of flat quick release collar with NOTHING hanging from the collar. NO PINCH COLLARS, ELECTRONIC COLLAR OR FLEXI LEADS ARE ALLOWED ON SITE.

Lures consist of white plastic bags and or unstuffed toy

Committee reserves the right to bar aggressive dogs from the event site.

The following actions may result in the fine and/or being excused from the event: exhibiting unsportsmanlike conduct or not picking up after one's dog.

RV PARKING

RV parking area is limited. RVs must park in designated area. Reservations must be made in advance. There is a \$20 charge for RV parking per night (NO HOOKUPS). 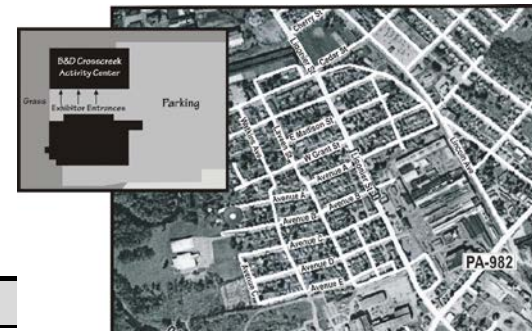

From the East: Take I-70/US 30 W. Continue to follow US-30 W. Merge onto PA-982 toward Bradenville (go 1.0 Miles). Turn LEFT onto LIGONIER ST. (LIGONIER is just past DIANE St.) (go 0.3 Miles). Turn LEFT onto AVENUE B. (AVENUE B is just past AVENUE C) (go 0.3 Miles). 501 AVENUE B is on the RIGHT. (destination is just past WATKINS AVE.) (go 0.01 Miles)

From the West: Take US-22 E. Turn RIGHT onto PA-981 (go 6.5 Miles). Turn Right onto PA-981/Industrial Blvd. Continue to follow PA-981 S (go 0.5 Miles). Turn LEFT onto LINCOLN AVE./PA-981. Continue to follow LINCOLN AVE. (Lincoln AVE. is just past DEPOT St.) (go 0.9 Miles). Turn RIGHT onto Cedar ST. (CEDAR ST. is 0.1 miles past CHERRY ST.) (go 0.1 Miles). Turn LEFT onto LIGONIER ST.
