

RELEASE, ASSUMPTION OF RISK, WAIVER AND INDEMNIFICATION This document waives important legal rights. Read it carefully before signing. I AGREE in consideration for my participation in this event to the following: I AGREE that the "Association" and "Event" includes all of their officials, officers, directors, employees, agents, personnel, volunteers and affiliated organizations of the Iowa Dressage and Combined Training Association. I AGREE that I choose to participate voluntarily in the event with my horse, as a rider, driver, handler, vaulter, longeur, lessee, owner, agent, coach, trainer, or as parent or guardian of a junior exhibitor. I am fully aware and acknowledge that horse sports and events involve inherent dangerous risks of accident, loss, and serious bodily injury including broken bones, head injuries, trauma, pain, suffering, or death ("Harm"). I AGREE to hold harmless and release the Association and the Event from all claims for money damages or otherwise for any Harm to me or my horse and for any Harm of any nature caused by me or my horse to others, even if the Harm arises or results, directly or indirectly, from the negligence of the Association or the Event. I AGREE to expressly assume all risks of Harm to me or my horse, including Harm resulting from the negligence of the Association or the Event. I AGREE to indemnify (that is, to pay any losses, damages, or costs incurred by) the Association and the Event and to hold them harmless with respect to claims for Harm to me or my horse, and for claims made by others for any Harm caused by me or my horse while at the Event. I have read the United States Equestrian Federation Rules about protective equipment, including GR801 and, if applicable, EV114 and I understand that I am entitled to wear protective equipment without penalty, and I acknowledge that the Association strongly encourages me to do so while WARNING that no protective equipment can guard against all injuries. If I am a parent or guardian of a junior exhibitor, I consent to the child's participation and AGREE to all the above provisions and AGREE to assume all of the obligations of this Release on the child's behalf. I represent that I have the requisite training, coaching and abilities to safely be involved in this Event. I AGREE that if I am injured at this Event, the medical personnel treating my injuries may provide information on my injury and treatment to medical professionals. BY SIGNING BELOW, I AGREE to be bound by all applicable Association guidelines and all terms and provisions of this entry blank and all terms and provisions of the Prize List. If I am signing and submitting this Agreement electronically, I acknowledge that my electronic signature shall have the same validity, force, and effect as if I affixed my signature by my own hand.
