We, the undersigned, hereby make application to Ringgold County for permission to apply **two applications** of **LIQUIDOW**TM **Calcium Chloride** for the purpose of dust suppression in the described location. The Applicant agrees to the following:

- 1. **DEADLINE FOR SIGN-UP IS May 11TH.** In order for the county to have sufficient time to prepare the roads before the first application, no permits can be accepted after this date.
- 2. To maintain Jerico Services, Inc. flags identifying the outer limits of the area to be treated. Flags must be in place by May 11TH and kept visible until October 1st. Failure to identify the treated area may result in your dust control being bladed through. Neither the county nor Jerico Services, Inc. assumes any liability if your flags are not in place.
- 4. I understand that Ringgold County will not blade/scarify the area after the treatment unless the county engineer deems such work necessary to maintain public safety. In which case, the work will be performed without compensation to the permit holder. Your road will be thoroughly bladed after October 1st, in preparation for winter.
