We, the undersigned, hereby make application to Sac County for permission to apply dust suppression in the described location. The Applicant agrees to the following:

- 1. **DEADLINE FOR SIGN-UP IS MAY 11<sup>th</sup>.** In order for the county to have sufficient time to prepare the roads before the first application, **no applications can be accepted after this date.**
- 2. To maintain Jerico Services, Inc. flags identifying the outer limits of the area to be treated with dust suppression. Flags must be in place by May 11<sup>th</sup> and kept visible until October 1<sup>st.</sup> Using Jerico Services, Inc. flags will serve to visually remind the blade operator as to the location of the treated area. Failure to identify the treated area may result in your dust suppression being bladed through. Neither the county nor Jerico Services, Inc. assumes any liability if your flags are not in place. If your flags are not in place when we come to apply your dust suppression we will center the application on your house.
- 3. I understand that Sac County will blade the treated area as it deems necessary without notice or compensation to the landowner. Your road will be thoroughly bladed after October 1<sup>st</sup> in preparation for winter.
- 4. This agreement is limited to **two** treatments only.
- 5. Jerico Services, Inc. does not guarantee the performance of the product due to factors such as weather, surface preparation or heavy traffic patterns.
