The applicant agrees to the following:

- 1. **DEADLINE FOR SIGN-UP IS APRIL 15TH** Application MUST be received by this date in order to be on the list for the first application. Late applications will be added to the list for second treatment only.
- 2. To measure area and maintain Jerico/EnviroTech Services flags identifying the outer limits of the area to be treated with Dust Suppression. Flags must be in place by April 1st and kept visible until October 15th. Flags are not only an identifier for our drivers, specifically where the treatment should be applied, they also serve as a visual reminder for the blade operator of the treated area. Failure to identify the treated area may result in your dust control being bladed through. Neither the county nor Jerico/EnviroTech Services assumes any liability if your flags are not in place and visible.
- 3. The county reserves the right to blade the treated area if it is deemed necessary for the safety of the public.
- 4. Jerico/EnviroTech Services does not guarantee the performance of the dust suppression products due to factors such as weather, surface preparation, and or heavy traffic patterns.
- 5. Please measure and flag your area accurately. If flags are not in place, Jerico/EnviroTech may apply the dust suppressant using reasonable judgment, or cancel your application.
- 6. If you enter credit card information, you acknowledge that Jerico/EnviroTech Services is not responsible for any loss of that information that occurs during transit to Jerico/EnviroTech Services.
