Failure to identify the treated area may result in your dust control being bladed through. Neither the county nor Jerico/EnviroTech Services assumes any liability if your flags are not in place and visible.
- The county reserves the right to blade the treated area if it is deemed necessary for the safety of the public.
- Jerico/EnviroTech Services does not guarantee the performance of the dust suppression products due to factors such as weather, surface preparation, and or heavy traffic patterns.
- Please measure and flag your area accurately. If flags are not in place, Jerico/EnviroTech may apply the dust suppressant using reasonable judgment, or cancel your application.
