UNFINISHED BUSINESS

Sewage/Sewage Authority Report

Adam-Met Walters for service on 5/24. On 5/27 slight overflow, moved timeline to 25 mins, also had a cable failure. 5/29 moved timeline back to 20 mins. 6/2 DO meter failure, replaced membrane and batteries which did not help. 6/5 Met Walters for service and dropped the DO meter with Environmental Specialists and picked up a rental DO meter from them.

- -Replacement DO meter cost approximately \$900, Adam to call Environmental Specialists to see if our DO meter can be mixed.
- -Motion to purchase a new DO meter if required by Kim Balthaser, seconded by Dan Balthaser, all in favor none opposed.
- -Motion to purchase a new overflow cable by Kim Balthaser, seconded by Dan Balthaser, all in favor none opposed. Adam to purchase new cable.

<u>Sewage Solicitor-Dennis Shatto</u>-Borough is in need of rules and regulations for new sewer connection and reconnection fees, etc. Council to review copy of another municipality's sewer rules and regulations.

-After a discussion with Dennis Shatto, it was decided to reduce Glenn's sewer EDUs for the 3 unoccupied properties from \$100 per month to \$50 per month as long as they stay unoccupied. If the now vacant trailers are rented the sewer rate will go back to \$100 per month retro-ed back to date of original bill being reduced, upon motion of Kim Balthaser, seconded by Dan Balthaser, all in favor none opposed.
