Put it back and it tripped the overload. 11/1 Stan was at plant, relay had failed on lift station pump

- #2, the lift station pump was fine it was a control problem with the relay which was replaced.
- -Ordered new DO meter, pump #3 in train 1 failed and needs replaced. -Need to order a backup pump. -Need more relays ordered, more cable clamps, ammonia test kits and alkalinity strips. -Still need to order chlorine and chlorine test packets.
