

RESALE CONSIGNMENT AGREEMENT

This consignment agreement is between Three Palms Trading Goods LLC (3Palms) and the following:

Terms of your consignment with Three Palms Trading Goods LLC:

- The consignment agreement covers all items accepted for sale by 3Palms and identified below and/or attached.
- 3Palms will determine when your goods will be placed for auction or resale. Most items will be listed for sale within 7 days of receipt.
- You (consignee) will receive 50% of the sale price for goods sold for \$40.01-\$350.
- You (consignee) will receive 40% of the sale price for goods sold for \$20.01-\$40.
- You (consignee) will receive 35% of the sale price for goods sold for \$10.01-\$20.
- You (consignee) will receive 30% of the sale price for goods sold for < \$10.
- You (consignee) will receive 58% of the sale price for goods sold for >\$350.
- If you place a reserve on an item and the item does not sell at auction, you will be charged the full reserve fee as determined by eBay or other ecommerce platform.
- Unsold items can either be reclaimed or donated to charity. 3Palms will give you 10 days notice of unsold items. Items left unclaimed after 10 days become the sole property of 3Palms. 3Palms reserves the right to sell at deeply discounted price, all proceeds being retained, or to donate the items to a charitable organization of 3Palms' choice.
- 3Palms will review your items offered for auction. Some items may not be suitable for resale and will not be accepted for consignment.
- You are responsible for contacting 3Palms with any change in contact information.
- Remorse - If you change your mind about consigning items, you must notify 3Palms within 48 hours of receipt.

Payment:

- Consignment checks or e-payment (Zelle, Venmo, etc) will be processed during the first week of each month. Checks will be mailed unless otherwise arranged.

3Palms will work proactively to sell and protect your merchandise. However, 3Palms is not responsible for loss or damage to merchandise due to, but not limited to fire, water, vandalism, theft, shoplifting, or natural disaster.

Note that items may take an indefinite period of time to sell. Please initial below your preferred length of time to wait for successful sales.
