CHAPTER 17 STREETS AND SIDEWALKS

Article I. In General

ARTICLE I. IN GENERAL

SECTION 17-1. LITTERING. No person shall throw, deposit or leave any trash, debris, cans, garbage or similar items in any of the streets, thoroughfares, alleys and ditches of the town.

SECTION 17-2. DEPOSITING INJURIOUS SUBSTANCES IN STREETS.

- (1) No person shall throw or deposit on or into the streets any nails, wire, scrap metal, glass, crockery or other substance injurious to the feet of persons or animals or to tires of vehicles.
- (2) No person shall operate or permit the operation of a vehicle upon which ashes, fuel, cinders, sand, gravel, paper, trash, rubbish or other materials are so loaded as to permit such articles to be scattered on the streets.

SECTION 17-3. DESTROYING OR REMOVING MATERIALS.

- (1) No person shall destroy, deface or injure any street or sidewalk in the town, or remove any material therefrom.
- (2) No person shall destroy, deface or injure, or tamper with, any street sign, street sign post or traffic control sign. (Ord. No. 50, S15)

SECTION 17-4. OBSTRUCTING STREETS. No person shall obstruct any public town street by fencing across or into the same, or by wilfully causing any other obstruction in or to such street or any part thereof without permission of the mayor-commissioner.

SECTION 17-5. OBSTRUCTING DRAINS OR DITCHES. No person shall obstruct the flow of storm water by obstructing any ditch or drain on the several alleys and streets of the town in any manner whatsoever, or any natural drain whatsoever, located within the town.

SECTION 17-6. USE FOR STORAGE AND SALE OF VEHICLES. No person shall use any of the streets or sidewalks within the town for the purpose of storing junk, abandoned or used automobiles or motor vehicles, or for temporary storage of vehicles for the purpose of sale.

SECTION 17-7. EXCAVATIONS IN STREETS---PERMIT REQUIRED. No person shall do any construction or repair work involving the tearing up and relaying of any street or part of street, or obstruct, dig up or into or in any way disturb any street or part of street, including removal or earth from ditches, without first procuring from the town commission a written permit therefor. The permit shall be issued under such conditions as may be prescribed by the town commission and shall accurately describe the portion of the street to be affected and shall make provision for the replacement of that part of the street which is to be replaced in the same condition as when disturbed and shall state a definite time within which the permit shall be operative.

SECTION 17-8. SAME---ERECTION AND LIGHTING OF BARRICADES. Any person carrying on or doing any construction, excavation or repair work in any street or part of street in the town, pursuant to a permit from the town commission as provided in Section 17-7, shall erect and maintain proper, safe and sufficient barricades, and during that period of time between one-half hour after sunset and one-half hour before sunrise shall maintain sufficient lights or flares around such barricades, work or excavations to warn persons of the presence of such excavations and work and to prevent injury to persons and property.

SECTION 17-9. SAME---REPLACING STREET. Upon the expiration of any permit granted by the town commission pursuant to the provisions of Section 17-7, the permit holder shall replace that street or part of street upon which such construction, excavation or repair work has been performed in the same condition as the street or part of street existed prior to the construction, excavation or repair work; and failure to do so shall constitute a misdemeanor against the town by the permit holder.

CHAPTER 17

SECTION 17-10. CULVERTS---INSTALLATION BY TOWN; SIZE.

- (1) All culverts placed in the road right-of-way shall be installed by the town.
- (2) The size of such culverts shall be determined according to a plan adopted for the area involved. (Ord. No. 28, S17)

SECTION 17-11. SAME---MATERIAL. Coated corrugated steel shall be used for culverts. (Ord. No. 28, S11).

SECTION 17-12. SAME---SIZE OF DRIVEWAY CULVERTS. Driveway culverts shall be twelve inches in diameter. (Ord. No. 28, S10.)
