
## The Common-Sense Take on COVID



While the Democrats were busy impeaching Trump for Biden's corruption a new threat was emerging in Wuhan, China in the form of what has become known as the **COVID Virus**. Whether COVID was the result of Chinese Communist Party (CCP) **malice**
