False Reporting Guidelines

Anyone reporting in good faith shall be immune from any civil or criminal liability.

Any person who knowingly and willfully makes a false report or counsels another to make a false report is guilty of a felony of the third degree punishable by up to five years in prison. In addition, the department may impose a fine not to exceed \$10,000 for each violation. Each time that a false report is made constitutes a separate violation. A false report is a report of child abuse, neglect or abandonment or adult abuse, neglect or exploitation that is made to the central abuse hotline which is not true and is **maliciously made** for the purpose of:

Harassing, embarrassing, or harming another person;

Personal financial gain for the reporting person;

Acquiring custody of a child or vulnerable adult; or

Personal benefit for the reporting person in any other private dispute involving a child or vulnerable adult

Section 39.205, Florida Statutes (F.S.) states what the department has to do concerning false reporting for children and Section 415.111, F.S. addresses with false reporting for adults.

On November 8, 2015 at 1:30pm, a call came in to [REDACTED] from Mrs. Parker.

The report stated, "[REDACTED] had an accident while [REDACTED] was in the classroom, because the teacher would not allow [REDACTED] to go when [REDACTED] needed to go." This is FALSE. (Please see emails below).

The report went on to say that, "Because [REDACTED] had the accident, the teacher became upset and [REDACTED], and told that [REDACTED] could not return to the school." This is FALSE. (Please see emails below).

"The parents attempted to go into the school, but were also reprimanded, and the mother was made to clean the restroom at school." This is FALSE. (Please see emails below).

"The teachers are on a schedule and are unable to deviate, and going to the bathroom was not on the schedule at the time." This is FALSE. (Please see emails below).

"On another unknown date, another child had an accident at the school, and because [REDACTED] was afraid of the consequences, flushed [REDACTED] underwear down the toilet. The staff at the school checked all of the little [REDACTED] at the school in order to identify who did

not have any underwear, and the parents of the child was reprimanded." This is FALSE.

At the time this report was made, the facts surrounding this separate incident were discussed in an open forum with the parents and the Principal. All parent questions were answered and it cleared up any misconceptions and false statements about what happened. After the open forum, no parent brought forward any grievance to the MCA board. MCA has a policy on parental grievances. To date the school has not had a single parent grievance.

Didn't [REDACTED] question why someone would contact [REDACTED] two months after alleged incident then contact the media and go on camera and lie? [REDACTED] should know that Mason Classical Academy is unable to publicly disclose the truth about this alleged incident because of federal privacy laws. Mrs. Parker intentionally and willfully gave [REDACTED] inaccurate and false information and was maliciously made for the purpose of embarrassing and harming the school's reputation.

As a result of this false report, our school was also damaged financially. Some of our donors expressed serious concerns. A fundraiser scheduled at Talbots at Waterside Shops was cancelled as a result of Mrs. Parker's continued spread of knowingly false statements. Even after [REDACTED] closed this case after no findings, Mrs. Parker has used social media as a way to continue lying and defaming the school. This is clear retaliation. Also, it appears that this has become personal, since the founder of MCA is mentioned in this post. This was posted last month on a public Facebook page, "Collier County School Board Watch:"

Valerie Bryant Parker Sadly, that was my child who was thrown out. My [REDACTED] year old [REDACTED] was unfairly [REDACTED] from Mason Classical Academy and denied any due process. In our case, the school failed to follow any proper protocol. To make matters worse, when we spoke out about this, the school's administration slandered us and disparaged our child with abusive and false claims and took to social media to suggest other parents do the same. Please think about that for a moment – this is a [REDACTED] year old child they villainized and a family who just days prior were as valued as any other MCA family. This from a school which prides itself on virtue and from a sitting county school board member who should be serving as an advocate for school children and their families. That's totally unacceptable. It's reprehensible actually and I think any parent would feel the same way if they and their children had been the recipients of such egregious mishandling and bullying. Now this would have never occurred in a public school bc there is protocol and accountability, but if it had, you bet Mrs. Lichter would have been all over it as a fierce advocate for those parent's rights.

If charter schools are publicly funded they should absolutely be held to the same standards and code of conduct as traditional public schools, esp considering the founder of Mason Classical, Mrs. Lichter, doesn't hesitate to call out CCPS for any of their shortcomings. It's a gross double standard.

This is [REDACTED] 3rd accident in a month of school. This is becoming a real problem for many reasons.

[REDACTED] need to independently handle their toilet needs. I have already told my students they can always interrupt me or any teacher for bathroom emergencies, and even run there if they need to. [REDACTED] should have known that already.

Also, my students have many opportunities to go to the bathroom throughout the day. I often remind them to go when there are breaks.

Another concern is that [REDACTED] stuck [REDACTED] hand down [REDACTED] pants and lifted it out dirty with [REDACTED] excrements.

Not only gross and something a [REDACTED] teacher should rarely handle, but very unsanitary for all of us. It was all over [REDACTED] seat, desk top, classroom floor, door handle, bathroom...as well as all over [REDACTED].

I am very concerned about [REDACTED] lack of Independence with [REDACTED] toilet needs.

Dear Mrs. Huck,

I wanted to follow up regarding █'s accident this afternoon. How awful that was for you, I'm sure. I feel terrible it happened. █ has been in the bathroom twice since we've been home which leads me to believe █ may █ of some sort.

When I picked █ up, the lady waiting with █ advised that █ made a couple comments to the effect that █ wanted to be home and it was more fun there...thinking maybe █ could have had a greater purpose. However, when I dug, █ said that █ did feel that way but said █ was asked and so █ answered that being home is more fun than school and talked about what █ likes to play with-etc. █ told me █ only wanted to get clean and was sad █ couldn't play with the special play dough you planned for the children to play with today. At any rate, I think it was a genuine accident. █ said █ realized █ had to go when you were teaching but █ didn't want to interrupt and thought it was best to wait until you were done, and then had the accident. I explained that if that ever happens again, its perfectly okay to raise your hand and, in an emergency situation like that, its also okay to interrupt and let the teacher know you have to go to the bathroom straight away. █ understands that now. I just think it was the onset and █ thought █ had control when █ really didn't.

I am making a donation to the school as a gesture of my appreciation in handling that very unpleasant situation and to help cover the cleaning supplies. █ was a mess and I can only imagine what you all had to deal with. Awful, awful, awful.

A charter school founded by a sitting Collier County school board member is under investigation.

The NBC2 Investigators confirmed the ██████ is investigating Mason Classical Academy for mental injury and inadequate supervision.

██████ was just a couple weeks into ██████ when ██████ parents said ██████ from Mason Classical Academy because ██████ had two bathroom accidents. Charter schools can't ██████ students. This is a lie. As you know from the email evidence provided, ██████ had more than two accidents and the nature of the accidents were not typical considering the child pulled out feces from ██████ pants and spread it in the classroom and bathroom.

This week, ██████ launched an investigation into the school. It's the second open investigation this year. "The whole experience was very surreal, and I think we're still trying to rebound from that," mom Valerie Parker said.

It took weeks for Valerie Parker and her husband, Remy, to open up about the incident. "██████ knew ██████ had to go to the bathroom. ██████ tummy rumbled. ██████ tried to hold it in, and then all of the sudden ██████ back got wet," Valerie Parker said.

They say ██████ had an accident. Then they received an email from school officials saying if it happened again, ██████ would be un-enrolled.

"██████ had gone to ██████ the year before, five days a week and never had an issue," father Remy Parker said.

But when it happened again, they said ██████.

"I was in shock. I was kind of confused. It just seemed very harsh type of punishment," Valerie Parker said. The email evidence between Mrs. Parker and school officials do not match this story she is reporting on the nightly news.

She told us about another incident where a child at the school flushed ██████ underwear down the toilet. In order to find out who did it, Valerie said school officials asked to see multiple children's underwears.

"Either in a set of two or three children, and had them pull down their waistband of their pants and uncover their underwear band to ensure they indeed had underwear on," Valerie Parker said.

Assistant Principal Joe Whitehead acknowledged a clog that day in an email. He wouldn't answer whether faculty asked kids to show their underwear.

"No child removed any article of clothing. No child was touched. In most cases, children were able to respond and give us something verbally," Whitehead said. Mason Classical Academy founder had the following to say, "To me this looks

like a targeted attempt to attack a school. Why wasn't this brought up two months ago? Why not put it to rest then? Because it has been put to rest."

"It makes you think that there's kind of a culture issue. There's something wrong," Remy Parker said. Mr. Parker made no mention of the nature of [REDACTED] child's accidents. I am not aware of [REDACTED] spreading their own feces all over the classroom and bathroom.

[REDACTED] wouldn't confirm details about its two investigations, other than allegations of mental injury and inadequate supervision.

"Parents are fearful. They're nervous," Valerie Parker said. Her narrative certainly changed.

The Parkers have pulled their [REDACTED] out of Mason Classical Academy as well.

[REDACTED] told us any action would be taken based on the outcomes of these investigations would be up to the school and/or law enforcement.

Mason Classical Academy, a Collier County charter school founded by two sitting board members, is under investigation by the [REDACTED] for alleged "mental injury" and "inappropriate supervision."

At least one of the investigations was triggered in part by an incident recounted to parents at a meeting called by the school last month — where school administrators told parents that after finding a child's soiled underwear in a school toilet, they began asking students individually to untuck their shirts and show the waistband of their underwear.

L [REDACTED] F [REDACTED], whose [REDACTED] is a [REDACTED]-grader at the school, attended the October meeting and said [REDACTED] was part of the search.

F [REDACTED] said he and other parents questioned the method used by administrators to identify the child who had unsuccessfully flushed their underwear and why they were not told immediately about what had happened.

"Parents were asking, 'Why is it that we were not informed that this was happening, at the time or immediately after?' " F [REDACTED] said. "Parents began finding out from their children. That's a failure of communication that caused a great deal of concern."

Questions also arose as to whether the incident constituted a strip search, which federal and state law prohibit in most cases — particularly in a school setting. Florida statute defines a "strip search" as having a person remove or rearrange their clothing "so as to permit a visual or manual inspection of the genitals; or undergarments of such person."

Valerie Parker, a parent of [REDACTED] former Mason Classical Academy students, was also present at the October meeting. Parker said in an interview that her

██████████, a former ██████████ student at Mason Classical Academy, was unenrolled from the school following two bathroom incidents. Remember the previous emails? There were a total of 4 incidents. The teacher reminded the parent about three incidents, then the 4th incident prompted the decision that the child may not be ready for ██████████.

Parker said ██████████'s incidents and the incident that led to the underwear searches point to an underlying issue at the school: strict limits on when and how students can use the bathroom carried out by school leaders through intimidation. In the emails between Ms. Parker and the teacher, Mrs. Huck, Ms. Parker said her child had issues with ██████████ belt then had ██████████ and had ██████████. The teacher made it clear that students were allowed to go to the bathroom anytime.

Both F██████████ and Parker said several parents and school volunteers at the October meeting related stories of students being afraid to ask permission to use the restroom and teachers asking students to wait to avoid disrupting the class.

"I tried to explain to them that ██████████ couldn't interrupt. That ██████████ was afraid to," Parker said of the day she was told ██████████ would be unenrolled from the school after soiling ██████████ clothes for the second time. "This is wrong. Mrs. Parker said in one email, *██████████ said ██████████ realized ██████████ had to go when you were teaching but ██████████ didn't want to interrupt and thought it was best to wait until you were done, and then had the accident.*" No where did she say ██████████ was afraid.

"There is a problem here — that children aren't allowed to go to the bathroom." Mrs. Parker does NOT mention ██████████, the belt, the ██████████. She also does not mention the statements made by the teacher, which included, *"I have already told my students they can always interrupt me or any teacher for bathroom emergencies, and even run there if they need to. ██████████ should have known that already. Also, my students have many opportunities to go to the bathroom throughout the day. I often remind them to go when there are breaks."*

Parker said she filed a complaint with the school district's last month.

The ██████████ investigations were launched on Oct. 10 and Monday, according to a spokeswoman for the ██████████, Natalie Harrell.

Harrell said that there are no prior institutional investigations into the school. David Hull, Mason Classical Academy's principal, said he is "very confident" that the investigation will not find the school at fault.

"There was no wrongdoing here," he said.

Of Parker's allegation, Hull said, "it's not what they're making it out to be."

"The truth is very different from the story that was put out there," Hull said. "It's disheartening that there are forces out there that want to hurt this school."

Mason Classical Academy was founded by two sitting school board members, Kelly Lichter and Erika Donalds. Lichter, who currently sits on the school's governing board, declined to comment for this story, as did Donalds, who no longer sits on school's advisory board. Byron Donalds, who sits on the school's

governing board and is also running for a local seat in the state House of Representatives, said he is confident in the school's leadership.

"My own kids go to this school. I know the staff and the teachers are working hard to provide a good education in a safe environment," Donalds said.

A recent letter to the editor of the Daily News asked why the story about the bathroom incident, and subsequent search of some of the boys, at Mason Classical Academy made it into the newspaper.

The Daily News publishes stories which express concern for children's well-being, including incidents at Collier County Public Schools.

Like other schools in the county, Mason Classical Academy is taking public dollars. Reporting about a school which should be educating students in a safe and respectful setting is holding that school publicly accountable.

There is also the potential for a conflict of interest, having two Collier County School Board members, Kelly Lichter and Erika Donalds, involved with the leadership of the school either directly or through a family member.

No other serving School Board member maintained ties to a Collier County Public School. So, where best can a factual, unbiased investigative report come from? It must come from our newspaper with its excellent reporters and editors. The subsequent letters serve as a community discussion.

The writer asks, "What would you think if your kid flushed a pair of underwear down the toilet? What would you think if you had to pay a plumber thousands of

dollars to fix the problem?" My first thoughts are about the young [REDACTED] health, and not causing a child to feel shame for having an accident, or in exercising understandable age-appropriate judgment and behavior. The problem seems to be the shame-based culture at the school, not the need to call a plumber. Our responsibility is to protect the health and welfare of our students, not to shame them.

Letter: Moral outrage

As a long-term advocate and physician provider for children, I felt moral outrage upon learning from articles in the Naples Daily News of actions taken by the administrators and/or teachers at Mason Classical Academy regarding the soiling of [REDACTED]'s underwear.

They physically searched [REDACTED] for evidence of who was not wearing underwear after finding underwear clogging a school toilet. Another [REDACTED] was asked to leave the school for a soiling accident.

Both of these actions constitute shaming behavior on the part of school authorities.

Are these incidents representative of how school leaders solve problems?

The issue of the law and illegal search will be determined by state authorities.

Schools must follow the highest ethical standards in their approach to children.

Parents must trust their children will be safe and respected, especially in school.

While the law must be followed and is at issue, we must address the impact on all of the children in the school. No children should be shamed. Accidents happen to all of us. Shaming can cause lasting damage to children's self-esteem.

Adults must learn and exhibit appropriate behavior when helping to educate children.

The leadership of Mason Classical Academy, including the board, administrators and teachers, must be held accountable for their behavior and actions.

I ask the Naples Daily News to continue to follow and expand the story, reporting on who from Mason Classical Academy has accepted responsibility, and what measures the school staff has taken to rectify their behavior which appears to be unethical, shaming and emotionally devastating.

We must stand with and for our children.

Letter: Disturbing if true

I was appalled to read in the Daily News about the "underwear" incident at Mason Classical Academy.

If indeed the facts are accurate, how can the school's principal and teachers call themselves educators? Do they not know the first thing about child psychology?

How terrified the "offending" [REDACTED]-grade child whose soiled underwear was in a school toilet must have been while administrators carried out a search to see which

student wasn't wearing underwear. And the students subjected to the search were undoubtedly confused if not upset.

Any reasonable person should know that children have toilet accidents. A school serving young children should have an understanding and supportive staff so that any child could feel able to tell his/her teacher about an "accident" and have it dealt with lovingly and privately.

Again, if the facts as presented are accurate, then shame on Mason Classical Academy, its principal and staff who allowed this outrage to happen to its children.

I think the evidence is very clear that this was indeed a false report with the malicious intent to harm Mason Classical Academy. On page 2 of the [REDACTED] Operational Procedure document under f.(4) "Has any contradictory statements been made?" The emails from Mrs. Parker contradict her statements in the report. In [REDACTED]'s operational procedure regarding false reports it state, letter f.(6) "Have statements been made during the investigation, which indicate retaliation?" Because she made her false report almost 2 months later then notified the media of her report, she was retaliating against the school because the school notified her that [REDACTED] could not attend MCA unless [REDACTED] was potty trained and that there had to be a plan put in place moving forward.

Our reputation has been damaged, and we could never tell our side of the story, because our attorney advised us that we would be violating federal privacy laws. I ask that [REDACTED] take this seriously and alert law enforcement about this false report. I would be happy to discuss this further.
