

# Risk Awareness and Release

## Earth Jedi

### An Outdoor Adventure Program

I, \_\_\_\_\_ acknowledge that my Child/Student (including International) \_\_\_\_\_, age \_\_\_\_\_ is being granted access to Earth Jedi's Outdoor Adventures. In consideration of Earth Jedi accepting my application and admitting my Child/Student into the Program, I agree to the following terms and conditions of their participation:

1. I acknowledge that I have read descriptive materials about the Program. I understand that there are dangers and risks, to my Child/Student (including International) in participating in the Program, arising from many factors over which Earth Jedi has no control, including:
  - a. *Terrain* - Adventures in the Nature exposes participants to rugged surfaces which may increase risk of injury.
  - b. *Transportation* - Transportation is provided to and from the pre-determined locations. The risks of being on the roads are always present and impossible to predict. The Participant(s) of Earth Jedi are driven by, and only by, the Owner/Operator of Earth Jedi.
  - c. *Falling Objects* - These may be experienced in wilderness settings. It is impossible to predict when they may occur.
  - d. *Weather* - Weather conditions may be inclement. It is my responsibility to dress my child/Int.Student with proper and sufficient clothing at all times.
  - e. *First Aid administration* - Should my Child/Int.Student receive an injury, the Earth Jedi First Aid attendant, has the right to perform First Aid, to the best of their ability on my Child/Int.Student. Should the injury be serious, 911/SAR will be called to assist.

I voluntarily accept those and all other risks arising for my Child/Student (including International) as a Participant, in the Program, including the risk of serious bodily injury, death, and property damage or loss, whether caused by negligence or by any other cause.

2. I understand that there are rules that apply to all Participants in the Program, and that it is my responsibility to remind my Child/Student (including International) that these rules, as they exist from time to time are very important and must be

followed in order to be able to continue adventures with the Earth Jedi Program. The rules are available from the Program Leader and on the Earth Jedi website.

3. I fully accept, without recourse against Earth Jedi, all risks of injury, illness, theft, loss, or related damages which may result from my Childs/ Students (including International), participation in the Program, whether during or outside regular Program hours.

4. I waive all rights and entitlement to seek damages or other recourse from Earth Jedi, and to bring any action, cause of action or claim for damages for any loss sustained by me, my Child/Student (including International) or as a result of my Childs/Students (including International) participation in the Program. I release Earth Jedi from liability for injury or loss of any kind arising from my Childs/Students (including International) participation in the Program, whether the injury or loss was caused by negligence or by any other cause.

5. I confirm on behalf of my Child/Student (including International), that I am the legal and authorized parent or guardian of here said, and that I have read and understood this Risk Awareness and Release, intending it to be binding upon mine and theirs heirs, executors and assigns and all members of my family.

I warrant to Earth Jedi that I have legal authority to act on the Participant's behalf in signing this Risk Awareness and Release.
