We would ask you to support us in keeping children safe by:

- Following the 'Griffin Players Code of Behaviour' and treating people with respect.
- Providing basic details about your child and making sure that we can contact you if there is an emergency.
- Talking to the designated person for child protection if you have concerns about any child in the society or the behaviour of any adult.
