Description/Benefits:

Glutathione is one of the most important antioxidants in the body and is prevalent in every cell and is involved in many important biochemical reactions in the body. It is primarily made in the liver and its levels fall as the body ages. Many factors such as viruses, toxins, poor nutrition, stress, illness, heavy metals, chemical exposure, surgery, Tylenol use, sun damage, protein deficiency, weight loss, cancer, chemotherapy, radiation decrease glutathione.

Glutathione prevents free-radical damage to cellular DNA with the capacity to decrease mutation and cancer initiation through its powerful immune-boosting, anti-inflammatory and detoxification properties. It is able to induce apoptosis in malignant cells and regenerate the other antioxidants like vitamin C & E. It has a strong ability to protect organs and tissues against the toxic effects of chemotherapy and radiation and has also been shown to reverse resistance chemotherapy. There are thousands of references in the medical literature regarding glutathione. Many describe the benefits in cancer therapy, neurodegenerative brain disease, cardiovascular disease, kidney disease, liver disease, and many other degenerative conditions involving free radical formation.
