ORDINANCE 370- CURBING OF DOGS

AN ORDINANCE PRESCRIBING THE PROCEDURE FOR CURBING OF DOGS AND THE REMOVAL OF FECES DEPOSITED THEREBY ON PRIVATE AND PUBLIC PROPERTY, FOR THE PROTECTION OF THE HEALTH, SAFETY AND WELFARE OF THE RESIDENTS OF CURWENSVILLE BOROUGH.

BE IT ORDAINED, AND IT IS HEREBY ORDAINED BY THE BOROUGH OF CURWENSVILLE CLEARFIELD COUNTY PENNSYLVANIA AS FOLLOWS;

SECTION ONE: PROCEDURE FOR CURBING AND REMOVAL OF FECES.

NO PERSON, AGENCY OR INSTITUTION OWNING, HARBORING, KEEPING OR IN CHARGE OF, TEMPORARILY OR OTHERWISE, ANY DOG OR DOGS SHALL CAUSE, SUFFER OR ALLOW SUCH DOG OR DOGS TO SOIL DEFIL DEFECATE OR COMMIT ANY NEWSENSE UP ON ANY PUBLIC OR PRIVATE PROPERTY WHATSOEVER, EXCEPT WITH IXPRESS AUTHORITY OR PERMISSION OF THE OWNER OF SAID PROPERTY. THE RESTRICTION IN THIS SECTION SHALL NOT APPLY TO THE PORTION OF THE STREET LYING BETWEEN THE CURB LINES OR THE CURB LINE IN THE SIDEWALK WHICH MAY BE USED TO CURB SUCH DOGS UNDER THE FOLLOWING CONDITIONS:

NO DOG SHALL BE ALLOWED TO BE UNATTENDED WITHIN THE BOROUGH AND EVERY SUCH DOG SHALL BE RESTRAINED BY LEASH OR OTHER APPROPRIATE DEVICE WHICH, FOR THE PURPOSE OF THIS ORDNANCE, SHALL BE CALLED CURBING.

ANY PARTY WHO SO CURBS A DOG SHALL IMMEDIATELY REMOVE AND DISPOSE OF ALL SUCH FECES DEPOSITED BY SUCH DOG BY ANY SANITARY METHOD SO AS TO PREVENT UNSIGHTLY DISPOSAL OR SMELL OR INTERFERENCE WITH THE HEALTH SAFETY AND WELFARE OF THE BOROUGH.

SECTION 2: VIOLATIONS AND PENALTIES

ANY PARTY CONVICTED OF VIOLATING ANY PROVISION OF THIS ORDINANCE SHALL BE SUBJECT TO A FINE NOT EXCEEDING THREE HUNDRED DOLLARS (\$300.00) AND COSTS OF PROSECUTION AND/OR UNDERGO IMPRISONMENT FOR A TERM NOT TO EXCEED THIRTY (30) DAYS.

SECTION THREE: SEVERABILITY

SHOULD ANY SECTION OR PROVISION OF THIS ORDINANCE BE DECLARED BY ANY COURT OF COMPETENT JURISDICTION TO BE INVALID, SUCH DECISION SHALL NOT AFFECT THE VALIDITY OF THE ORDIANNCE AS A WHOLE OR ANY OTHER PART THEREOF.

SECTION FOUR: REPEAL

OLD ORDINANCES AND RESOLUTIONS AND PARTS OF ORDINANCES AND RESOLUTIONS INCONSISTENT HEREWITH ARE HEREBY REPEALED.

SECTION FIVE: EFFECTIVE DATE

THIS ORDINANCE SHALL BE EFFECTIVE UPON ADOPTION.
