BOARD OF DIRECTORS MEETING MINUTES

**The December 4, 2023
Called to order at 7:00 PM**

ROLL CALL

REPORTS

TREASURER

Dick provided an abbreviated report mentioning that the final figures will change slightly from what is currently being reported but that he will have a report for the membership meeting.

DOCKS & GROUNDS

EJ reported that over 20 members came out to the November ACME workday. Tony asked about the status of quotes from contractors. Discussion between EJ and Frank ensued, during which EJ clarified the quotations for the capital project required by the lease.

SOCIAL

Tony thanked those that have helped with Social for the past month.

COMMODORE

Frank stated that he was dropping out of the race for Commodore and indicated his support of Dave Kays. He then began to speak of other candidates he thought should be voted in as board members. He was advised that such politicizing was out of order. Frank left the meeting.

SECRETARY

Barbara reported that 37 members were present at the meeting. She also responded to a question regarding the ad for Sailorman.

BY-LAWS COMMITTEE REPORT

Sheldon Crabtree, Chair of the By-Laws Committee reported that the Committee had reviewed two proposed changes, one of which will be finalized and circulated to obtain the required 25 signatures prior to being presented to the Board. This proposal involves the parameters necessary to become an eligible candidate for the Board. The second proposed amendment was deemed not in the best interest of the Club and will not be pursued further at this time. The 2nd proposed amendment dealt with adding an "associate" level of membership to include temporary boat docking and non-compliance with the general eligibility to become a Club member.

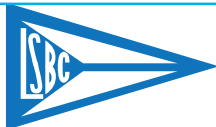
