This agreement between Park Plaza East Pool Also Known as “PPEP” “we” and “us”, and the person named above, also Known as “representative” and “you” will be considered binding upon signatures from representatives of both parties. Prices are based upon (1) a 2-hour time frame and (2) the number of guests in attendance. Additional time can be purchased in 30-minute increments for \$30.00. Any additional time must be requested and paid in full no later than (NLT) 1 day before the event. No time will be added on the day of the event. **PLEASE NOTE: In the event either party cancels the program or event(s) due to circumstances beyond either party’s control including, but not limited to, acts of God, civil emergency, riot, war, severe weather, strike, pandemic, or other unforeseen and unusual circumstances, neither party shall be liable to the other for any damages, rental fees, or cancellation fees. Under these circumstances a full refund will be issued otherwise, the following policies will be in full effect.**

I will be present at all times during the rental period.

I understand that the rules and policies set forth by the administration of Park Plaza East Pool are for my safety and the safety of my guests, therefore, I will ensure that I and all my guests will follow lifeguard directions and abide by the rules or face removal from the premises.

I understand that PPEP will not be held liable for injuries that are a result of not following Lifeguard directions and/or pool rules and policies.

NO GLASS containers (including Pyrex) are permitted inside the pool area at any time.

I understand that I am responsible for event setup. I further understand that I am responsible clean up and removal of all materials used during my event. (trash, decorations, utensils, cleaning BBQ’s if used etc.) I understand that I will be charged a \$75 cleaning fee for any mess left behind. PPEP lifeguards will be responsible for proper placement of pool equipment and closing the pool facility.

I understand I must clean and possibly vacate the gazebo and/or pool facility no later than my indicated end time.

Representatives may arrive 15 min early for decorating, however, no paper decorations are allowed and all decorations must be removed at the indicated end time. (Includes parties during normal business hours)

I understand Park Plaza East Pool is not responsible for any items that are lost or stolen. Locker rentals will be available for securing personal property and valuables.

I understand that Park Plaza East Pool board members, staff, and/or life guards have the right to limit and/or cease the consumption of alcoholic beverages for any person. No refund will be issued if asked to leave for disruptive behavior.

I understand that cigarette smoking will be allowed in designated areas, however, marijuana use of any kind will not be permitted anywhere on PPEP property and will result in immediate termination of the event with no refunds if anyone is caught using it.
