Compensation for this position will be at Step 1 in accordance with the agreement between District and the United Public Service Employees Union (UPSEU).

**4. BE IT RESOLVED**, upon the recommendation of the Superintendent of Schools, the Board of Education accept the resignation of Sonia Cuellar, as School Monitor Part Time, effective October 6, 2020.

**5. BE IT RESOLVED**, upon the recommendation of the Superintendent of Schools, the Board of Education hereby awards the contract for home-to-school transportation to and from Chedar Chabad, from the Guardian Bus Company, for the period of November 15, 2020 through June 30, 2021, in the amount of \$ 1,250.00 per pupil per month.
