**PURSUANT TO DUE CALL AND NOTICE THEREOF,** the special meeting was held on Tuesday, June 27, 2023, at City Hall at 5:30 pm. Present were Mayor, Tammy Thornton, Deputy Finance Officer, Marilee Krcil, City Attorney, Beau Barrett, and the following council: Rich Dufur, Tom Abdouch, Colby Kirwan, Jamie Soukup and Dan Cimpl. The Mayor called the meeting to order and opened with the Pledge of Allegiance

The conflict-of-interest declaration statement was recited. Cimpl cited a conflict with a line-item personnel SDCL 1-25 (1)(4).

A motion was made by Dufur and seconded by Abdouch to offer/discuss the position of City Administrator/ Finance Officer to an applicant. Mayor asked for a roll call vote: Cimpl – Abstain, Jamie-nay, Kirwin-aye, Abdouch-aye, Dufur-aye. Aye-3, Nay-1, Abstain-1. Motion carried.

A motion was made by Dufur, seconded by Kirwan at 8:35 pm to adjourn the meeting. All voted aye, motion carried.
