## REGULAR MEETING OF THE COMMON COUNCIL OF THE CITY OF WAGNER, CHARLES MIX COUNTY, SOUTH DAKOTA, November 6, 2023, AT 7:00 PM.

**PURSUANT TO DUE CALL AND NOTICE THEREOF,** the regular October meeting was held Monday, November 6, 2023, at City Hall at 7:00 pm. Present were Tammy Thornton-Mayor, City Administrator Debbra Houseman, City Attorney Beau Barrett and Councilmen: Rich Dufur, Tom Abdouch, Jamie Soukup, Colby Kirwan, and Taylor Mohr. Others present were Mike Kazena- Public Works Director, Damon Griffith-Police Chief, Matt Williams-City IT, Jamie Tjerdsma, Darcy Kaberna, Margaret Doom-Wagner Area Growth, Jessa Doom Housing Board, and Sharon Haar.

Mayor Thornton called the meeting to order at 7:00 pm.

#### All in favor, motion carried.

A public hearing was held to approve a Special Event Liquor License for the sale of alcohol on December 2, 2023, at the Armory located at 600 E Hwy 46 for the Guard Gala was reviewed. No one from the public was present to object. Motion by Soukup, second by Kirwan to approve the Special Event Liquor License Application for December 2, 2023, at the guard Gala at the Armory located at 600 E Hwy 46. All in favor, motion carried.

A public hearing was held for the rezoning of the property described as Lots 1,2,3,4,910,11,12 of Lot F of the NW Quarter Section 3 Township 95 north, Range 63 West of the 5<sup>th</sup> PM in the City of Wagner, Charles Mix County, South Dakota. The request of the rezone was to change the above-mentioned property from Highway Commercial to Residential. Motion by Kirwan, seconded by Abdouch to approve the rezoning of as Lots 1,2,3,4,910,11,12 of Lot F of the NW Quarter Section 3 Township 95 north, Range 63 West of the 5<sup>th</sup> PM in the City of Wagner, Charles Mix County, South Dakota from Hwy Commercial to Residential. All in favor, motion carried.

Craig Krsnak was present with the 2024 Health Insurance Quotes. Motion by Kirwan, second by Cimpl to approve the renewal of the Avera 2000 with life benefit plan for 2024. All in favor, motion carried.

The 2<sup>nd</sup> Reading of the Animal Control Ordinance was held. Motion by Dufur, second by Abdouch to accept the 2<sup>nd</sup> Reading of the City of Wagner Animal Control Ordinance Amendment:

### Ordinance No. 2023-002

An Ordinance Amending Wagner Municipal Code Section 2-2-1, Section 2-2-2, Section 2-2-10, Section 2-3-2, Section 2-3-4, and Section 2-3-5, repealing Section 2-3-3, and adding a new Section 2-2-12 and new Section 2-2-13 of the Wagner Municipal Code regarding the regulation and impoundment of animals in the City of Wagner.

The text of Section 2-2-1 of the Wagner Municipal Code shall be amended as follows:

2-2-1 Dog & Cat Licenses Required; Proof of Vaccination. No person may keep, harbor, or maintain who is the owner of or has in his or her possession any dog or cat, male or female, shall permit the same to run at large within the city limits four months of age or older unless such dog or cat is licensed as provided in this Chapter. No license may be

issued until the applicant has presented proof of rabies vaccination signed by a licensed veterinarian to the appropriate licensing official.

The text of Section 2-2-2 of the Wagner Municipal Code shall be amended as follows:

2-2-2 License Application. Any person desiring to keep maintain or have in his custody or control by himself or agent, within the said cityCity of Wagner, any dog or cat, shall, before the first day of May-January in each year, at the City Finance Office, apply for and fill out a license to keep such dog or cat, and will include the name, sex, color and other distinguishing characteristics of said dog or cat, and the name of the owner thereof, and shall state that said dog or cat has no vicious propensities so far as known to the applicant or, alternatively, shall provide proof of insurance as required under Section 2-2-10, and shall provide documentation of current rabies vaccination signed by a licensed veterinarian. Such application shall be on a printed blank to be prepared by the City Finance Officer and shall be filed with that office.

# The text of Section 2-2-3 of the Wagner Municipal Code shall be amended as follows:

The text of Section 2-2-5 of the Wagner Municipal Code shall be amended as follows:

## 2-2-5 Vicious Dogs; Definitions.

- (A) "Owner" means any person, firm, corporation, organization, or department possessing or harboring or having the care and custody of a dog.
- (B) "Vicious dog" means,
  - 1. Any dog with a known propensity, tendency, or disposition to attack unprovoked, to cause injury to, or otherwise threaten the safety of human beings or domestic animals; or
  - 2. Any dog which because of its size, physical nature, or vicious propensity is capable of inflicting serious physical harm or death to humans and which would constitute a danger to human life or property if it were not kept in the manner required by this ordinance; or
  - 3. Any dog which, without provocation, attacks or bites, or has attacked or bitten, a human being or domestic animal; or
  - 4. Any dog owned or harbored primarily or in part for the purpose of dog fighting, or any dog trained for dog fighting.
- (C) A vicious dog is "unconfined" if the dog is not securely confined indoors or confined in a securely enclosed and locked pen or structure upon the premises of the owner of the dog. The pen or structure must have secure sides and a secure top attached to the sides. If the pen or structure has no bottom secured to the sides, the side<u>s</u>d must be embedded into the ground no less than one (1) foot. All such pens or structures must be adequately lighted and kept in a clean and sanitary condition.
- 2-2-10 **Insurance**. Owners of <u>any\_vicious dogs as that term is defined</u> <u>under Section 2-2-5(B)</u> must within 14 days of the effective date of this chapter provide proof to the Finance

Officer shall maintain a policy of public liability insurance in the amount of at least \$25100,000.00, insuring the owner for any personal injuries inflicted by his or her vicious dog, and shall provide proof of insurance to the Finance Officer.

A new section 2-2-12 shall be enacted and added to Chapter 2 of the Wagner Municipal Code as follows:

2-2-12 Animals Running At Large. It shall be unlawful for any person, firm or corporation to allow any animal, owned, controlled or harbored by any person to run at large on the streets, alleys, or property of any other person or entity within the City limits of Wagner, South Dakota. Any person having an animal within the City limits shall have it tied, leashed or otherwise controlled upon their property. It shall be unlawful for any person to allow an animal off his or her property without the animal being held in leash.

A new section 2-2-13 shall be enacted and added to Chapter 2 of the Wagner Municipal Code as follows:

2-2-13 **Penalties**. Any violation under Chapter 2-2 is deemed a class 2 misdemeanor punishable by a fine up to \$500.00, or imprisonment up to thirty-days, or a fine and imprisonment. The penalties for violation shall be established and may be amended from time to time by resolution of the City Council of the City of Wagner.

The text of Section 2-3-2 of the Wagner Municipal Code shall be amended as follows:

2-3-2 Stray Animal Impounded; Vicious Dogs. Any animal or animals found running at large may be impounded in the public pound and shall not be released until the owner, or some other person designated by the owner, shall pay to the Chief of Police, or his designee, the fees and penalties hereinafter provided." Any dog found running at large that is determined by law enforcement to be a "Vicious Dog" as that term is defined under Section 2-2-5 of this Code, which cannot be impounded safely, may immediately be destroyed by any law enforcement officer acting in the line of duty.

Section 2-3-3 of the Wagner Municipal Code is hereby repealed.

The text of Section 2-3-4 of the Wagner Municipal Code shall be amended as follows:

2-3-4 **Chief of Police as Pound Master; Duties**. It shall be the duty of the Chief of Police, or his designee, who is hereby made Pound Master, to detain and impound all animals found running at large contrary to the ordinances of the City, and immediately give notice of such impounding to the owner or person last in charge of the animal or animals impounded, if known. An impounded animal shall not be released unless the owner or some designated person on his or her behalf, within 72 hours, pays to the City Finance Officer a claim fee of \$25 for the first offense and \$75 for each offense thereafter, for each animal so impounded belonging to the same ownerall fees, penalties, and expenses related to the impoundment of an animal. No impounded dog or cat shall be released without proof of current licensure. In addition, the owner of said impounded animal or animals, or his or her designated person, shall also be responsible for the rabies shot and

eurrent City dog or cat tags for the impounded animal or animals, plus any additional expenses incurred for each animal or animals so impounded. In addition, no impounded animal or animals shall be released until the animal is current on the rabies vaccination and has a properly issued and current dog or cat tag. This charge for the rabies vaccination and dog or cat City tags will not be charged upon proof that the animal or animals have a current rabies vaccination and have current City dog or cat tags. Any impounded animal or animals not picked up by the owner, or the owner's designated person, within 72 hours of impounding shall be may be offered for sale or adoption to the public, transported to a participating Humane Society, or euthanized, disposed of in a humane manner, with at the discretion of the Chief of Police, or his designee's discretionPound Master using his or her best judgment, or at the direction or with consultation of a licensed veterinarian.

The text of Section 2-3-5 of the Wagner Municipal Code shall be amended as follows:

- 2-3-5 Fees and Expenses. The fees for impounding any animal or animals under this chapter shall be \$25 for the first offense and \$75 for each offense thereafter, per animal or animals, on a per head basis, plus, any rabies shots or current City dog or cat tags required, if any, plus, any other incidental expenses incurred for the benefit of the impounded animal or animals. The owner or caretaker of any animal impounded under this chapter shall pay a fine not in excess of \$500.00 for each animal so impounded. In addition, the owner or caretaker shall be liable for the expenses of impounding. The City Council of Wagner shall establish and may amend from time to time, by resolution, the fine and a schedule of rates for expenses of impounding. The owner or caretaker of the impounded animal shall be liable for all fees and expenses incurred under this chapter regardless of whether the animal is retrieved from impoundment or not. Any incurred fees and expenses not paid to the Finance Officer within 30 days after notice and demand thereof may be recovered in a civil action against the owner or caretaker.
- 2-3-6 **Illegal Acts**. No person shall interfere with the Chief of Police, the Pound Master, or his or her<sup>2</sup>s assistant<sup>2</sup>s, in the performance of their duties under this chapter. Further, any person who shall remove or undertake to remove such impounded animal or animals from the pound, or the possession of the Pound Master, without paying the appropriate charges set out in this ordinance and with<u>out</u> the permission of the Pound Master, shall be guilty of an offense, and upon conviction thereof, be subject to a fine of up to \$200.00 per occurrence.

The council reviewed a list of property presented for surplus. Mayor Thornton appointed Jamie Soukup, Dan Cimpl, and Taylor Mohr to the appraisal committee. The following property was presented for surplus 6/.40 Cal Gloks and the 1998 Crown Victoria. The appraisal committee set the values of the .40 Cal Gloks at \$275 each and the 1998 Crown Victoria with a 150,380 miles at \$1,500. Motion by Soukup, second by Mohr to approve the surplus for sale of 6-.40 Cal Glok's at the value of \$275 each and the 1998 Crown Victoria J50,380 miles at the value of \$1,500. All in favor, motion carried.

Discussion followed regarding the pool and the future plans of moving forward with some sort of a pool project. Houseman informed the council that, she would need to secure an engineer/architect for design plans on a Bath House/storm shelter for the swimming pool. Motion by Kirwan, second by Dufur to authorize hiring an engineer to secure designs for a bathhouse/storm shelter. All in favor, motion carried.

The council reviewed the Snow Removal Ordinance and the enforcement of the ordinance in the upcoming snow season. The council was also informed that the Emergency snow route and removal ordinances in the Post. The consensus of the council is that the Ordinance will be fully enforced.

Margaret Doom Wagner Area Growth and Jessa Doom Housing Board were present to speak with the council about the Disc Golf property. The request was for the city to allow Doom to work with the City Administrator to prepare an agreement for the donation of the disc golf property for a housing development. Motion by Kirwan, second by Dufur to authorize the City Administrator to work with the Housing Board and the City Attorney to prepare an agreement for the donation of the Disc Golf Property for a housing development on that location. All in favor, motion carried.

M. Doom also made a request on behalf of Chamber and WAG to have the council approve the parade route for the parade of lights and to approve the discharge of Fireworks. Motion by Mohr, second by Soukup to approve the Parade of lights parade route beginning on Main Street by Custom Touch to proceed South on Main Street and to approve the discharge of Fireworks by Custom Touch contingent upon the approval of the Fire Chief. All in favor, motion carried.

A request to rent a payloader from Wagner Building Supply for snow removal was discussed. Motion by Soukup, second by Cimpl to approve renting a Payloader from Wagner Building Supply when needed for snow removal at the cost of \$100 per hour. All in favor, motion carried.

The Holiday Schedule was discussed regarding the day that will substitute for the December 24<sup>th</sup> and the 1/2 Day Holiday on December 31, 2023. Motion by Dufur, second by Abdouch to approve the Employee Holiday and Closure of City Facilities on December 26<sup>th</sup> in replacement of the December 24<sup>th</sup> day and Closure of City Offices at Noon on December 29<sup>th</sup> in replacement of December 31<sup>st</sup> noon closure Day. All in favor, motion carried.

The council discussed an employee appreciation incentive of gifting a ham or a turkey. Soukup requested that this item be continued to December.

Discussion followed regarding the purchase of the 2024 Durango for the Police fleet. Houseman informed the council that she is very close to having the Community Facilities Grant completed for the vehicle, and also if the grant was not approved the vehicle would need to be funded thru reserve cash. It was also explained that there is a time restraint on getting the vehicle ordered to guarantee placement on the list for a vehicle in 2024. Motion by Mohr, second by Kirwan to approve placing an order for the 2024 Durango for the Police Fleet. All in favor, motion carried.

A letter of commitment to participate in the Charles Mix County Hazard Mitigation Plan Update was reviewed. Motion by Kirwan, second by Cimpl to approve participation in the Charles Mix County Hazard Mitigation Update and authorize Mayor Thornton as the signatory on that document.

Mike Kazena was present to give department reports. Kazena Reported that they have put up 900 ft of Snow Fence, all the snow removal equipment is prepared for use and they also started getting the Christmas lights up in preparation for the Holidays and some water valve replacements have been completed. The council was also informed that the pool skimmers will be completed by Wednesday.

Houseman, informed the council that they are actively trying to get a date set for an armory meeting to discuss the terms of the lease with the National Guard. The Council was also informed that there was damage to a line on the floor from tape. Houseman explained that the City is holding the deposit from the rental until cost can be determined. Houseman also inquired as to whether the City thought the deposit shall be held since the event was to raise money for the City Pool. The council was also informed that Matt Yost was contacting the company that painted the lines to get cost for repair of the line. Jamie Tjerdsma and Darcy Kaberna were both present on behalf of the pool committee. They both stated that they would like the cost of repair shared with them so that an insurance claim could be made if necessary. Soukup requested that this item be continued until more information can be presented.

Margaret Doom was present to give her report on behalf of Wagner Area Growth. Doom Reported that she has been working on several projects regarding housing. Doom is in the process of getting a housing study matching grant completed with Augustana University to fund a portion of the study. She has attended meetings regarding a grant to enhance the farmer's market and hire someone thru WAG to oversee planning and execution of the Farmers market and events in connection with the market. Doom

explained that this will be a shared position with Tyndall. Doom also stated that WAG will be the fiscal agent for a childcare crisis grant thru GOED. Doom also shared some of the events for the night of the parade of lights such as Christmas or Holiday scenes on the empty lots along Main Street, having Santa present etc. Doom informed the council that she is working in collaboration with Chamber to plan an event for the Dakota Life Premiere featuring the City of Wagner.

The council reviewed the Planning and Zoning minutes from the October 3, 2023, Meeting. Motion by Kirwan, second by Soukup to accept the minutes from the October 3, 2023, meeting. All in favor, motion carried.

Mayor Thornton reminded the council that had signed up for the Elected Officials Workshop that they needed to go online and complete the course that the City has paid for certain councilman to attend. Mayor Thornton also stated that City Administrator Houseman has been working to get the NEO Gov classes assigned to the employees and the council to show participation in the Safety Benefits program.

Motion by Cimpl, second by Dufur to go into executive session at 9:06 pm for the purpose of personnel in accordance with SDCL 1-25-2. All in favor, motion carried.

Mayor Thornton declared the council out of executive session at 10:23 pm.

Motion by Kirwan, second by Abdouch to adjourn at 10:23 pm. All in favor, motion carried.
