RECEIVER'S THIRD MOTION TO WITHDRAW PREVIOUSLY FILED MOTIONS

Comes now Guy M. Hohmann, this Court's appointed Receiver ("Receiver"), and files this Third Motion to Withdraw Previously Filed Motions ("Motions") and respectfully shows unto the Court as follows:

BACKGROUND INFORMATION

The Receiver previously filed an Unopposed Motion to Appoint the National Futures Association as Monitor [Dkt. 167], Order Granting Unopposed Motion to Appoint the National Futures Association as Monitor [Dkt. #167-1], Order Granting Receiver's Unopposed Motion for Approval of Interim Distribution Plan [176-1] and [Dkt. #178] Amended Proposed Order Granting Receiver's Unopposed Motion for Approval of Interim Distribution Plan. Since the filing of the motions and orders listed above, the Receiver has agreed to a settlement (subject to this Court's approval) that would allow for a distribution to investors to increase from 9 cents to 36 cents on the dollar of each investor's claimants approved claim amount. At the present time, the Receiver

and ING Bank finalized the settlement agreement. A copy of the settlement agreement with ING was filed as exhibit 1 to the Receiver's Motion for Leave to File Under Seal [Dkt. # 205]. Due to IRS requirements, US investors will be required to file W-9's and 1099's. Upon doing further research, National Futures Association ("NFA") does not offer the services needed to meet the

IRS's requirements. The NFA also had a much longer lead time when it came to issuing checks

(months vs. five business days).

For this reason, the Receiver seeks the Court's permission to withdraw the motions listed above. The Receiver identified a distribution agent with the service offerings better suited to assist with the ING Settlement Distribution. The Receiver will submit to the Court, an ING Settlement Distribution Plan for the Court's approval.

CONCLUSION AND PRAYER

For the reasons set forth above, the Receiver respectively requests this honorable Court grant the foregoing requested relief and for such other relief to which the Receiver may show himself to be entitled.
