

- Rumor spread of Berkshire Acquiring PG&E, Buffet later put the rumor to rest

Book value per share, increased at a 19.1% CAGR during 1965-2017

Berkshire's stock performance has been equally strong, increasing at a 20.9% CAGR during 1965-2017.

At the end of September 2018, Berkshire had \$118 billion in insurance float.

### Bear Case

Risk: Ability to consistently find deals that not only add value but are large enough to be meaningful.

Longevity of chairman and CEO Warren Buffet (88) and managing partner Charlie Munger (95)

Berkshire's insurance business faces competitive and highly cyclical markets, economically sensitive, focused on U.S. markets.

With expenses increasing at a slower rate than revenue and the company seeing a marked improvement in insurance underwriting profitability



Berkshire dedicated \$43 billion (funded by \$19 billion of equity sales) to marketable equities last year and spent another \$1.3 billion on share repurchases.



Concerns-that Berkshire Hathaway's size will prevent it from growing at a decent clip in the future

#### "Focus on the forest, forget the trees"



### Controlled Business Grove



- Buffet has described this as Berkshire's most valuable grove
- Consists of companies with excellent economics and a competitive advantage where Berkshire controls 80%-100%
- Earned just under \$17 Billion last year

# 5%-10% Equity Grove



- Berkshire's equity position in large publicly traded companies with excellent economics and a competitive advantage
- Examples of 5-10% Positions are American express Apple, Wells Fargo, Coca-Cola, and Bank of America
- Total Value of Berkshire's minor equity positions is \$173 Billion

### Shared Grove



Shared position in companies such as of Kraft Heinz (26.7%), Berkadia and Electric Transmission Texas (50%), and Pilot Flying J –(38.6%), totaled about \$1.3 billion in 2018

### Treasury and Other Security Groves



- Berkshire sits on an enormous pile of cash and marketable securities.
- A portion of these assets are "Untouchable" as Berkshire faces the risk of sudden increases in insurance claims

### The Insurance Grove



- The primary propeller of Berkshire's Growth since 1967
- Collect now, pay later business model is a plus
- Growing competition in the P/C insurance industry has led to industry wide underwriting losses

### Primary Insurance

Direct Premium-for-protection-of-loss insurance is primary insurance

Berkshire Hathaway primary group, National Fire & Marine, and Geico are examples of their primary insurance holdings.

Increase in competition in the Insurance industry and slim moats cause worry.

Float generated in 2018: \$122 Billion

### Reinsurance

Reinsurance is when one insurance company handles the portion of another insurance company's policy

Generally pertains to specific risks ceded by the primary insurer

Reinsurers have the discretion of accepting a policy or walking away form it

# BERKSHIRE HATHAWAY RISKS & VALUATION



Most major investment and capital allocation fall to Warren Buffet, age 88, and Charlie Munger, age 95.

Narrow moat subsidiaries that make up a large portion of revenues face increased competition.

Potential underwriting losses could occur due to Berkshire's tolerance for risk if a significant event occurred.

Insurance claim loss estimates can be inaccurate

# Book Value and It's Relevance

In the past, Warren Buffet has encouraged shareholders to pay attention to Berkshire's book value as a means of determining its intrinsic value

Buffet has gone into the open market and purchased Berkshire at times when book value appears to be low

BIC has gone by this advice (along with Dave's nudging) and bought Berkshire Hathaway when book value was low

# Book Value and It's Relevance

Buffet has stated that Berkshire has changed from a company who's value resides in operating businesses rather than marketable stocks

GAAP rules state Berkshires equity holdings at market value but understate operating businesses.

Prospective share repurchases cause intrinsic value to increase while book value decreases


