Renewable Energy (Project) Finance Innovation

The renewable energy industry is growing rapidly in the US, but challenges to finance availability and policy certainty persist. Tax equity is limited. Policy-driven finance instruments are expiring (US Treasury grant), confounding (DOE loan guarantees), disallowed (PACE bonds) or risky (SREC contracts). Initiatives like the **Green Bank**, **Carbon Market**, and Energy Independence Trust, as well as the usual suspects – private equity, tax equity, vendor finance and the like - are eager to establish risk-mitigated, scalable and innovative solutions. In short, lots of capital stands ready to underwrite qualified projects. This event asks, "do we already know what we need to do to scale RE finance?"
