Minutes of the Parish Council Meeting of 16th October 2023

1. **Apologies** – None received

2. **Declarations of interest** - None received

3. **To approve the Minutes of the Meeting held on 18/9/2023** -

7. **Planning applications:**

a) 23/01759/S73 – this motion was rejected by 7 votes to nil (*not considered a S73 application and not in keeping with the neighbourhood plan*)

b) 23/01084/OUT – this motion was supported by 7 votes to nil

c) 23/01592/FUL – this motion was rejected by 7 votes to nil (*Overdevelopment, not in keeping with the neighbourhood plan, potential highways issues*)

d) 23/01590/HOUSE – this motion was rejected by 7 votes to nil (*harmful to the conservation area – in support of the conservation officers' comments*)

8. **Finance**

a) To approve payments list - The payments list was approved

b) Income and expenditure – to receive quarterly update – the update was approved, subject to a review of allocations and a review of the Microsoft Subscriptions

c) Banking arrangements – the new account with Unity has been applied for and is awaiting. The savings account with HSBC has been moved to the current account pending agreed developments.
