RESOLUTION OBJECTING TO THE ISSUANCE OF A SPECIAL USE PERMIT TO ALLOW A BAR AND MUSIC VENUE WITH OUTDOOR MUSIC ON APPROXIMATELY 4.43 ACRES LOCATED ON LOT 1D-R, BLOCK 1, WALNUT HEIGHTS UNIT 1, LOCATED ADJACENT AND WEST OF PROPERTY ADDRESSED AT 731 N. WALNUT AVENUE IN NEW BRAUNFELS

WHEREAS, the Housing Authority of the City of New Braunfels, Texas was notified by the City of New Braunfels, Texas of the above cited request for a special use permit and given the opportunity to favor or to object to this proposal, and
