



Pure CallerID automatically opens a case to remove the spam and/or blacklist score and the DID is then returned to the pool, avoiding downtime and redundant costs for additional DIDs. Real-time Compliance and Purification – Enhance List Quality

There are 4 tiers of service to purify campaign lists real time ensuring the list is in compliance. The options range from identifying the line types and active/inactive to being able to append the contact information (address etc.) if incorrect. Each tier can be chosen for any individual campaign to optimize dialing strategies.
