EXECUTIVE SUMMARY

The Town of Holden Beach provides public recreation to its citizens as a means of supporting a high quality of life. The Parks and Recreation Department is primarily funded by occupancy taxes and seeks grant assistance when possible.

Studies have shown that quality of life issues are very important to residents and visitors. Lively programs and events can also have a major impact on community development. The goals for recreation, as ascertained by the Cape Fear Council of Governments 2019 Land Use Plan for



the Town of Holden Beach, are to, "maximize public access to the beaches and public trust waters of the Town of Holden Beach and maximize recreational opportunities for residents and visitors alike."

To fulfill this goal, the Town recognizes the importance of *planning* as a means of improving recreation opportunities for all its residents and visitors. As a result, the Town of Holden Beach Board of Commissioners hired McGill Associates, PA (McGill) to assist with the creation of an updated 10-year comprehensive recreation master plan – to include all existing and future park facilities and grounds.

The Town of Holden Beach Comprehensive Recreation Master Plan 2021-2031 provides the framework for guiding the Town of Holden Beach Board and staff. The framework for this master plan is based upon conducting an inventory of the existing park system, recording site observations, and evaluating public comments made at community input sessions. The assessment of existing park facilities, or lack thereof, will identify the immediate needs in the community and predict future needs.

Another purpose of the master plan is to analyze and recommend the addition or renovation of parks, programs, and recreational facilities. It also prioritizes certain projects, such as recommended park upgrades or possible expansion, by taking into consideration the identification of user population and the development of recreation standards. The master plan is action-oriented and will provide the Town of Holden Beach with a practical guide for the enhancement of its facilities and programs for the next ten (10) years.

In preparing the Town's Comprehensive Parks and Recreation Master Plan, a steering committee made of Town planning and recreation staff members was created to help guide the McGill team in the development of the public survey and master plan goals and recommendations. A key objective in the development of the master plan was the solicitation of community input. This



feedback identifies additional needs for Town residents, such as renovation, construction, property acquisition, development, and operational policies, for now and in the future. Community input, along with the comparison to state and national standards are the initial steps in the master plan process.

State and national standards were used as a guide to support the recommendations made for the Town of Holden Beach's recreation facilities. Using these standard guidelines, McGill developed a plan which applied specifically to the resident and non-resident users of the Town's recreation facilities.

The master plan emphasizes practical and more desirable improvements to the existing recreation system, including parks and recreational facilities. It is not designed to be exclusive but rather to enhance recreational opportunities in the community. It is intended to maintain the type of venue in the Town of Holden Beach that fosters community spirit, activism, and bonding between local citizens.

A study of the demographic profile of Town residents is a key factor in making specific and accurate recommendations.

Not only does the master plan make recommendations for a 10-year period (2021-2031), but it also suggests how the identified objectives might be achieved. Opportunities for grants, partnerships, and outside funding are recommended as aids in the establishment of a capital improvement plan and an operating budget.

The master plan focuses on providing the Town with an accurate, usable guide for decision-making as the Town begins to implement projects, such as:

- Renovating existing facilities currently owned by the Town of Holden Beach
- Exploring the possibilities for developing new facilities
- · Developing facilities and programming for future parks and greenways
- Updating policy and ordinances to meet community needs and desires

It is commonly accepted that physical activity through recreation and park use improves one's overall mental and physical health. Availability of recreation resources is a factor that influences an individual's physical activity behavior. (Availability of Recreation Resources and Physical Activity in Adults, Am J Public Health. 2007 March; 97(3): 493-499.) Due to the fact that the Town of Holden Beach is an island, the majority of the Town's recreation facilities and amenities are centrally located.

Different strategies to mitigate the issue of recreation availability may entail new developments, including a basic set of recreation amenities for new residents, as



well as investing in a trail network that provides safe pedestrian access to park facilities.

Extensive research demonstrates the positive economic impact of recreation, parks, and tourism on local economies. The Town of Holden Beach is currently attracting new residents and tourists eager to experience the quality of life it provides. The Town can leverage its many natural, historic, and recreational resources, and continue to develop its amenities by improving public spaces, park facilities, programming, and events. Recommendations in Section 4 present achievable actions that support the Town's goals and ability to serve its residents.

The Town of Holden Beach Comprehensive Recreation Master Plan is divided into five major component sections:

<u>Recreation Needs Assessment – Preference Exercises</u>

The community input sessions included a preference exercise that allowed participants (tourists, visitors and local residents) to share their top preferred amenities for the recreation system. Overall, the preference exercise results indicate little difference between the top preferred choices between locals and tourists. To reiterate:

Top 7 amenities for locals were:

- 1. Canoe/kayak launch (35 votes)
- 2. Natural surface trails (34 votes)
- 3. Bike path (30 votes)
- 4. Fishing dock (25 votes)
- 5. Accessible play features (19 votes)
- 6. Dog park (18 votes)
- 7. Boardwalk (17 votes)

Top 7 preferred amenities for tourists:

- 1. Natural surface trails (55 votes)
- 2. Restroom building (53 votes)
- 3. Fishing dock (49 votes)
- 4. Canoe/kayak launch (35 votes)
- 5. Dog park (31 votes)
- 6. Bike path (30 votes)
- 7. Accessible play features (29 votes)



Both groups polled preferred similar recreation amenities except for 2 items. The tourist group listed a preference for restrooms. This is an understandable desire considering many tourists are day trippers or not sleeping over via on-island lodging. The local's top 7 list differed from the tourists in that they included a boardwalk amenity.

Focus Group Interviews

A complete list of focus group major themes and/or topics mentioned by each group can be found in Appendix D. Seven different groups of participants were interviewed via a virtual meeting using Microsoft Teams' meeting platform. Each meeting lasted approximately one hour. Participants were encouraged to share their opinions and feelings about the future of Holden Beach Parks and Facilities. We are deeply appreciative for the time and effort given to the town by these citizens.

The top seven items mentioned by these groups are in order of number of times mentioned:

- a. Programs/classes
- b. Bike path/lane
- c. Trails
- d. Dog park
- e. Launches
- f. Fishing
- g. Tennis, pickleball, fitness (equal mentions)

Facility Improvements Recommendations

Site visits and information provided by Town staff were used to access and make recommendations for needed improvements. The following lists contain recommendations for improvements to existing facilities within the Town's recreation system:

Bridgeview Park

- Ongoing maintenance
- Design a small area plan to tie together Bridgeview Park, public restroom building, and Jordan Boulevard Pavilion via an attractive linear park/multi-use trail



- Add separate fishing platform/wildlife observation deck
- Assess basketball backboard hoops for needed repairs
- Add shade and additional seating near basketball court



Jordan Boulevard Pavilion

- Update parking area (repave)
- Create annual plan to assess gazebo/shelter for needed maintenance/repairs
- Add accessible connection path with Bridgeview Park
- Improve ADA accessibility



Sailfish Drive Park

- Provide accessible canoe/kayak launch
- Construct covered picnic/gathering space (gazebo, shelter structure, etc.)
- Add educational signage about local history or natural resources of Holden Beach



- Add additional picnic facilities (furnishings and shade)
- Delineate parking spaces
- Add restroom facilities (waterless restroom)
- Improve ADA accessibility

796 Ocean Boulevard

- Consider reuse of this structure as a community recreation resource
- Bathhouse (restrooms/showers)
- Classroom or exhibit space
- Rentable meeting space (with kitchen)
- Improve parking layout
- Improve accessibility ADA



Sand Dollar Park

- Add picnic tables and bench swings to the east side of the park
- Add an educational kiosk discussing natural heritage
- Add wayfinding trail signage to connect to existing trails on adjacent property to the east



Halstead Park

- Improve/repair existing pier and fishing platform to meet ADA accessibility
- Consider adding fish cleaning station to fishing platform
- Develop accessible canoe/kayak launch off existing pier 30' back from highwater mark
- Add educational signage
- Evaluate the parking layout for a more efficient design
- Evaluate the facility for code compliance

Holden Beach Pocket Park

- Ongoing maintenance
- Consider revolving sculpture display (partner with area artists)
- Improve ADA accessibility



Holden Beach Fit Trail

- Update equipment and provide instructive/usage signage
- Improve ADA accessibility by paving stations with pervious concrete

Olden Holden Bike Route

- Work with the North Carolina
 Department of Transportation on the
 potential for separate bike lane on
 Ocean Boulevard and/or sidewalk
 widening to accommodate increasing
 population of users
- Improve ADA accessibility



Beach Access Sites

- Develop highly visible signage noting available public parking locations
- Market beach access sites via widely available brochure maps
- Work with the North Carolina
 Department of Transportation on the potential for high visibility pedestrian crosswalks, where appropriate







- Consider beach access matting where needed for ADA access
- Add waterless restroom facility at McCray Street parking area
- Add waterless restroom facility at end of Ocean Boulevard E. right-of-way
- Add doggy-bag stations at all access sites

Future Park Development Considerations

Section 4 of this document will describe recommended future park development. The areas discussed include:

- Holden Beach Pier (future community park)
- Street Right-of-Way ICWW Access Points (future)
- Scotch Bonnet Park (future community park)
- Sandspur Waterway Walk (future boardwalk/trail)
- Possible locations for a dog park

In Section 4.5 the need for typical recreation amenities are assessed and recommendations are discussed for the following:

- Multipurpose Fields for Football, Soccer, and Lacrosse

- Walking /Hiking Trails and Bikeways

Staffing And Maintenance Recommendations

Section 4.6 discusses staffing needs and provides recommendations. The Town of Holden Beach Parks and Recreation Department's structure consists of one full-time employee. Maintaining adequate staffing for parks and recreation facilities and programs will be necessary to foster a good quality of life for Town residents and prospective businesses that may seek to relocate to the Town of Holden Beach. The existing and proposed staffing levels for the Holden Beach Parks and Recreation Department are as follows:

Maintenance Staffing Recommendations

Staffing for maintenance is dependent on the levels of service the Town wishes to provide to each facility. The Town should consider creating a maintenance plan which includes details of number of hours and level of service for each maintenance task (mowing, repairs etc.). These plans are documented in the NRPA, Commission for Accreditation of Park and Recreation Agencies (CAPRA) standards and are recommended to be reviewed for a future maintenance plan for the Town.

Projects For Development

The park system for the Town of Holden Beach should continue to grow and respond to changes in Town demographics. Future planned facilities should be implemented incrementally to provide for these changes. Section 4.7 provides a list of recommended projects divided into those recommended for implementation within the first five years after plan adoption (2021-2026) and those for the second five-year period (2027-2031). The prioritization of projects should consider available funding, and political will to implement.

The main categories of projects include:

- Needed improvements to existing Town of Holden Beach-owned facilities
- Development of planned facilities to meet the *current* needs of recreation for Town residents
- Development of planned facilities to meet the future needs of recreation for Town residents

- Provide accessible canoe/kayak launch (Sailfish)
- Construct covered picnic/gathering space (gazebo, shelter structure, etc.) (Sailfish)

- Where feasible, design and construct waterless restroom facilities at suitable beach access sites

SECTION 1 POPULATION TRENDS AND PROJECTIONS

1.1 TOWN HISTORY

The area surrounding the Town of Holden Beach began to see development before the Revolutionary War as a land for agricultural uses. The proximity to Lockwood Folly River also made the area a desirable location for transportation purposes. Holden Beach is a narrow coastal barrier island that was originally purchased by Benjamin Holden in 1756, along with four mainland tracts. The Holden family utilized the island for fishing and cattle grazing.

During the Civil War, the inlet on the east side of the island leading to Lockwood Folly River was a dangerous place for ships and several blockade runners resulting in ships running aground and sinking in 1864. The remains of one ship, the CSS Bendigo, can still be seen during low tide — creating an artificial reef for aquatic life.

While the Holden family-maintained ownership of the island, a commercial fishery was started, as well as the beginning ideas of the Holden Beach Resort. A bridge was initially built in 1925, however with the construction of the Intracoastal Waterway, it was destroyed. A public ferry was negotiated for and became operable in 1934. In the 1940's, when land and an oceanfront house could be purchased for \$600, development began to occur on the island for permanent residents, second homeowners, and as a vacation destination.

1.2 LOCAL SETTING

The Town of Holden Beach, known as the Family Beach, is located midway between the popular and commercialized coastal cities of Wilmington, NC and Myrtle Beach, SC. However, as a small coastal barrier island, it exudes the feeling of a quaint beach town. With over eight miles of clean, sandy beaches and a year-round moderate temperature, Holden Beach is a place that many visitors choose to experience a unique, quiet, family-oriented atmosphere. The small downtown area on the island is considered by many as a reason to keep coming back year after year.

Boating, fishing, hiking, and shell hunting on the island are very popular activities. Golfing is another popular activity and there are over 125 superb golf courses located within close proximity of the island. The island is also a sea turtle habitat and during the hatching season (May – October) visitors can witness one of



nature's most interesting pleasures — watching hundreds of small sea turtles boil out of the sand and march to the ocean.

Holden Beach, with its small coastal island feel, provides both residents and visitors a wholesome family-oriented atmosphere that also offers access to a beautiful coastal setting. This environment, along with the natural setting, provides great opportunities for multiple forms of recreational activities that will improve the community's quality of life.

1.3 DEMOGRAPHIC PROFILE

A review of the demographic information for the Town of Holden Beach has been evaluated to better understand the characteristics of the community. It also serves as a tool to identify future trends and projections that may influence recreation and park planning. Information concerning age and gender are important factors in determining the needs for recreation in the community. The table below contains the general demographic characteristics for full-time residents of Holden Beach, as ascertained by the 2019 North Carolina Office of State Budget and Management (NC OSBM) estimates.

In 2000, the population of the Town of Holden Beach, according to the U.S. Census Bureau, was 787. However, possibly a reflection of the economic downturn that occurred in 2008–2010, the Town population in 2010 had dropped to 575, a decrease of 26.9%. Since that time, there has been an increase, according to the NC OSBM, back to 675 residents, showing a growth of 17.4% from 2010 to 2019. This is a trend that will likely continue as more and more individuals are attracted to the coastal lifestyle and the opportunities that it provides.



When planning recreation, it is important to consider the impact of vacationers. visitors, and temporary residents visiting the community on a seasonal basis. Typically, the seasonal population has the greatest impact on services and resources from the end of May to the beginning of November. Populations in beach municipalities can vary throughout a given year. Determining how the seasonal population impacts a town can be difficult due to the range of factors that must be considered in estimating the peak population. In addition, population (year-round) figures established by the NC state demographer and the US Census Bureau do not account for the seasonal population. This requires figures to be estimated based upon best available data. Based on 2015 NC OSBM housing data there were 2,382 available housing units. Of these 2,382, there are 978 that are occupied year-round. Based on this information the total housing available for vacation rentals is 1,404. According to the Cape Fear Council of Governments 2019 Land Use Plan for the Town, the approximate estimated peak seasonal population grows to around 20,000+. While the permanent residents of the Town of Holden Beach are the key members to plan for, it is also important to understand that the seasonal population plays a big role in how the park facilities are used and any necessary recommendations must account for this large group of people.

1.4 TOWN OF HOLDEN BEACH POPULATION PROJECTIONS

Population projections can vary widely due to intervening factors such as the strength of the economy, availability of jobs, and housing prices. Population projections identify potential challenges and needs that may confront the community in the future.

County population projections are provided by the NC OSBM; however, municipal population projections are not. The NC State Demographer's population components of change estimate that Brunswick County's population will increase from migration into the County. Components of change from natural growth, births and deaths, will have a minor change in the County's population decline, however the increase will be far greater than the decrease. It is also assumed that this trend of population change will be the same for Holden Beach.

According to the NC OSBM, in 2020, the permanent population of Brunswick County was projected to be 147,644 people, whereas in 2030, the permanent population is expected to be 180,776 people. This is an increase of about 33,132 people or 22.4%. If the same percentage increase was applied to the 2019 NC OSBM estimate population of 675 for Holden Beach, the estimated increase for 2030 would be 826. The future population will be limited by the availability of land and the pace and type of future development.



1.5 STATE POPULATION TRENDS

the According Carolina to North Comprehensive Statewide Outdoor Recreation Plan (SCORP) 2020-2025, senior citizens comprise the fastest growing group. The age senior population is expected to have significant impacts throughout society because of income levels, population, and unique needs. The NC OSBM projects that by the year 2030, one in five North Carolinians will be 65 years old and older.



More senior adults are seeking active lifestyles as part of their daily routines.

This growing segment of our society is a significant user of recreational programming and facilities. The Town's Parks and Recreation Department will have to increase the number and type of activities and facilities to effectively serve this population, both now and in the future. To meet the demands of residents and visitors, the Town will have to continually evaluate its recreation and ancillary facilities, as well as offer more types of recreational programs as the population changes.

SECTION 2 EXISTING PROGRAMS, PARKS, AND FACILITIES

2.1 FACILITY INVENTORY



Bridgeview Park offers a mix of recreation amenities in a central location.


This section will look at all the facilities currently offered to fully understand the recreational opportunities that the Town of Holden Beach has access to. These recreational facilities derive from many different sources, including the following:

- Town-owned parks and other recreational facilities
- Privately-owned facilities
- County-owned facilities
- Other local municipalities
- Schools

As of the writing of this plan a brief analysis of the Town's recreation facilities was performed noting any visible improvements needed for each facility. The necessary improvements to existing facilities can be found in Section 4. This method of study served as a guide for the Town in its efforts to develop a plan for present and future needs.

The Town of Holden Beach residents and visitors have many of their recreation needs met through the facility offerings currently owned by the Town. In addition to the facilities owned by the Town, recreational opportunities are provided by private facilities, county parks, and the surrounding communities.

Parks

Bridgeview Park

Bridgeview Park is a great recreational facility for residents and visitors on the island. The park is located adjacent to the Town Hall and is along the sound side of the island along the Intracoastal Waterway (ICWW). It provides access to a basketball court that is also striped with (2) pickleball courts. Additionally, there are open green



space, a splash pad area, a picnic shelter, a playground area with shade sails, and bocce courts. Visitors can also access the water for nature observation and canoe/kayaking on the dock with (2) canoe/kayak launches, and a boat dock that can be leased for short stays on the island for a nominal fee by transient boaters with boats that are greater than 26' long. Registered users have access to restrooms/showers and laundry facilities.



Jordan Boulevard Pavilion

Jordan Boulevard Pavilion is the island's oldest park and is a great place for water access. The park is located on the western side of the bridge that connects to the mainland along the sound side of the island. It provides visitors access to open space, a fishing dock with a shelter, a



large picnic pavilion, public Wi-Fi, and nature observation. Tai Chi classes have been offered periodically at this location. Adjacent to the Jordan Boulevard Pavilion is a motorized boating access location (launch). The boat launch is under the Holden Beach Bridge on the ICWW and allows boaters and anglers access to the water from the island.

Emergency Operations Center

This Town-owned facility is in Brunswick County, just a few miles off the island of Holden Beach, and is zoned under the jurisdiction of the Town of Holden Beach. This facility houses the Town's emergency operations and vehicle fleet and contains a training room with an occupancy load of 40 people and a kitchen. This space is primarily used for recreation programming (classes, meetings, etc.)

Sailfish Drive Park

Sailfish Park is a small passive park located on the western end of the island along the sound side of the island. The park provides visitors access to open space, a fishing dock, picnic tables, nature observation, and a sand beach with ICWW (water) access.



Sand Dollar Park

Sand Dollar Park is a passive park located at the end of Sand Dollar Drive. The park is predominantly coastal marshland along the ICWW. It provides visitors access to open space and a nature observation. Its natural setting also provides a great habitat for coastal flora and fauna. This location also offers water entry to the ICWW with an informal canoe/kayak launch.



Halstead Park

Halstead Park is a small passive park located to the east of the bridge along the sound side of the island. The park provides visitors access to a fishing dock, a picnic shelter, and seating. This is one of the of many destinations along the Olden Holden Bike Route and provides cyclists bike racks to park and take in the environment.



Holden Beach Pocket Park

Holden Beach Pocket Park is a small passive park located midway on the island along Ocean Boulevard. This mini park offers visitors access to a beautifully landscaped location for seating and nature observation. It is also a space to take a break while walking along the sidewalk or cycling the Olden Holden Bike Route.



Special Use Facilities

Holden Beach Fit Trail (Fitness Stations)

Holden Beach provides a unique recreational amenity to promote the health and well-being of residents and visitors. Along the sidewalk on Ocean Boulevard between Scotch Bonnet Drive and Greensboro Street, the Town has provided (9) fitness stations. By providing this amenity, it shows the desire to provide the quality of life that the people desire in a creative way where land is scarce.





Padgett Garden

The Town has partnered with the Holden Beach Beautification Club to provide well-landscaped areas that enhance the quality of the island, as well as furnish spaces that people can find respite while exploring the Town. Padgett Garden is located at the intersection of Ocean Boulevard and Holden Beach Road as




you cross the bridge and enter Holden Beach. The garden provides a short walking path, seating, and shade structures that are surrounded by lush landscaping, statuary, and a water feature with memorial stones.

796 Ocean Boulevard

The Town owns a home adjacent to a sewer lift station at 796 Ocean Boulevard. This property has views of the marsh and ocean. The home has two bedrooms and a half bath on the top floor, and two bedrooms and a full bath, living room, and kitchen on the bottom floor. Ample parking is available with additional space for parking along Ocean Boulevard. For possible uses see page 38.

Butterfly Garden at Holden Beach Fire Station

The Town has partnered with the Holden Beach Beautification Club to provide well-landscaped areas that enhance the quality of the island, as well as furnish spaces that people can find respite while exploring the Town. The Butterfly Garden is located along the back of the Holden Beach Fire Station. It offers a picnic table and seating to people who visit this quaint garden.





Bicycle Routes

Olden Holden Bike Route

The Olden Holden Bike Route is a traverse of the island that explores the local history and allows users to experience the natural beauty of this coastal region. This bike route has three different segments that can either be used individually or linked together to provide approximately 20 miles of island biking. The Olden Holden Bike Route also hits all the recreational facilities that Holden Beach offers.

Beach/Water Access Sites

Holden Beach is a barrier island along the Atlantic Ocean and as such has over 8 miles of beautiful beaches and is bordered to the north by the ICWW. The Town provides 23 public beach access points to allow visitors the opportunity to enjoy the public beaches. Each of these places have different levels of access. While some of them provide parking, restrooms, and showers, others provide only a boardwalk or cut through the dunes to allow visitors beach/water access. Below is a list of known public beach access sites (available parking opportunities noted):

- 10. End of Jordan Boulevard (parking and public restrooms available)



- 11. Between Jordan Boulevard and the bridge access ramp (showers provided and ramp to beach, drop off space, 15-minute parking only)
- 12. Adjacent to 301 Ocean Boulevard. West (limited parking on Neptune Street)
- 13. Adjacent to 329 Ocean Boulevard West (limited parking on Neptune Street)
- 14. Adjacent to 357 Ocean Boulevard West (limited parking on High Point Street)
- 15. Adjacent to 389 Ocean Boulevard West (limited parking on Fayetteville Street)
- 16. Pier Area (2) (parking in pier lot)
- 17. Adjacent to 567 Ocean Boulevard West (limited parking on Starfish Street handicapped parking available)



Section 3 Recreation Needs Assessment

3.1 INTRODUCTION



The degree of need for parks, recreation, and open space is most directly influenced by the expectations of the Town of Holden Beach residents, relating strictly to the quality of life to which they aspire. This master plan addresses, as its first priority, the parks and recreation facility needs envisioned by the residents and visitors of the Town of Holden Beach.

Section 2 of this master plan inventories the Town's existing programs, parks, and facilities, as well as lists the recreation facilities available at local schools, other public municipalities, and private recreation facilities near the Town. It also looks at county parks within proximity to Town. This detailed inventory includes the facilities which are available within each park to create a better understanding of the existing recreational opportunities within the Town. The demographic and population trends (found in Section 1 of this master plan) provide information needed to understand the expected growth of the Town in the future. This master plan will be used as a guide for improving recreational opportunities for residents and visitors.

Community input and recreation standards are primarily used when determining adequate park types and numbers of facilities needed for the Town. This master plan compares standards developed by the National Recreation and Park Association (NRPA), an independent, non-profit professional organization for park/recreation departments nationwide as guidance when making long range recreation planning recommendations. NRPA recognizes the uniqueness of



communities and their recreation departments. Therefore, currently the NRPA recommends recreation providers seek public input and use community desires and needs to determine the types and quantities of future recreation facilities.

Recreational standards are guidelines, *not requirements*, for use by communities in estimating the demand for parks and recreation in their given geographic areas. To assure that the Town's Parks and Recreation Master Plan contains distinctiveness, yet versatility, input was sought from its integral components: the project steering committee, Town staff, Town Board of Commissioners, and citizen representatives.

3.2 TYPES OF PARKS AND RECREATION FACILITIES

A comprehensive park system is made up of a variety of park types ranging from small neighborhood playgrounds to larger parks with athletic fields, playgrounds, community centers, and open space. The type of park reflects the differing recreational preferences of diverse users. Park models are used as guidelines for fulfilling the future recreational needs of communities. Not all these types of parks are the responsibility of the Town government; several agencies (federal, state, county, and other local municipalities) play roles in providing recreational opportunities as well. To further understand the Town's role in providing recreation services to its citizens, it is necessary to understand the elements of a comprehensive park system. These types of parks and recreation facilities may or may not be included in comprehensive park systems. Examples of typical park types are described in more detail in Appendix G. The typical park types are:

- Regional parks
- District parks
- Community parks
- Neighborhood parks
- Mini parks
- Linear parks/greenways
- Special use facilities
- Open space

Holden Beach is an island with limited available land for development. Currently the Town provides neighborhood and mini parks, as well as natural open space (beach strand, marsh areas, etc.). Linear parks and boardwalks are future park types which could be developed for Holden Beach residents.



3.3 PUBLIC INPUT NEEDS ASSESSMENT

The methodology used in establishing the Town's Comprehensive Recreation Master Plan should always include citizen input. In order to ensure a successful study, it is vital that the public users of recreational facilities be able to share their issues, needs, and desires.

Community Involvement

To facilitate public input two (2) community input sessions were conducted during the master plan process. These public input opportunities were held on April 2nd and April 3rd, 2021. These sessions, along with the community survey, were advertised by the Town on their website and via recreation department social media. The promotion of the public input opportunities and survey was also made available through project information cards that were distributed to individuals by the project team and word of mouth. Approximately 181 individuals participated in the community input sessions. April 2nd saw approximately 33 tourist participants and 63 local participants. April 3rd included approximately 73 tourist participants and 12 local participants.

The community input sessions were held over the Easter Weekend on Good Friday and the following Saturday. The information shared included mapping and visual preference exercises, as well as open dialog and question/answer opportunities. At both events, written notes were used to record participant comments and opinions. A visual preference survey of various park amenities gave participants the opportunity to vote for the amenities they felt would be good additions to the Town's park system. Each participant was limited to two favorites. To help delineate between locals and tourists a different colored marker was used to show what participants desired. A large map provided participants with the existing locations of each of the recreation system's facilities and other destinations, such as private facilities and schools. Participants were



asked to provide insight into where potential new recreation facilities might be located. These boards gave everyone an opportunity to share their opinions and thoughts in creating a list of hopeful changes to the existing recreation system. This was a crucial step to ensure that attendees were able to be heard, voice their concerns, and receive clarification.

Results of First Input Session - Friday, April 2, 2021

The first community input session was held on Good Friday at two different times throughout the day. Approximately 93 participants engaged in open conversation related to their opinions on the state of the existing recreation system, including facilities and programs, as well as their concerns and questions. The dominant participants at this public event were locals.

Common concerns that were addressed included:

- Need for bike lanes to improve biking opportunities
- Desire for more public water access for fishing and canoe/kayak launch
- Desire for natural surface trails

Participants were asked to choose two amenities from a Visual Preference Survey that they would most like to see offered by Holden Beach's Parks and Recreation System. They were each asked what amenities they would like to see provided. A mark was placed next to the images that best correlated with their preferred amenities. Locals and tourists were given different colored markers to gain an understanding of what was desired by each individual group. The locals want bike paths (30 votes) and natural surface trails (28 votes). The tourists would like to see natural surface trails (15 votes) and more canoe/kayak launches (14 votes). The Visual Preference Board for community input session 1 is in Appendix B.

Results of Second Input Session — Saturday, April 3, 2021

The second community input session was held at various local parks and beach access points across the island. Approximately 88 participants engaged in open conversation related to their opinions on the state of the existing recreation system including facilities and programs, as well as their concerns and questions. Most of the participants for this community input event were tourists.

Common concerns from the second public input session were similar to the first community input session which included:

- Restrooms
- Additional fishing docks
- Additional natural surface trails
- Dog park



Participants were asked to choose two amenities from a Visual Preference Survey that they would most like to see offered by Holden Beach's Parks and Recreation System. They were each asked what amenities they would like to see provided. A mark was placed next to the images that best correlated with their preferred amenities. Locals and tourists were given different colored markers to gain an understanding of what was desired by each individual group. The locals want natural surface trails (6 votes), restroom buildings (5 votes), and bike paths (4 votes). The tourists would like to see restroom buildings (47 votes), fishing docks (40 votes), and more natural surface trails (40 votes). The Visual Preference Board for community input session 2 can be found in Appendix B.



Overall, the combined participation from the 2 community input sessions for the visual preference exercise resulted in different top 10 preferences. The amenities listed below represent the desires of the locals, starting with the most desired amenity.

- 1) Bike paths
- 2) Natural surface trails
- 3) Fishing dock
- 4) Canoe/kayak launch
- 5) Accessible play features
- 6) Dog park
- 7) Boardwalk
- 8) Community center
- 9) Tennis
- 10) Boat ramp

The following amenities represent the desires of the tourists, starting with the most desired amenity.

- 1) Natural surface trails
- 2) Restroom buildings
- 3) Fishing dock
- 4) Canoe/kayak launch
- 5) Dog park

- 6) Bike path
- 7) Pickleball
- 8) Accessible play features
- 9) Boardwalk
- 10) Picnic shelter



Overall, the preference exercise results indicate little difference between the top preferred choices between locals and tourists. To reiterate, the top 7 amenities for locals were:

- 1. Canoe/kayak launch (35 votes)
- 2. Natural surface trails (34 votes)
- 3. Bike path (30 votes)
- 4. Fishing dock (25 votes)
- 5. Accessible play features (19 votes)
- 6. Dog park (18 votes)
- 7. Boardwalk (17 votes)

Top 7 preferred amenities for tourists:


- 1. Natural surface trails (55 votes)
- 2. Restroom building (53 votes)
- 3. Fishing dock (49 votes)
- 4. Canoe/kayak launch (35 votes)
- 5. Dog park (31 votes)
- 6. Bike path (30 votes)
- 7. Accessible play features (29 votes)

Both groups polled preferred similar recreation amenities except for 2 items. The tourist group listed a preference for restrooms. This is an understandable desire considering many tourists are day trippers or not sleeping over via on-island lodging. The local's top 7 list differed from the tourists in that they included a boardwalk amenity.

The following images are a compilation of the results from both community input sessions. The amenities that the locals desire are marked in **black** and those that the tourists would like to see are marked in **red**.











FOCUS GROUP INTERVIEWS

As part of the planning and community input collected for this study, meetings were conducted March 3rd - 10th of 2021. Seven groups comprised of 52 private citizens were interviewed in broad groupings. The groups were:

The Steering Committee (3.3.21)
Realtors (3.8.21)
"Hodgepodge" – General Citizens (3.9.21)
Retirees (3.8.21)
Families (3.10.21)
Landscaping and Arts (3.5.21)
Water Based Recreation and Exercise Enthusiasts (3.9.21)

A complete list of focus groups' major themes and/or topics mentioned by each group can be found in Appendix D.

These focus groups met virtually due to Covid-19 restrictions. These meetings encouraged participants to share their opinions and feelings about the future of Holden Beach Parks and Facilities. The information shared is indicative of the desires and/or concerns of group participants. The time and effort given to the Town by these citizens was critical in discovering the needs of the variety of people that live in and visit Holden Beach.

Overall, there was a shared belief that recreation is a valuable part of the quality of life for residents and visitors to the Island and that those activities enhanced the natural coastal amenities of Holden Beach. Water access, accessibility, and walking/biking paths were of great interest between all the groups interviewed. Enhancement of existing amenities and the expansion/development of new amenities was also supported.

The analysis of the comments provided indicated the following items as major themes (in order of most to least popular mentioned):

- a. Programs/classes
- b. Bike path/lane
- c. Trails
- d. Dog park
- e. Launches
- f. Fishing
- g. Tennis, pickleball, fitness (equally mentioned)



Community Survey

The active participation of residents in the Town of Holden Beach was crucial in developing a master plan that reflects the true needs of the Town. With this in mind. community input was solicited throughout the entire planning process. A survey was created as tool to gather information from the

general public concerning the existing and future needs of the Town Park and Recreation System. A project marketing card was developed to encourage awareness of the project and provide both a web address to the community survey, as well as a QR code for use via smartphone/mobile devices to connect to the online survey and provide their input.

To gather additional public input and reach the broadest cross section of Town residents, a printed version of the master plan surveys was made available at the town meetings. See Appendix C for complete survey questions and results.

The surveys provided for data collection from all persons in the household of the survey respondent. The return rate for the survey was excellent based on 358 surveys accessed to 358 completed surveys. The surveys represented 609 individuals (data per household size). These results included both the survey handouts collected at public events and the online survey responses. The survey data collected was a representative cross section of the Town of Holden Beach in terms of age and household size.

The surveys were designed to elicit answers on resident's needs and desires for recreation opportunities. It included a section where respondents rated their use of existing facilities both within and outside town limits. The survey instructed respondents to rank the programs and facilities in order of importance to their household and to list the facilities they would like to see added to the park and recreation system.

Conclusions

As the Town of Holden Beach strives to continue providing quality parks and recreation facilities, they will need to understand what kinds of facilities and programming the community desires. Additionally, they should analyze how to obtain funding to pay for such amenities. The input provided by the community at



the public input sessions and via survey responses indicated a desire to strengthen the recreational offerings through updates and new amenities. Some of these included adding trails and biking opportunities throughout the island, construction of a dog park, and water access via canoe/kayak launches and fishing docks. Other amenities to consider are traditional games such as horseshoe, cornhole, and bocce.

3.4 EVALUATION OF PARK LAND NEEDS

When comparing a park system to national standards, one method is to examine the total acreage of the park system. The NRPA Park land guidelines (in acres) for the total service population of the Town of Holden Beach are provided in the following table. Population figures in this analysis are estimated at 675. The acreage requirement is based on the population ratio method (acres of park land per population of 1,000) pre-established for each classification of park.

The Town of Holden Beach's existing recreational facilities have been designed for a smaller population base and include a mix of active and passive recreation facilities. Regional and district park resources provided by state and county systems that are within proximity to the Town can serve the public. Due to the limited resource of land and the influx of people during the busy season, the Town needs to consider how to creatively provide the necessary recreational amenities.

Based on the information contained in Table 3.2, the Town of Holden Beach meets the national standard guidelines for three of the listed park categories, such as neighborhood and mini park acreage needs. It should be noted that regional and district parks are not typically an amenity provided by small- or medium-sized municipalities. However, expansion of the system with future park facilities, trails, and programs will need to be considered to provide improved recreational access to residents and visitors.

3.5 EVALUATION OF FACILITY NEEDS

Level of service standards were established based upon information gathered from the NRPA's *Sports, Fitness and Leisure Activities Topline Participation (SFIA) Report, 2019 Physical Activity Council's Overview Report on U.S. Participation*, and historical evidence from professional experience. Recommendations based upon these standards have been compiled in Table 3.3 in order to assess the current and projected future (up to 10 years) facility needs for recreation facilities in Holden Beach.



Table 3.3 depicts the results of the current and future recreational facility needs assessment based on level of service standards. The charts do not consider community input, which is a primary guide for the development of the master plan.

Based on the information contained in Table 3.3, the Town of Holden Beach meets many of the recommended standard guidelines for many of the typical recreational facilities for their permanent population. In a few categories, the number of existing facilities exceed the level of service recommendations. Keep in mind that the standards do not consider tourist population, which is a large part of Holden Beach's seasonal population. Because of the limited size of the island and the scarcity of available land the Town relies on recreational facilities on the mainland for traditional activities. For this reason, some of the facilities listed above may not be needed for implementation. As future growth occurs, facility needs should be reevaluated.

To better understand not only what recreation resources a community has but how accessible those facilities and programs may be to the general population, this study looked at typical service areas. Typical service areas for each type of recreation facility were previously discussed in this section. Map 3.1 (see Appendix A for larger version) illustrates what portions of the community lie within or near the typical recreation service areas. Populations typically affected include children and seniors that do not drive. Both user groups generally have greater leisure time and can directly benefit from access to parks and recreation facilities.

Solutions to improving recreation in Holden Beach include not only providing facilities and amenities that residents desire and need, but also considering where such facilities and amenities should be located. Existing recreation service areas illustrated above indicate that the island is well served, however the necessary amenities are lacking. Planning for future parks and recreation system expansion should consider developing additional amenities at the existing parks. As new residential and large commercial developments are planned, the Town should take an active role in working with developers on what types of recreation amenities should be provided per the Town's Unified Development Ordinance requirements.

The Town of Holden Beach Comprehensive Parks and Recreation Master Plan considers community workshops, recreation survey findings, projected demand, service area analysis, and Town Staff input as the primary guides in prescribing the current and future recommendations for the Town's parks and recreation development. The following section (Goals and Recommendations) describes those recommendations in more detail.

SECTION 4 GOALS AND RECOMMENDATIONS

4.1 INTRODUCTION

This master plan serves as a map for the future development of recreation facilities for the Town of Holden Beach. The plan incorporates recommendations to accomplish the objectives set forth by the Town Board of Commissioners, the steering committee, and community members. See Appendix H for recommendations. These recommendations are divided into the following categories:

- Role of the Town of Holden Beach
- Roles of Other Recreation Providers
- Park Proposals and Recommendations
- Facility Proposals and Recommendations
- Staffing and Maintenance Recommendations
- Priorities for Development

4.2 ROLE OF THE TOWN OF HOLDEN BEACH

The goal of the Town of Holden Beach Parks and Recreation Department is to provide places of recreation and beauty that fulfill the needs of the residents who call Holden Beach home and provide an atmosphere that visitors will remember and have the desire to come back year after year. To fulfill this goal it will take work, dedication, and funding to maintain the recreational facilities that are currently owned and operated by the Town of Holden Beach, as well as expand the network of parks and recreation opportunities to meet the needs and desires of residents, visitors, and tourists.

To avoid overextending the staff, the Town needs to investigate partnerships with other recreation providers and community groups. Current partnerships need to continue, and the possibility of new partnerships need to be explored.

A large factor to consider is the growing population of tourists visiting the island. The Town's Planning and Parks and Recreation Departments should work together to assess and formulate future strategies to improve and maintain the level of service required for the future of Holden Beach.

4.3 ROLES OF OTHER RECREATION PROVIDERS

Public Sector

Brunswick County

As a barrier island located within Brunswick County, Holden Beach plays an active role in providing tourism and recreational opportunities to both County and Town residents. As the demands for the future of recreational facilities continues to increase, the Town should coordinate future planning efforts with County recreation departments to identify recreation programming, facility expansion, and potential partnerships.

Other Local Municipalities

Oak Island and Ocean Isle Beach, neighboring islands, also have limited available land for parks and programming. Due to the nature of island life, these communities should coordinate facility options and programming needs that will alleviate the pressure that comes from limited land and a high tourism industry. Shared resources and facilities, as well as clearly defined roles related to programming will be critical to avoid offering duplicate or competing services. The Town should also seek partnerships with nearby communities on the mainland, such as Shallotte, to provide recreational programming that is not feasible on an island, such as field-based athletics.

Private Developers

Private developers are an important asset to the Town in providing resources and opportunities for the Town's recreation system. Private developers can assist the Town by the dedication, construction, and/or reservation of future park sites, open space, and/or greenway corridors during the overall development process.



4.4 PARK PROPOSALS AND RECOMMENDATIONS

Existing Facility Recommendations

Understanding the needs and desires of the Town and the community members is essential before making recommendations to the existing park system and expansion possibilities. Community workshops, Town staff discussions, and the recreation survey were integral in helping identify the primary interests and concerns of Town residents.

Geographic equity of park access is also an important consideration to provide short-distance access and service to all Holden Beach residents. An analysis of recreation service areas can be used to make land acquisition recommendations for both current and future needs (see Section 3). Future park site acquisitions should be balanced and proportional to service populations in all areas of Town.


The Existing Service Area map in the preceding section clearly demonstrates where park inequities are occurring. The Town still has opportunities it should pursue via future land acquisition and park development. Map 4.1 shows possible park projects aimed at meeting future (2031) recreation demand. After

assessing the desires from public input, reviewing the needs from the Town, and evaluating the existing service areas, this plan proposes two additional (new) community parks located centrally on the island. The park proposals can offer passive recreational opportunities that promote the goal to provide the quality of life that both residents and visitors are seeking.



This plan also recommends that the Town consider development of a dog park at Scotch Bonnet Park. Providing a space for four-legged furry family members to run around is essential for their health and well-being. The map also proposes possible locations for canoe/kayak launches. Such an amenity will generate additional water access along the intercoastal waterway for fishing and boating.

In Section 3, specific facility needs were identified for the Town of Holden Beach by both the recreation guidelines and the community input process. Subsequently, Section 4 summarizes the Town's needs for their existing facilities and makes recommendations for activities to be considered in the future development of their park system. The following list contains recommendations for improvements to existing facilities within the Town recreation system:

Bridgeview Park

- Implement ongoing maintenance
- Design a small area plan to tie together Bridgeview Park, public restroom building, and Jordan Boulevard Pavilion via an attractive linear park/multi-use trail
- Add separate fishing platform/wildlife observation deck
- Assess basketball backboard hoops for needed repairs
- Add shade and additional seating near basketball court





Jordan Boulevard Pavilion

- Update parking area (repave)
- Create annual plan to assess gazebo/shelter for needed maintenance/repairs
- Add accessible connection path with Bridgeview Park
- Improve ADA accessibility



Sailfish Drive Park

- Provide accessible canoe/kayak launch
- Construct covered picnic/gathering space (gazebo, shelter structure, etc.)
- Add educational signage about local history or natural resources of Holden Beach



- Add additional picnic facilities (furnishings and shade)
- Delineate parking spaces
- Add restroom facilities (waterless restroom)
- Improve ADA accessibility

796 Ocean Boulevard

- Consider reuse of this structure as a community recreation resource
- Bathhouse (restrooms/showers)
- Classroom or exhibit space
- Rentable meeting space (with kitchen)
- Improve parking layout
- Improve accessibility ADA



Sand Dollar Park

- Add picnic tables and bench swings to the east side of the park
- Add an educational kiosk discussing natural heritage
- Add wayfinding trail signage to connect to existing trails on adjacent property to the east



Halstead Park

- Improve/repair existing pier and fishing platform to meet ADA accessibility
- · Consider adding fish cleaning station to fishing platform
- Develop accessible canoe/kayak launch off existing pier 30' back from highwater mark
- Add educational signage
- Evaluate the parking layout for a more efficient design
- Evaluate the facility for code compliance

Holden Beach Pocket Park

- Implement ongoing maintenance
- Consider revolving sculpture display (partner with area artists)
- Improve ADA accessibility



Holden Beach Fit Trail

- Update equipment and provide instructive/usage signage
- Improve ADA accessibility by paving stations with pervious concrete

Olden Holden Bike Route

- Work with the North Carolina Department of Transportation on the potential for separate bike lane on Ocean Boulevard and/or sidewalk widening to accommodate increasing population of users
- Improve ADA accessibility



Beach Access Sites

- Develop highly visible signage noting available public parking locations
- Market beach access sites via widely available brochure maps
- Work with the North Carolina Department of Transportation on the potential for high visibility pedestrian crosswalks, where appropriate
- Consider beach access matting where needed for ADA access
- Add waterless restroom facility at McCray Street parking area
- Add waterless restroom facility at end of Ocean Boulevard E. right-of-way
- Add doggy-bag stations at all access sites

Future Park Development Considerations

The following list contains recommendations for improvements to future /proposed facilities within the Town of Holden Beach recreation system.

Holden Beach Pier (Future Community Park)

This study has identified public desires for additional recreation amenities, as well as convenient access to the beach strand. The pier is currently a privately owned property that is one of the largest open spaces on the island. Public procurement of the existing Holden Beach Pier would provide



the Town with a large space to develop public recreation amenities needed to meet the growing demands of residents and visitors. In order to provide a quality facility to the public, the Town will need to conduct studies to assess the necessary repairs so that the pier is up to code. A site master plan will also need to be created to gather community input and determine the improvements that will best suit the needs and desires of the Town and community.

Street Right-of-Way ICWW Access Points (Future)

Northern terminus points of some Townowned streets could be improved to provide public access to the ICWW for water sports (canoe/kayak, fishing, wildlife observation, etc.) Each location would present unique conditions and design challenges; thus, each project would need careful planning and design.





Improvements may be as simple as signage and a small wooden or natural path to the water while other locations might support pervious parking spaces or other more substantial amenities. The Town would need to verify the permitting requirements needed prior to making any improvements. Potential areas identified for public water access improvements include:

- Boyd Street
- Roger Street
- Davis Street
- Sand Spur Lane (at Sand Dune Lane)
- Quinton Street SW (privately owned)
- Ferry Road (at Canal Drive) offers potential for small parking area
- Conch Street

Scotch Bonnet Park (Future Community Park)

The existing Scotch Bonnet site (18.6 acres) was recently used as a dredge spoils site. Prior to this use the Town had developed minimal recreation uses such as a dog park. It is recommended that the Town conduct a site master plan to explore the redevelopment of this location for recreation purposes again. This future community park would be able to meet the public demand for a dog park. It is recommended that site improvements include natural surface walking trails with educational signage that link to the ICWW and the adjacent Drew Griffin Environmental Research Facility, canoe/kayak access to the ICWW, a picnic shelter, and bench seating.

Other design considerations should include benches, shade structures, and parking. Parking could be installed along Scotch Bonnet Drive. It will be important to address accessibility of all amenities and connectivity to the Ocean Boulevard pedestrian path.

The Town owns the adjacent parcel to the east of the Scotch Bonnet site. These trails could host a disc golf course, as well as wildlife observation opportunities. Extending natural surface trails to this parcel is recommended. Such an extension could become part of a more expansive trail network that connects the areas between Heron Landing Way and Greensboro Street.

Sandspur Waterway Walk (Future Boardwalk/Trail)

As mentioned above, the Town of Holden Beach should consider the development of a trail along the ICWW that would connect from Swordfish Drive to Greensboro Street. Such a trail would link up several spoil sites on the island, the Scotch Bonnet site, and the Drew Griffin Environmental Research area and would connect to the existing Olden Holden Bike Route. Such a trail network would need to be planned and constructed in multiple phases and require careful design and permitting. The Sandspur Waterway Walk would become a much-



loved destination for walkers and could serve as a desirable recreational resource for the community.

Possible Locations for Future Dog Park

As part of the Town's 2021 Comprehensive Recreation Master Plan needs analysis, the Town of Holden Beach has requested that optional locations be explored for siting a future dog park. Historically, the Town dog park was on Scotch Bonnet Drive but was eventually closed and used as a dredge spoil site. The site has recovered from this use and could be redeveloped for recreational uses that may also include a dog park. This site and seven other locations are being recommended for further analysis by the Town (see options below). Aerial images shown are from the Brunswick County GIS online mapping site and show areas outlined in blue that offer possible useable space and areas in red to indicate potential fenced areas. All options would require more intensive investigation to determine final suitability.

The Town currently has two areas of right-of-way land, which are designated as transportation corridors, between Ocean Boulevard W and Brunswick Avenue W. Each of these parcels are one-third of an acre and would provide the opportunity for a small dog park. These areas also afford the possibility for on-street parking and are centrally located on the island. See images of these sites on the next page.

Scotch Bonnet Drive (parcel number: 231MC001 – 20.92 acres)

It is suggested that **1.5 acres** of this space be used to develop 2 separate fenced (small and large) dog park areas.



1.5 acres could provide for separate small and large dog areas.

Scotch Bonnet Drive (parcel number: 246CE07103 – 4.34-acres)

This 4.35-acre site is a mix of marsh and drier land. Approximately 0.5 acres could be fenced for use as a dog park. Parking could be on the street.







This area offers the opportunity for on-street parking and has established trees for shade.

4.5 FACILITY PROPOSALS AND RECOMMENDATIONS

In Section 4.5, specific facility needs were identified for the Town of Holden Beach by the community input process and the recreation guidelines set forth. This section follows up on these needs and provides facility recommendations for the Town's existing and proposed park sites. These facilities will provide users with multiple recreation opportunities within the park system.

Baseball/Softball

The Town currently has no adult/youth baseball fields. Due to the limited availability of land and the general population being seniors, it is not recommended to incorporate this type of recreational facility on the island. The Town should partner with local municipalities or the County on the mainland to provide access to this type of facility.

Adult/Youth Basketball

The Town currently has one basketball court. Based on the recommended guidelines the Town meets the requirements. The Town should consider partnering with local municipalities or the County on the mainland to provide access to more basketball courts for programming purposes if desired.

Multipurpose Fields for Football, Soccer, and Lacrosse



The Town currently has no multipurpose fields. Due to the limited availability of land and the general population being seniors, it is not recommended to incorporate this type of recreational facility on the island. The Town should partner with local municipalities or the County on the mainland to provide access to this type of facility.

Tennis Courts

According to park standards, the Town currently provides no tennis courts. Based on the recommended guidelines the Town should develop one new court by 2031. The Town should consider reaching out to the owner of the private tennis court at the corner of Sunshine Drive and Ocean Boulevard regarding a possible partnership that would make this amenity available to the public.

Pickleball Courts

According to the existing park facility inventory, the Town of Holden Beach currently provides two striped pickleball courts on the basketball court at Bridgeview Park. Based on the recommended guidelines, the Town meets the current need. The potential partnership between the owner of the private tennis court at the corner of Sunshine Drive and Ocean Boulevard and the Town could lead to the dual use of that court, striped to accommodate both tennis and pickleball.

Volleyball Courts

According to the existing park facility inventory, the Town currently provides no volleyball courts to residents. Based on the recommended guidelines, the Town should consider adding at least one volleyball court to meet the current demand for volleyball courts.

Horseshoes and Other Small Game Courts

According to the existing park facility inventory, the Town of Holden Beach currently provides one bocce ball court. Based on the recommended guidelines the Town meets the needs for traditional game courts such as horseshoe pits, bocce ball, and cornhole.

Other small game courts to consider include concrete cornhole courts and four square. The Town should consider the popularity of these easy to implement and maintain amenities despite current demand as reflected in the public survey.

Picnic Shelters and Tables



A July 2019 article in the NRPA states that "gathering with family and friends at the park for games, picnics, or barbecues" ranked as one of the top three outdoor recreation activities in America.

The Town currently has three dedicated picnic shelters with tables at various facilities on the island. According to recommended guidelines, the Town meets the needs of the current recommendations for its population size. The Town also provides four picnic tables that are uncovered at Sailfish Park.

Playground Activities

According to recreation standards established in this document, the Town meets the minimum recommended requirements for playground equipment by providing one playground. According to the results of the public input sessions and the community survey, it is recommended that the current Town Park playground equipment be updated to include more accessible features and multigenerational capabilities. In general, playground equipment should be accessible to all ages and physical abilities.

Playgrounds should be considered an essential amenity for all future neighborhood park development projects.

Outdoor Performance Area

Opportunities for cultural and performing arts is an important facet of any wellrounded recreation program. It also adds to the quality of life of those fortunate enough to have access to related facilities and programming.

The Town currently uses the Jordan Boulevard Pavilion as a facility for outdoor performances. Based on community input, it is recommended that the Town construct a separate dedicated space for outdoor events, such as concerts, movies, and other productions that is not so close to the bridge and provides visitors with a more enjoyable experience.

Walking /Hiking Trails and Bikeways

Currently, the Town provides 0.35 miles of natural surface trails for walking as well as a 20-mile bike route that traverses the island. Community input clearly showed a desire for additional trails and bikina opportunities. With future trail expansion, it is recommended that all Natural surface trails are less expensive than trails include 0.25-mile



distance asphalt paving and provide users with a pleasant walking experience.



markers and informational signage that promote the trails' use for reaching fitness goals.

The Town should also consider connecting park facilities, residences, and popular destination spots with sidewalks, as needed.

A highly recommended goal for the Town to pursue is to create a small area plan to develop a linear park/multi-purpose path connecting the Holden Beach Town Hall, Bridgeview Park, the public restroom building, Jordan Boulevard Pavilion, boat ramp, Padgett Garden. This effort would create a safer more cohesive public space under and around the Holden Beach bridge and could become an attractive destination for residents and visitors. Existing efforts to link Padgett Garden with the public restroom building could be expanded as the first of a multi-phased approach to the project.

The Town should seek to develop a master plan exploring design options, materials, opinions of costs, and other due diligence required to complete this small area plan.

PROGRAMS/EVENTS RECOMMENDATIONS

The existing town recreation programs, activities and events are listed in section two. This plan recommends that these programs continue but periodically be evaluated based on participation levels and costs. It is important to provide



programs that patrons have interest in and that support the Town's overall recreation goals.

4.6 STAFFING AND MAINTENANCE RECOMMENDATIONS

This master plan covers a planning period of 10 years. The facilities to be implemented during that time as part of the recommendations may require some level of additional staffing and additional funding for facility operation and maintenance. Consideration of these budgetary impacts should be made prior to facility implementation.

Multiple factors may come to influence what the future staffing needs of the Town of Holden Beach Parks and Recreation Department will encompass. Those may include population growth, available tax dollars, capital improvement plans, and development of tourism efforts.

The Town of Holden Beach Parks and Recreation Department's structure consists of one full-time employee. Maintaining adequate staffing for parks and recreation facilities and programs will be necessary to foster a good quality of life for Town residents and prospective businesses that may seek to relocate to the Town of Holden Beach. The existing and proposed staffing levels for the Holden Beach Parks and Recreation Department are as follows:

Maintenance Staffing Recommendations

Staffing for maintenance is dependent on the levels of service the Town wishes to provide to each facility. The Town should consider creating a maintenance plan which includes details of number of hours and level of service for each maintenance task (mowing, repairs etc.). These plans are documented in the



NRPA, Commission for Accreditation of Park and Recreation Agencies (CAPRA) standards and are recommended to be reviewed for a future maintenance plan for the Town.

4.7 PRIORITIES FOR DEVELOPMENT

Projects Methodology

The park system for the Town of Holden Beach should continue to grow and respond to changes in Town demographics. Future planned facilities should be implemented incrementally to provide for these changes. This section describes how the recommended facilities for the Town are prioritized. The following factors guided the prioritization of individual segments of the master plan and were derived from input and desires specified by the residents of Holden Beach:

- Needed improvements to existing Town of Holden Beach owned facilities
- Development of planned facilities to meet the *current* needs of recreation for Town residents
- Development of planned facilities to meet the future needs of recreation for Town residents

Projects for Consideration

The park facility project list is an essential tool that provides the Town of Holden Beach Parks and Recreation Department with a breakdown of projects to consider. Given the magnitude of the budgets for improvements to existing parks and for new park and greenway facilities, prioritization of these needs is important and the purview of Town officials and staff. The following is a list of projects based upon the needs assessment process:

- Provide accessible canoe/kayak launch (Sailfish)
- Construct covered picnic/gathering space (gazebo, shelter structure, etc.) (Sailfish)
- Delineate parking spaces (Sailfish)
- Add restroom facilities (waterless restroom) (Sailfish)



- Design and construct waterless restroom facilities at suitable beach access sites where feasible
- Conduct site master plan study (Scotch Bonnet)
- Design/construct dog park (Scotch Bonnet)
- Develop trails with educational signage that link to the ICWW and adjacent Drew Griffin Environmental Research Facility (Scotch Bonnet)
- Provide shade, seating, and picnic facilities (Scotch Bonnet)
- Develop parking along Scotch Bonnet Drive (Scotch Bonnet)
- Improve/repair existing pier and fishing platform (Halstead)
- Add fish cleaning station to fishing platform (Halstead)
- Develop accessible canoe/kayak launch off existing pier 30' back from highwater mark (Halstead)
- Delineate parking spaces (Halstead)
- Conduct study of parking layout to gain useable park space (Halstead)
- Work with the North Carolina Department of Transportation on potential for separate bike lane on Ocean Boulevard and/or sidewalk widening to accommodate increasing population of users (Olden Holden)
- Create and install Town-branded wayfinding and directional signage for all recreation facilities
- Install highly visible signage noting available public parking locations near beach access sites
- Market beach access sites via widely available brochure maps
- Add high visibility crosswalks for all beach access sites

2027-2031

- Add separate fishing platform/wildlife observation deck (Bridgeview)
- Add educational signage about local history or natural resources of Holden Beach (Sailfish)
- Add additional picnic facilities (furnishings, shade) (Sailfish)
- Update equipment and provide instructive/usage signage (Fit Trail)
- Add educational signage (Halstead)
- Assess and develop ICWW water access points at northern terminus points of Town owned roads
- Identify location for (2) new community parks; develop master plans, secure funding, and implement parks

- Procure and develop master planning for Holden Beach Pier
- Conduct master plan for Holden Beach linear park/multi-purpose path connecting Holden Beach's Town Hall and other recreation facilities near the Holden Beach Bridge
- Begin due diligence and planning for the Sandspur Waterway Walk

SECTION 5 FUNDING AND ACTION IMPLEMENTATION PLAN

5.1 INTRODUCTION

This section describes how the Town of Holden Beach can implement a safe, convenient, and usable parks and recreation system through the execution of its established goals in the Town's Comprehensive Parks and Recreation Master Plan. The strategy for achieving goals involves the recommended park and recreation facilities/programs discussed in Section 4. Section 5 exhibits strategies and opportunities, key implementation steps and policies, necessary staffing, and methods for developing facilities. Together, these sections form the implementation program.

The results of the Town of Holden Beach Parks and Recreation Comprehensive Master Plan 2021–2031 are based on the following discovery methods: (1) a review of the study area that is within the Town limits, (2) an analysis of the existing parks and facilities, (3) community input, and (4) recreation standards that have been generically developed for local governments. The master plan is designed to be action-oriented and to serve as a tool in the improvement and enhancement of the park system for the Town.

5.2 ANTICIPATED FUTURE (10-YEAR) RECREATIONAL PROJECT LIST

A recreation capital improvement program for the development of park facilities is designed to encompass, at a minimum, a 10-year period of the comprehensive parks and recreation master plan. To assist the Town in determining those needs, this study provides a list of anticipated recreation projects based on plan recommendations. The proposed recreational project list provides costs based on recent (2019–2021) material/labor costs. The provided opinion of probable costs includes assumed general expenditures, such as site preparation, building structures, access, site utilities, parking, and specific recreation improvements. The list provided also includes estimates for planning or design fees.

The proposed Anticipated Future Recreational Project List will cover a 10-year period and serve to set recreation expenses for each fiscal year for implementation of specific projects. The opinions of cost are preliminary in nature and are for planning purposes only. As the time approaches to consider the recommended improvements, it will be necessary to receive up to date opinions of cost.

The total anticipated 10-year recreation project cost of \$6,830,500 represents the proposed, cumulative figure to be spent for parks and recreation development,



improvements, and renovations by the year 2031. See Appendix D for a detailed breakdown of estimated costs. The total figure does not consider an inflation rate over the 10-year period through the year 2031.

5.3 ECONOMIC DEVELOPMENT INITIATIVE

Studies have shown that economies are impacted *positively* where bicycle and pedestrian tourism is fostered and promoted, and where investments are made in bicycle and pedestrian facilities. The number of people who feel comfortable walking or riding bicycles is a measure of the quality of life in that area.

Multi-Use Trails

Multi-use trails are extremely popular amenities for vacationing bicyclists and pedestrians. Tourists and visitors to the area often return to communities that provide places which are safely removed from busy roads for walking and bicycling. Multi-use trails offer scenic recreation, which is suitable for a wide range of ages and abilities. Many times, lodging is in close proximity to popular trails, thereby increasing



Greenways are both a recreational and transportation asset.

occupancy for the owner. For residents in these locales, investments in trails and greenways can increase property values and improve the overall livability of a community, as well as attracting, retaining, and expanding tourism and the associated revenues. In a coastal setting, boardwalks and marsh walks provide access to areas that are otherwise unsuitable for human interaction.

Multi-use trails having vegetated buffers located adjacent to waterways act as filters to clean the water, trapping nonpoint source pollutants. These pollutants, including sediment, pesticides, fertilizers, oil, gas, and other chemicals, are transported into streams, rivers, and/or lakes by stormwater when rain events occur.

Trail Development

The ongoing construction of bicycle and pedestrian facilities is proving to be a wise economic investment for the communities through which they pass. The Town of Holden Beach Parks and Recreation Department should annually assess and include funding towards the maintenance of popular trails/sidewalk paths to



preserve the value that they contribute to the community. Trails and pathways have a positive effect on nearby property values with homebuyers and business owners realizing the effect that such facilities bring to a community. Real estate agents and homebuyers alike are recognizing the benefits of properties located near trails. Both locally and nationally, the construction of trails has proven to be a cost- Property values increase where trails have effective use of public funds. Multi-use been developed. trails allow more visitors and residents to



replace automobile trips with non-motorized trips, thereby moving the citizenry closer to achieving public health objectives, including increased opportunities for physical exercise.

To develop the necessary bicycle and pedestrian trail facilities, the Town should seek to develop a bicycle and pedestrian plan with the assistance of the North Carolina Department of Transportation.

Parks

Research has substantiated the direct relationship between economic growth and the existence of parks and open space in communities and municipalities around the country. This growth includes increased property values in residential, urban. and industrial communities, as well as the increased revenue from tourists.

Increased Property Value

The real estate market consistently demonstrates that residents throughout the country are willing to invest larger amounts of money in properties that are located close to parks and open space areas than they would for homes that do not offer these types of amenities. The higher values of these homes produce higher property taxes in the affected area. In some instances, additional property taxes are sufficient to recoup the annual debt charges on bonds, which were originally used to finance park acquisition and development.

Studies have shown that property values typically increase when parks or outdoor facilities, such as outdoor festivals, movies, and restaurants, are in the immediate locale. Studies also indicate that commercial asking rents near park property exceed rents in surrounding submarkets.



Tourism

A park becomes the signature attraction for a community or municipality and it is often used as a marketing tool to attract residents, tourists, conventions, and businesses. Parks have the ability to shape the identity of the area and give residents a sense of pride.

Organized events held in public parks, such as art festivals, athletic events, food festivals, concerts, and plays often bring substantial positive economic impacts to their communities by filling hotel rooms and restaurants and bringing customers to other local business enterprises. The Town should entertain providing additional concerts and festivals to ensure that they are able to provide the desired events to the community throughout the year.

5.4 OPPORTUNITIES AND STRATEGIES

Funding

Identification of sufficient funding is a crucial element that is required to implement the master plan. The *North Carolina Statewide Comprehensive Outdoor Recreation Plan* is a guide by which funding sources for park and recreation facilities may be identified. Funding for future projects will be a key issue that will need to be addressed in the upcoming years if governments continue to provide basic minimum services.

To meet the existing and future needs of the Town of Holden Beach, the goals and objectives that are identified in the master plan should be seriously considered for implementation. The Town will need to reevaluate their annual budget for the Holden Beach Parks and Recreation Department based on projected capital improvement costs, staffing needs, and operations/maintenance costs.

Dedicated Source of Local Funding

In order to leverage and provide matching funds for many of the programs listed above, the Town of Holden Beach should evaluate the existing departmental budget and funding for capital improvements to include the following:

- Property/sales tax
- Bonds
- Fee in-lieu of contributions
- User fees/registration fees



Property/Sales Tax Revenues

General tax revenues traditionally provide sources for general operations and maintenance of park systems for local governments. Parks and recreation development is scheduled along with health, public safety, utilities, in regular budgets established by the Town. Assessed valuation of real and personal property tax and sales tax provides the framework for the major portion of the tax base for the Town. Currently the Town funds their parks and recreation expenditures via the occupancy tax.

Traditionally, ad valorem tax revenue has been the primary source of funding for the park and recreation enhancement of properties/facilities owned by local governments. Recreational opportunities are considered a public service and often are a standard line item on general fund budgets. Creative financial opportunities are possible; however, ad valorem taxes will continue to be the major revenue source to support the system. As such, communities often vote to raise their local tax rate temporarily in support of their park and recreation systems.

General Obligation Bonds

Many communities issue bonds, typically approved by shareholders, to finance site development and land acquisition costs. The State of North Carolina grants local governments the authority to borrow funds for parks and recreation through the issuance of bonds. The amount is not to exceed the cost of acquisition or improvement of park and recreation facilities. Total bond capacities for local governments are limited for parks and recreation to a maximum percentage of the assessed property valuation. Since the issuance of bonds relies on the support of the voting population, the implementation of awareness programs is essential prior to a referendum vote.

General Obligation Bonds are the preferred financing approach of the North Carolina Local Government Commission and the general securities market because these instruments are backed by the full faith and credit of the issuer. That simply means that the bonds represent an encumbrance against the property tax base of the issuing jurisdiction and therefore offer the best available security to the bond holder. The State of North Carolina gives the issuance of bonds not to exceed the total cost of improvements (including land acquisition). In view of the recommended capital improvements suggested in this plan, the Town may consider continuing to use General Obligation Bonds to develop new facilities. Total bonding capacities for local government is limited for parks and recreation to a maximum percentage of assessed property valuation.

The following are key factors to consider before using this financing instrument:

• In North Carolina, the issuance of General Obligation Bonds requires a referendum of the voters within the issuing jurisdiction.

- The term of the debt may be extended to 20–30 years.
- The debt is publicly sold, so there are costs associated with the sale. These costs generally total 3% to 5% of the total bond principal. The issuance costs offset the lower interest rate and, therefore, this instrument becomes more attractive as the size of the issuance increases and the issuance costs are spread over the larger debt. It has been found that this financing option becomes financially superior as the debt principal exceeds \$10-\$12 million.
- Generally, prepayment of the debt cannot be accomplished until reaching a call date. This usually is around 75% of debt retirement.

Failure of the General Obligation Bond to be ratified by referendum could mean that the Town could not go forward with an alternative approach to financing without substantially changing the scope of the project.

User Fees/Registration Fees

Communities throughout the nation employ a wide variety of user fees for public use of recreational programs and services within their recreation departments. The amount of the fee is usually determined by a portion of the recreation costs needed for improvements and operations. These user fees are typically levied for special facilities, such as water parks and golf courses; however, they can also be charged for the use of trails and ball fields. The Town of Holden Beach should continue to generate revenue by charging user fees for use of facilities such as picnic shelters in order to cover operation and administrative costs. In addition, the Town should continue to have a separate fee rate structure for residents and non-residents. As the park system continues to develop, the Town should examine their fee structure to identify opportunities for additional revenue. The current user fees appear to be fair and reasonable for a majority of the Town residents and non-residents. Elected officials should determine the fees and charges based on departmental input; the fees should not be so high that persons of modest income would ultimately be denied the use of park facilities.

Other sources of funding

Funding/Acquisition Sources

Implementing the recommendations of this Comprehensive Parks and Recreation Master Plan will require a combination of funding sources that include local, state, federal, and private money. This section provides a listing of the most commonly used funds for park and greenway facility projects in North Carolina. Fortunately, the benefits of protected greenways and parks are many and varied. This allows programs in the Town to access money earmarked for a variety of purposes including water quality, hazard mitigation, recreation, air quality, alternative transportation, wildlife protection, community health, and tourism. Competition is always stiff for state and federal funds. It becomes imperative that local governments work together to create multi-jurisdictional partnerships and to



develop their own local sources of funding. These sources can then be used to leverage outside assistance. The long-term success of this plan will almost certainly depend on the dedication of local revenue stream for park and greenway projects.

It is important that the Town of Holden Beach fully evaluates its available options and develops a funding strategy that can meet community needs, maximize local resources, improve quality of life, and leverage outside funding. Financing will be needed to administer the continued planning and implementation process, acquire parcels or easements, and manage and maintain facilities. Further research into these programs is recommended to determine requirements for specific grants.

McGill advises the Town to pursue a variety of funding options. Below is a list of park and greenway funding opportunities that are typically sought by communities. Creative planning and consistent monitoring of funding options will likely produce new opportunities not listed below.

Grants

State and federal agencies offer numerous grants to assist municipalities in the financing of their parks and recreation projects. This source of funding should definitely be investigated and pursued by the Town for present and future park and recreation improvements. In addition to the ones most applicable to the Town, others can be found in Appendix F.

North Carolina Parks and Recreation Trust Fund (PARTF):

PARTF was established for local governments and the North Carolina Division of Parks and Recreation in 1994 as a funding source for the development and/or improvement of parks and recreation facilities, and for the purpose of land acquisition. A state-funded program, PARTF



matches monies spent by municipalities on parks and recreation, with each sharing 50% of the cost. The maximum matching fund amount provided by PARTF is \$500,000. Contact the Recreational Resources Service for additional information at (919) 515-7118.



Land and Water Conservation Fund (LWCF):

A federally funded program, LWCF, was established for local and state governments in 1965 as a funding source for outdoor recreational development and land acquisition. LWCF monies are derived from the sale or lease of nonrenewable resources, primarily offshore oil and gas leases, and surplus federal land sales. Acquisition and development grants may be used for a wide variety of outdoor projects, such as town parks, tennis courts, bike trails,



outdoor swimming pools, and support facilities (roads, water supply, et cetera.) Facility design must be basic rather than elaborate and must remain accessible to the general public. No more than 50% of the project cost may be federally funded by LWCF, although all or part of the project sponsor's matching share may be obtained from certain other federal assistance programs.

Coastal Management Beach & Waterfront Access Program (CAMA)

The Division of Coastal Management (DCM) has notified local governments in the 20-county coastal area that grant funding is available for Public Beach and Waterfront Access projects for the upcoming 2021–2022 fiscal year.

DCM awards about \$1 million a year in matching grants to local governments for projects to improve pedestrian access to the state's beaches and waterways. Local governments may use access grants to construct low-cost public access facilities, including parking areas, restrooms, dune crossovers and piers. Projects range in size from small, local access areas to regional access sites with amenities, such as large parking lots, bathrooms, and picnic shelters.

Towns and counties may also use the grants to replace aging access facilities, help acquire land for access sites, or to revitalize urban waterfronts. Funding for the Public Beach and Coastal Waterfront Access Program comes from the North Carolina PARTF.



Recreation Trails Program (RTP)

RTP is a \$1.5-million federal grant program designed to help states provide and maintain recreational trails for both motorized and non-motorized vehicle recreational trail use. The program is administered by the U.S. Department of Transportation's Federal Highway Administration.



RTP is a reimbursement grant program. RTP distributes funds equally among Funds must be spent and then states. reimbursed upon completion

deliverables. Eligible applicants must be a state, federal, or local government agency or qualified non-profit organization. All applications are reviewed by the North Carolina Trails Committee and recommendations are made to the Secretary of the Department of Natural and Cultural Resources. The Secretary makes the final determination on grant awards.

Environmental Enhancement Grant Program (EEG)

The objective of the EEG program is to fund projects that address environmental needs of North Carolina specifically to protect water quality as well as conserve natural areas. To be eligible, applicants must be a non-profit organization or government entity. The types of grants included are land acquisitions and easements; construction, remediation, and restoration; and research, planning, and education. The maximum award available is \$500,000 and must be completed in 3 years from the date of a fully executed Memorandum of Understanding.

North Carolina Land and Water Fund (NCLWF)

Created in 1996 by the North Carolina General Assembly and previously referred to the Clean Water Management Trust Fund (CWMTF), NCLWF grants monies to local governments, state agencies, and not-for-profit conservation groups. The money is to help finance projects that specifically address water pollution issues. NCLWF will fund projects that contribute toward a network of riparian buffers and greenways for environmental, educational, and recreational benefits. There is no match required by local municipalities; however, the suggestion of a match is highly recommended.

Contributions

The solicitation of contributions is an acceptable method of fundraising for recreation departments. These donations, typically in the form of land, cash, labor,



and materials, could be solicited to assist the Town of Holden Beach with its enhancement program. Corporations, civic organizations, individuals, and other groups generally donate to a specific park project; however, donations may also be solicited for multiple project improvements or additions. The National Recreation and Park Association recommend the use of private, not-for-profit, tax-exempt foundations as a means of accepting and administering private gifts to a public park system.

Park Foundations

Foundations are another source of financing by making direct contributions within communities, states, or the nation. These types of funds are usually described as special program foundations, general-purpose foundations, or corporate foundations. Foundations can provide the needed resources to support park projects. Foundations generally have very few restrictions and/or limitations and are typically received from local entities. A list of appropriate foundations can be found at http://candid.org.

Partnerships

To implement the recommendations contained in the comprehensive master plan, the Town of Holden Beach should expand their partnership agreements with other public agencies and private-sector organizations. There are many different types of partnerships that can be formed to achieve the goals established by the Town. In fact, many local governments throughout the nation are utilizing partnerships with public and private-sector interests to accomplish community goals.

Listed below are the various types of partnerships that the Town should consider in its efforts for the improvement and addition of parks and recreational facilities:

- Programming partnerships to co-sponsor events and facilities or to allow qualified outside agencies to conduct activities on properties which are municipally owned
- Operational partnerships to share the responsibility for providing public access and use of facilities
- Development partnerships to purchase land and/or build facilities
- Management partnerships to maintain properties and/or facilities

To implement the recommendations contained in the comprehensive master plan, the Town should expand their partnership agreements with other public agencies and private-sector organizations. The Town should evaluate forming additional partnerships which address the needs of a comprehensive park system. Direct requests should be made to meet potential partners, inviting them to evaluate the possible benefits of partnering. This step should be made to generate interest and agreement prior to solidifying any responsibilities for each participating party.



Private-sector partnerships can be beneficial to municipalities. Developers can use private funds to develop facilities on municipal property and lease it to the Town long term. Over a period, the developer returns a portion of the revenue to the Town and at the end of the lease the facility is turned over to public ownership. This type of arrangement would typically be a large capital investment for a special use facility.

Land Acquisition and Development

Life Estate

A life estate is a gift, whereby a donor retains the land during his/her lifetime and relinquishes title of the property after his/her death. In return, the owner (or family) is relieved of property tax for the given land.

Local Gifts

Donations of land, money, labor, and construction can have significant impact on the acquisition and development of park property. The solicitation of local gifts is highly recommended and should be organized thoroughly, with the utilization of very specific strategic methods. This often-untapped source of obtaining funds



requires the contacting of potential donors, such as individuals, institutions, foundations, and service clubs.

Easement

An easement is the most common type of less-than-fee interest in land. An easement seeks to compensate the property owner for the right to use his/her land in some way or to compensate for the loss of his/her privileges to use the land. Generally, the landowner may still use the land and therefore, continues to generate property tax revenue for the Town.



Fee Simple Purchase

Fee simple purchase is the most common method used to acquire municipal property for park facilities. Although it has the advantage of simplifying justification to the general public, fee simple purchase is the most difficult method to pursue due to limited monetary resources.

Fee Simple with Lease-back or Resale

This method allows local governments to acquire land by fee simple purchase yet allows them to either sell or lease the property to prospective users with restrictions that will preserve the land from future development. The fee simple with lease-back or resale method of development commonly results from situations in which landowners, who have lost considerable monetary amounts in property value, determine that it is more economical to sell the land to the Town (with a lease-back option) than to keep it.

Long-term Option

Long-term options allow municipalities to purchase property over a long period of time. This method is particularly useful because it enables the Town to consider a particular piece of land that may have future value, though it is not currently desired or affordable. Advantages to this method of property acquisition are that the Town can protect the future of the land without purchasing it upfront, the purchase price of the land will not increase, and the Town will have the right to exercise its option. The disadvantage to the Town is that all privileges relinquished by the landowner require compensation in the form of securing the option.

5.5 PLAN ADOPTION

The first step in implementation of the Town of Holden Beach Comprehensive Parks and Recreation Master Plan is adoption of the plan by the Town Board. By adopting the master plan, the community is able to help shape larger regional decisions so that they fit within the goals of the plan. The Town also gives itself greater authority in shaping local land use decisions so that they achieve the goals and vision of this plan. In addition, the adoption of this master plan is essential in order to maximize available grant opportunities.

Among the opportunities available to promote the recommendations contained in the master plan is the ability to <u>build upon</u> an already committed and active base of residents, visitors, and enthusiasts in the area. Through their organizations, institutions, publications, and networks, the Town can promote both the improved and new parks and greenway facilities and programs. Second among the opportunities, is the <u>availability</u> of the existing park facilities such as amenities, programs, and existing trails. Though some changes are being suggested in the



short-term and an expanded network is suggested for the long-term, the presence of an existing network provides a strong foundation from which to build. Many Town residents are already accustomed to using the existing park facilities and should become used to seeing new park amenities, programs, signage, and other improvements. Building on their existing awareness of what is available is much easier than building on no awareness.

Action Steps

Upon adoption of this plan, implementation of specific recommendations can begin. Many of these will occur simultaneously and include policy and facility improvement changes. The key steps are:

- 1. Secure a dedicated source of revenue to address the 10-year and beyond capital improvement program and address the goals of the master plan.
- Provide staffing necessary to support and oversee the implementation of this plan and the proper maintenance and operation of the facilities that are proposed.
- 3. Develop and implement educational and awareness programs, such as public events and promotion of parks awareness by civic and environmental advocacy groups. These programs can be used to announce new park facilities and upcoming projects.
- 4. Begin working on the recommendations that are listed in the 10-year Anticipated Recreation Projects List. From these opportunities come the framework for an initial implementation strategy. These recommendations include:
 - Aggressively begin to establish potential funding mechanisms for future park expansions. This high priority goal is essential for realizing the proposed recommendations for the future growth and development of Holden Beach's parks and recreation facilities.
 - Use the nucleus of park patrons to expand the awareness of the amenities and programming of the Town of Holden Beach Parks and Recreation System.
 - Expand and modify the existing park system into a comprehensive, multi-use system — distributed so that it better meets the needs of the community, provides opportunities to all and enhances the current park system.
 - Continue making the critical pedestrian and bicycle connections between destination points that will allow for preservation of open space and offer an alternative mode of transportation.

The steps above represent the core of the implementation strategy. As the individual policy recommendations and physical recommendations are addressed, they should each fit within one of these four primary strategies.


- The Town needs to ensure that facility planning is integrated with other regional planning efforts at the state and local levels and with long-range and current land use, transportation, parks, environmental, and community planning. The following are mechanisms to achieve this action step:
 - 1) Expand local capital improvements program for yearly appropriation for greenway and park development
 - 2) Set aside money for future land acquisition, construction, and maintenance of parks and recreation facilities
 - 3) Pursue and request pedestrian/bicycle projects to be added to NCDOT TIP
 - 4) Pursue developing and expanding existing and new partnerships
 - 5) Apply for PARTF grants and other related recreation grants for future parks and recreation projects
 - 6) Seek other sources of revenue funding for parks and greenway improvements, such as including local assessment districts and developer exactions
 - 7) Pursue funding from other sources listed in this section

5.6 CONCLUSION

The Town of Holden Beach Comprehensive Parks and Recreation Master Plan has laid out a set of strategies for expanding and developing a safe, convenient, and usable park system. The plan has assessed the study area, analyzed the existing facilities, received and analyzed community input, reviewed recreation standards, developed recommendations, and provided strategies for implementing the plan. The Comprehensive Parks and Recreation Master Plan is an extensive document to be used in the improvement and enhancement of the park system for the Town of Holden Beach.


Existing Holden Beach Recreation Facility




Q16 Would you favor or oppose expanding recreational opportunities in Holden Beach?


Q17 What, if any, sources of funding are you willing to support in order to make improvements, build new facilities, and create programs? Check all that apply.

APPENDIX F

Federal Aid Construction Funds

These funds are included in the National Highway System (NHS), Surface Transportation Block Grant Program (STBG), and Congestion Mitigation and Air Quality (CMAQ). The funds provide for the construction of pedestrian and bicycle transportation facilities. The primary source of funding for bicycle and pedestrian projects is STBG Enhancement Funding.

The Safe, Accountable, Flexible, Efficient, Transportation Equity Act of 2004 (SAFETEA)

The SAFETEA approved by the federal government in 2004, is a primary source for financing bicycle, pedestrian, and greenway projects throughout the country, at both the local and state levels. Providing as much as 80% for development and construction costs, this grant is earmarked for facilities such as sidewalks, rail trails, bike lanes, and greenways. The Enhancement Program (a section of SAFETEA) is used primarily by municipalities since this section focuses on bicycle and pedestrian corridors, environmental mitigation, historic preservation, and scenic byways. 20% matching funds are required by the applying entity and applicants must meet several other criteria as well. Prior to applying for this grant, a thorough engineering assessment should be performed to determine construction costs.

Watershed Protection and Flood Protection

The USDA Natural Resource Conservation Service (NRCS) assists state and local governments in their operation and maintenance of watersheds whose areas are less than 250,000 square acres. The NRCS provides both financial and technical assistance to eligible projects for the improvement of watershed protection, flood prevention, sedimentation control, public water-based fish and wildlife enhancements, and recreation planning. The NRCS requires a 50% local match for public recreation and fish/wildlife projects.

State Construction Funds

These funds (not including the Highway Trust Fund for Urban Loops and Interchanges) may be used for the construction of sidewalks and bicycle accommodations that are a part of roadway improvement projects.

Examples of Typical Parks

To better understand the size, and scope of different park types the following examples have been provided:

Regional Parks

Regional parks are typically very large sites and would not be appropriate for Holden Beach due to land constraints. However, on these sites, the unique qualities that exemplify the natural features found there, such as diverse land formation, vegetation, and wildlife, are preserved. Most regional park facilities contain environmental centers, campsites, nature trails, observation decks, and picnic areas. In addition, open fields for non-structured activities, such as frisbee-throwing or kite-flying, are also generally found there.

When land is acquired for the development of regional parks (or the expansion of existing sites), the land should be comprised of the previously mentioned characteristics, and whenever it is possible, accompanied by natural water features, such as lakes, rivers, or creeks. The majority of the site should be reserved for passive recreation, with the remaining acreage used for active recreation. Both the acquisition and the development of regional parks are typically undertaken by a federal or state agency.





District Parks

A district park functions as the major source of active recreation for several neighborhoods within a community. Brunswick County provides this type of park for residents and visitors of Holden Beach to utilize. District parks are intensely developed. offering a multitude of facilities in order to serve their intended geographic user area. Activities are balanced between active and passive recreation. District Parks are typically developed accommodate athletic league sporting events and tournament competition. Passive recreation opportunities, such as walking for pleasure, Town Creek Park in Winnabow, NC wildlife observation, and picnicking are found in



the undisturbed areas — preferably within surrounding buffers. District parks present great opportunities for non-traditional types of recreation.

Sites for district parks should be relatively level to alleviate excessive grading for the active facilities. When possible, there should be an equal balance of wooded and cleared areas. If a natural water feature is present, the adjoining land should be developed primarily as passive recreation. Accessibility to neighborhoods should be an important consideration when choosing sites. The development of district parks is typically the responsibility of county or municipal agencies.



Community Parks

Community parks focus on meeting community-based recreational needs, as well as preserving unique landscapes and open spaces. Compared to district parks, community parks have a smaller range of recreation facilities. They may host athletic league sports events and provide passive recreation. 50% of the community park property should be developed for only passive recreation, with these relatively undisturbed areas serving as buffers around the park and/or acting as buffers between active facilities.

Community park sites should have varying topography and vegetation. A number of different tree species should also be present in forested areas. Community parks should contain cleared areas for the purpose of locating active recreational facilities. At least one natural water feature (lake, river, or creek) is desirable in community parks. The land acquired for use as a community park should be contiguous in nature and strategically located in order to serve all users within the designated community. The development of community parks typically falls within the realm of municipal responsibilities.

Neighborhood Parks

Neighborhood parks offer the public a convenient source of recreation while serving as the social focus point of neighborhoods. Usually located within walking distance of the area serviced, neighborhood parks provide both active and passive recreation opportunities that are of interest to all age groups. The smaller size of neighborhood parks, as compared to those previously mentioned, requires intense development with 50% of each site remaining undisturbed to serve as a buffer between the park and adjacent property owners.

Specific standards/criteria for neighborhood parks are as follows:

Mini Parks

The function of a mini park is to provide very limited, isolated, or unique recreational needs. Mini parks are the smallest classification of parks. They are often provided by school and church playgrounds. These parks are located within walking distance of the area served and they provide limited recreational activities. Their very small size requires intense development and there is little or no buffer between mini parks and adjacent property owners.



Mini Parks maximize space and provide access to recreation near popular destinations. Halstead Park is a popular mini park in Holden Beach.

Specific standards/criteria for mini parks are as follows:

1/4 to 1/2 mile radius to serve walk-in recreation needs of surrounding populations

Acreage/Population Ratio:

0.5 acres per 1,000 persons



Boardwalk/Marsh walk

Boardwalks and marsh walks are a type of linear park. Linear parks are areas developed for one or more varying modes of recreational travel, such as hiking and biking. Linear parks are developed for several reasons:

- To connect existing recreational facilities
- To facilitate public right-of-ways
- To connect destination points
- To meet public demand

The length and size of linear parks vary considerably, depending on the terrain of the park land and the distance between entities to be transportation. connected, such as parks, schools, homes,



Linear parks provide recreation and transportation.

businesses, and cultural/historical resources. In some cases, a linear park is developed within a large land area designated for protection and management of the natural environment with recreation opportunities as a secondary objective. Boardwalks and marsh walks provide access to areas for passive recreation that are otherwise inaccessible due to the sensitive nature of the ecosystem.

Unique or Special Use Facilities

The unique or special use facilities are park types that exist for the sole purpose of enhancing or utilizing a special man-made or natural feature. They can include beaches, parkways, historical and archeological significant sites, swimming pools, conservation easements, flood plains, and other amenities that are not typical. Minimum standards relating to acreage or population have not been established by the park and recreation industry for this category of park. A size that is sufficient to protect and interpret the resource, while providing optimum use, is considered desirable.



The Holden Beach Fit Trail is a creative way to provide health benefits in an area with limited available land.

Open Space



While it is realistic and appropriate to adopt population-based standards for park land and facilities, it is more difficult to establish standards for Town-initiated open space conservation efforts. The Town has a great asset pertaining to open space with the regional benefit of the beach. Due to this resource, the Town becomes a popular destination source for tourists.

Public open space is defined as any land acquired for the purpose of keeping it in a primarily undeveloped state. The functions of open space include:

- Preservation of drainage areas for water supplies (watersheds)
- Protection of areas which are particularly well suited for growing crops (farmland preservation)
- Protection of communities to prevent urban sprawl (greenbelts)
- Protection of wildlife habitat (sanctuaries)
- Protection of approach and take-off areas near airports (clear zones)
- Protection of undevelopable land (landfills)
- Protection of areas aesthetically pleasing for a corridor (viewshed)

While these areas are some of the more common open spaces, many others exist.

APPENDIX H



General Recommendations

General recommendations are designed to provide guidance for the operations, goals, administration, and growth of the Town of Holden Beach. Many of these recommendations depend upon successful collaboration between the Town departments.

Recommendation #1: Facility and Program Accessibility

Every park and recreation facility the Town operates should respect and provide the needs of the disabled population through design and programming. All new facilities should be designed to meet current Americans with Disabilities Act (ADA) requirements. Upon visual inventory, the Town continues to bring itself into compliance with these regulations at most existing facilities. As new facilities are acquired or developed, priority should be given to the continual upgrading of existing facilities, if any become non-compliant.

Recommendation #2: Design and Daily Maintenance

The facilities owned and operated by the Town should appeal to residents of the Town and visitors to the area. Priority should be given to improving the design of facilities that are architecturally, functionally, and ecologically progressive. Daily maintenance practices should be implemented to improve the cleanliness and longevity of all facilities.

Master planning should always be completed for park improvements or new facilities <u>prior</u> to final budgeting and/or design; thereby, making the phasing/development more transitional and of higher quality. Design (and redesign) of all facilities should embrace ecologically responsible elements and methods with the use of native plants for landscaping, the incorporation of wildlife habitats, the incorporation of permeable surfaces to reduce stormwater runoff, where possible, and green building practices for structures.

Recommendation #3: Walkable Communities

The Town should promote land uses and site designs that make walking and bicycling convenient and enjoyable. They should also encourage the inclusion of public greenways or trails in private developments and the establishment of connectivity to and/or between both current and future parks and other public destinations.

Recommendation #4: 10 Minute Walk Movement

The NRPA, Trust for Public Land (TPL), and Urban Land Institute (ULI) have partnered together to promote safe, equitable park access for U.S. citizens. The goal is to provide 100% of people access to a quality park or green space within a 10-minute walk of their homes by 2050. The Town of Holden Beach is encouraged to pledge their support to the 10 Minute Walk Mission. For more information visit 10minutewalk.org.



Recommendation #5: Contiguous Property Acquisition

When property that is contiguous to existing parks becomes available, all reasonable efforts should be made to acquire the property. The acquisition of contiguous property next to Town parks should be of high priority to the Town of Holden Beach. Efforts should be made immediately to seek first option on all contiguous properties. At the time these options are sought, other possibilities should be presented to the property owner as well. Some property owners may be receptive to conservation easements while retaining the title to the property. Conservation easements will allow the Town the opportunity to use properties for recreation while providing the immediate benefits of preservation. Numerous grant sources can be used for land acquisition. Extreme care should be exercised in choosing the correct process(es) and timing for acquisition to meet the full potential afforded by grants.

Recommendation #6: Multi-Use Trails

Based on state and national studies, walking and biking are highly desired activities, which are increasing by bounds. North Carolina's 2020-2025 Statewide Comprehensive Outdoor Recreation Plan (SCORP) found that 61% of survey participants reported that "walking for pleasure" to be the most common outdoor recreational activity. The plan also found that 59% of survey respondents reported hiking trails to be important.

The Town of Holden Beach should encourage coordination and planning for future utility easements with greenway facilities. The easements should be established to allow for the inclusion of recreation facilities where possible. Where new development occurs, the Town should work with the developer to provide rights-of-way or easements for proposed and future trails.

Recommendation #7: Greenway Funding

The Town of Holden Beach should consider adding language to its development ordinances concerning a fee in lieu of open space dedication standards and Water Allocation Policy in order to incentivize this option where appropriate, as a means of funding greenways.

Recommendation #8: Bicycle Facilities

Given the high cost of fuel for vehicular transportation, air quality concerns, and the need to increase the health and fitness of the population, a planned network of bike lanes and shared roadways should be developed to support alternative transportation around the island to recreation facilities and other popular destination areas. Future roadway construction within the Town should include provisions to accommodate pedestrian and bicycle travel. This network should connect



both <u>existing</u>, as well as <u>future</u> park facilities and greenways. In addition, bike racks (offered at potential high-use areas) should be installed at all publicly owned facilities within the Town. The Town should seek to develop a bicycle and pedestrian plan with the assistance of the North Carolina Department of Transportation.

Recommendation #9: Wayfinding

The Town of Holden Beach should consider utilizing guide pamphlets and aesthetically pleasing, consistent, and Town-themed directional signage and informational kiosks to promote nearby parks and recreation facilities and destinations. Highlighting and mapping the existing park offerings will provide people with the opportunity to locate recreational and other destinations, as well as present a cohesive message to users that they support a high quality of life for its residents.

Recommendation #10: Intergovernmental Cooperation

The Town of Holden Beach should seek to coordinate planning efforts with the Brunswick County Parks and Recreation Department and local municipalities to provide park facilities and programming opportunities. Representatives of the Town and of these agencies should meet periodically to discuss development and recreation projects that are planned or are underway within the area. The purpose of these meetings is to discuss upcoming project opportunities and development trends in demographics and growth, newly identified citizen needs in recreation and open space, and recreation master plan updates for Brunswick County, local municipalities, and adjacent counties. This will also ensure that redundancy in services is prevented and that all opportunities for partnerships and connectivity are being utilized.

Recommendation #11: Partnership Agreement

It is recommended that Town Staff meet with existing and potential partners to determine needs and possible partnership opportunities. These partners can include but not be limited to local chapters of community clubs and organizations, private firms and companies within proximity to the Town, non-profit organizations, and land conservancy organizations. The Town should begin this process by developing an approach to each

potential partner to establish an understanding of each entity's needs and, ultimately, result in a partnership agreement. The process will require periodic progress meetings with each partner to facilitate the partnerships goals and objectives. This may entail presentations to the partner's board or committee.

Recommendation #12: Interpretative Signage

The Town should consider placing signage that would identify any historic and natural landmarks along pedestrian corridors. This type of signage would not only enhance the pedestrian experience but also provide educational and cultural information to users.

Recommendation #13: Educational and Stewardship Programming

The Town of Holden Beach should develop a consistent environmental education program and interpretative facilities at park locations, along future greenway corridors, and for future park development. These programs should include stewardship and community volunteer programs geared to the management of natural areas and wildlife habitats.



Recommendation #14: Green Building

It is recommended that the Town implement green building components into the existing and future parks facilities. Green building techniques consist of using building materials and construction practices that reduce environmental impacts which can include greenhouse gases, water pollution, and air pollution, and promote energy efficient building materials/methods. These efforts will improve environmental stewardship for park facilities and educate park users.



Recommendation #15: Acceptance of Fee Simple Land Donation

If land is offered to the Town of Holden Beach as donation by fee simple title with no restrictions, the property should be surveyed for natural heritage significance and relationship to existing plans and parks. If the land contains no environmental hazards, restrictive covenants, or restrictive easements, it can be useful and beneficial for the Town to assume ownership. Not all donated land has to be developed into a park in order to be useful. Any land donation to the Town serves a great public need even if it is banked for the future because the development and public needs of the distant future (over 50 years) is unknown. If donated property is properly managed, the revenue and future significance

of the property will far exceed its current contribution to the tax base. If the Town chooses not to accept land donation of a particular property, efforts should be made to assist the property owner with contacting an agency that accepts land donations or conservation easements. Land donations (which the Town has no interest in owning) could be donated to the Local Parks Foundation.

Recommendation #16: Natural and Cultural Heritage Inventory

The Town of Holden Beach should encourage the preparation of an Inventory of Significant Natural and Cultural Areas within the Town and planning jurisdiction. The intent of this study would be to identify areas deemed to be significant natural and/or cultural resources, which should be evaluated for consideration of preservation. Recommendation #17: Technology Access

As the culture continues to move towards information accessibility, providing access to Wi-Fi connectivity within the parks is an amenity that can elevate the usership of park facilities. The Town should identify the locations within their park facilities to install the necessary equipment that will provide users the ability to access Wi-Fi connectivity.

Recommendation #18: Programs and Classes

To expand recreation programming, the Town should continue to provide recreation classes and programs in appropriate Town parks and facilities. The Town should assess the need to contract future programming offerings out to concessionaires. This could extend the programs offered by non-profits and private recreation providers into future County-owned facilities, which may be more accessible to residents who are not currently served. It also would strive to increase programming options by starting new contract programs and activities in the following service areas: health and fitness, swim safety classes, environmental education/nature-based outdoor recreation/trails, non-sports interest classes, and fine/cultural arts programs.

Recommendation #19: Tourism Marketing

The Town of Holden Beach is a popular family destination for vacationing and day trips to the area. The Town should partner with local real estate and rental agencies to provide informational packets at available rental properties highlighting the recreational opportunities provided on the island. Informational packets should also be made available at local restaurants, shops, and destination places to inform visitors to the Town.
