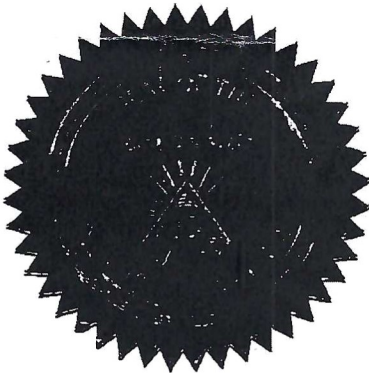

Stare Decisis

See *Elliot v. Peirsol*, 26 U.S. 328, 340 (1828) (“*Courts are constituted by authority and they cannot act beyond the power delegated to them. If a court acts without authority, its judgments and orders are regarded as nullities. They are not voidable, but simply void; and form no bar to a remedy sought in opposition to them, even prior to a reversal. They constitute no justification; and all persons concerned in executing such judgments, or sentences, are considered, in law, as trespassers.*”).

MEMORANDUM

On or about January 6, 2023, you, Monise A. Brown, Donnie M. Carrington-Martin, James Hayward West, Lisa E. Yates, Jonathan Patrick Beattie, Anthony B. Covington, and William R. Greer (hereinafter "defendants") were duly served with process at their mailing address (either directly or by their agent) with the Affidavit of Fact: Writ of Quo Warranto [Exhibit: D] from Lamont Maurice El (hereinafter "complainant"), which were entered in the records of case number: C-08-CR-22-000652 (and related case number C-08-CR-23-000122) of the private foreign de facto corporation CIRCUIT COURT FOR CHARLES COUNTY (Inc.). The defendants were given three (3) days from their receipt of the Writ of Quo Warranto to answer and prove jurisdiction. The defendants failed to answer and prove jurisdiction which constitutes default.

On or about January 10, 2023, the defendants (now to including Lisa Vronch) were duly served with process at their mailing address (either directly or by their agent) with the Affidavit of Fact: Rescission of Signature [EXHIBIT: A] which was entered in number 00424942 in the records of the foreign de facto corporation MARYLAND PAROLE COMMISSION (Inc.) / DEPARTMENT OF PUBLIC SAFETY AND CORRECTIONAL SERVICES (Inc.), and served as lawful notice of the rescission of the signature / autograph on the misrepresented instrument - bill of attainder / foreign bill of exchange titled Order for Release on Parole dated July 11, 2019, inscribed by the complainant under protest and duress as representative of the fictitious corporate person / nom de guerre LAMONT MAURICE BUTLER. There was no cause to the contrary made thereto by the defendants. Therefore, the instrument titled Order for Release on Parole dated July 11, 2019, and any associated attachments are void ab initio due to fraud. See *United States v. Throckmorton*, 98 U.S. 61, 25 L.Ed. 93 ("*Fraud vitiates the most solemn contracts, documents, and even judgments.*").

On or about January 17, 2023, the defendants were duly served with process at their mailing address (either directly or by their agent) with the Affidavit of Fact: Default Judgment [Exhibit: E] from the complainant, which was entered in the records of case number C-08-CR-22-000652 (and related case numbers C-08-CR-23-000122), and ordered for the defendants to dismiss case numbers C-08-CR-22-000652 and C-08-CR-23-000122 with prejudice along with any other attachments associated thereto for lack of jurisdiction and fraud. There was no cause to the contrary made thereto, however, the defendants failed to execute their duty which constitutes wanton negligence and breach of duty.

On or about March 7, 2023, the defendants were duly served with process at their mailing address (either directly or by their agent) with the Affidavit of Fact: Default Judgment [Exhibit: A] from the complainant which was entered in the records of case number 08-K-13-000884 (and related case numbers C-08-CR-22-000652 and C-08-CR-23-000122) which ordered for the defendants to dismiss case number 08-K-13-000884 with prejudice along with any other attachments associated thereto for lack of jurisdiction and fraud. There was no cause to the contrary made thereto, however, the defendants failed to execute their duty which constitutes further wanton negligence and breach of duty.

On or about March 10, 2023, the defendants were duly served with process at their mailing address (either directly or by their agent) with the Affidavit of Fact: Writ of Error [Exhibit: B] from the complainant, which was entered in the records of case number 08-K-13-000884 (and related case numbers C-08-CR-22-000652 and C-08-CR-23-000122) and record number 00424942, and ordered that the de facto administrative proceedings under color of law in such records are unconstitutional, notwithstanding, and void ab initio for fraud and lack of jurisdiction. There was no cause to the contrary made thereto by the defendants.

On or about April 27 2023, the complainant was given the misrepresented instrument - bill of attainder / foreign bill of exchange titled DISPOSITION (bearing a copy of the signature / autograph of the defendant, Lisa Vronch, and dated May 10, 2023) from the defendant, Lisa Vronch, as an offer for the complainant to stand as surety for the fictitious corporate person / nom de guerre LAMONT MAURICE BUTLER in order to deprive the liberty and nationality of the complainant under color of law in want of jurisdiction, and the complainant wrote "under protest and duress; all rights reserved" on the signature line of such instrument to express his disapproval and exoneration from any obligation or liability set forth therein due to fraud and lack of jurisdiction.

On or about June 7, 2023, the complainant was given the misrepresented instrument - bill of attainder / foreign bill of exchange titled PLEA / SENTENCE AGREEMENT dated June 7, 2023, from the defendant, Jonathan Patrick Beattie, as an offer for the complainant to stand as surety for the fictitious corporate person / nom de guerre LAMONT MAURICE BUTLER in order to deprive the liberty and nationality of the complainant under color of law in want of jurisdiction, and the complainant wrote "under protest and duress; without prejudice" on the signature line of such instrument to express his disapproval and exoneration from any obligation or liability set forth therein due to fraud and lack of jurisdiction.

On or about June 7, 2023, the complainant was given the misrepresented instrument - bill of attainder / foreign bill of exchange titled UNSUPERVISED PROBATION ORDER dated June 7, 2023, from the defendants, Lisa E. Yates and James Hayward West, as an offer for the complainant to stand as surety for the fictitious corporate person / nom de guerre LAMONT MAURICE BUTLER in order to deprive the liberty and nationality of the complainant under color of law in want of jurisdiction, and the complainant wrote "under protest and duress; without prejudice" on the

signature line of such instrument to express his disapproval and exoneration from any obligation or liability set forth therein due to fraud and lack of jurisdiction.

On or about June 30, 2023, the defendant, Hayward James West, filed the misrepresented instrument - bill of attainder / foreign bill of exchange titled COMMITMENT RECORD dated June 30, 2023, against the fictitious corporate person / nom de guerre LAMONT MAURICE BUTLER under color of law in want of jurisdiction in order to deprive the liberty and nationality of the complainant by way of fraud.

On or about July 6, 2023, the defendant, Lisa E. Yates, filed the misrepresented instrument - bill of attainder / foreign bill of exchange titled CRIMINAL - BILL FOR COST dated July 6, 2023, against the fictitious corporate person / nom de guerre LAMONT MAURICE BUTLER under color of law in want of jurisdiction as an attempt to extort the complainant by way of fraud.

On or about July 12, 2023, the defendant, Donnie M. Carrington-Martin, filed the misrepresented instrument - bill of attainder / foreign bill of exchange titled FORFEITURE ORDER dated July 12, 2023, against the fictitious corporate person / nom de guerre LAMONT MAURICE BUTLER under color of law in want of jurisdiction as an attempt to deprive the complainant of his property (i.e., arms, ammo, magazines, holsters, belt, etc.) by way of fraud.

Wherefore, it is this 26 day in the month of September, 2023, in the Morocco Consular Court at the Maryland state,

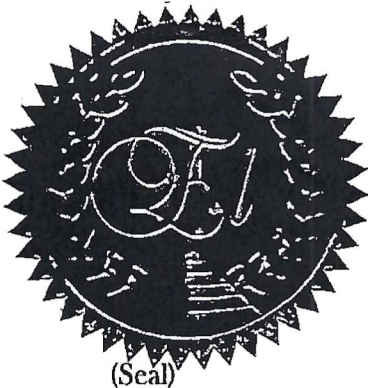
ORDERED AND ADJUDGED that a writ of error be and the same is hereby entered against the defendants, Lisa Vronch, Monise A. Brown, Donnie M. Carrington-Martin, James Hayward West, Lisa E. Yates, Jonathan Patrick Beattie, Anthony B. Covington, and William R. Greer;


It is further **ORDERED AND ADJUDGED** that the misrepresented instruments – bills of attainder / foreign bills of exchange titled **DISPOSITION** dated April 27, 2023, **UNSUPERVISED PROBATION ORDER** dated June 7, 2023, **PLEA / SENTENCE AGREEMENT** dated June 7, 2023, **COMMITMENT RECORD** dated June 30, 2023, **CRIMINAL – BILL FOR COST** dated July 6, 2023, **FORFEITURE ORDER** dated July 12, 2023, and any other attachments associated thereto are **UNCONSTITUTIONAL, NOTWITHSTANDING, NULL and VOID AB INITIO** and are **UNENFORCEABLE** for lack of jurisdiction and fraud;

It is further **ORDERED AND ADJUDGED** that the collusive action and de facto administrative proceedings under color of law in record number 00424942 in the records of the foreign de facto **MARYLAND PAROLE COMMISSION (Inc.)**, and in case numbers C-08-CR-22-000652, C-08-CR-23-000122 and 08-K-13-000884 in the records of the foreign de facto **CIRCUIT COURT FOR CHARLES COUNTY (Inc.)**, including the de facto administrative hearing held on June 7, 2023, and any other attachments associated thereto are **UNCONSTITUTIONAL, NOTWITHSTANDING, NULL and VOID AB INITIO** and are **UNENFORCEABLE** and **CLOSED** for lack of jurisdiction and fraud;
