Re: The collusive action and de facto administrative proceedings under color of law in case number C-08-CR-22-000652 and related case numbers C-08-CR-23-000122 and 08-K-13-000884 (i.e., STATE OF MARYLAND v. LAMONT MAURICE BUTLER); and the void de facto administrative hearing arbitrarily scheduled for March 24, 2023, under color of law by color of authority.

Stare Decisis

See Melo v. United States, 505 F.2d 1026 ("Once jurisdiction is

challenged, the court cannot proceed when it clearly appears that the court lacks jurisdiction, the court has no authority to reach merits, but, rather, should dismiss the action.")

For the record, I am Lamont Maurice EL, a Moorish-American national (not a U.S. citizen or stateless), natural person, in full life, in propria persona (not pro se), sui juris, authorized representative, ex rel. LAMONT MAURICE BUTLER. I am an aboriginal sovereign national to this land by jus sanguinis and as such, you and your private foreign de facto corporation acting as an administrative agency, i.e., CIRCUIT COURT FOR CHARLES COUNTY (Inc.), do not have nor possess lawful jurisdiction or judicial authorization to hear, present, or pass judgment in any matter concerning my affairs under your quasi criminal non-sanctioned tribunal of private foreign color of law process.

Furthermore, your lack of jurisdiction and fraud was proved by conclusive evidence, e.g., the Affidavit of Fact: Default Judgment [Exhibit: E] received by you and entered in the records of case number C-08-CR-22-000652 on or about January 17, 2023; the Affidavit of Fact: Default Judgment [Exhibit: A] received by you and entered in the records of case number C-08-CR-23-000122 on or about March 6, 2023; and the Affidavit of Fact: Default Judgment [Exhibit: A] received by you and entered in the records of case number 08-B-13-000884 on or about March 7, 2023, do to your failure to answer and prove lawful jurisdiction. There was no cause to the contrary made thereto by you.

Your continued attempt to erroneously schedule another unconstitutional de facto administrative hearing for March 24, 2023, for the collusive

action and de facto administrative proceedings under color of law in case number C-08-CR-22-000652 and in related case numbers C-08-CR-23-000122 and 08-K-13-000884 by your color of authority and in want of jurisdiction constitutes fraud and a violation of my right to due process of law secured under Article III, section 2, and the 5th Amendment of the Constitution for the United States of North America; and a violation of my right to consular jurisdiction and venue secured under Articles 20 and 21 of the Treaty of Peace and Friendship of 1836 between the United States of North America and the Moroccan Empire.

WHEREFORE, it is hereby ORDERED and ADJUDGED that a writ of error be and the same is hereby entered against you, James West, Lisa F. Yates, Jonathan Patrick Beattie, and Anthony B. Covington;


It is further ORDERED and ADJUDGED that the collusive action and de facto administrative proceedings under color of law in case number C-08-CR-22-000652 and in related case numbers C-08-CR-23-000122 and 08-K-13-000884 in the records of the private foreign de facto CIRCUIT COURT FOR CHARLES COUNTY (Toc.), including the de facto administrative hearing scheduled for March 24, 2023, and any date thereafter, and any other attachments associated thereto are unconstitutional, notwithstanding, null and void ab initio, and unenforceable for lack of jurisdiction and fraud.
