

Privacy Policy

This Privacy Policy ("Policy") applies to Powerlandgroup.com, and Power Land Group ("Company") and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to the Company include Powerlandgroup.com. Collection of your Personal Information

In order to better provide you with products and services offered, the Company may collect personally identifiable information, such as your:

- First and last name
- Mailing address
