

THIRD SUPPLEMENTAL DECLARATION OF COVENANTS, EASEMENTS, CONDITIONS AND RESTRICTIONS FOR EDGEWATER SUBDIVISION

THIS THIRD SUPPLEMENTAL DECLARATION OF COVENANTS, EASEMENTS, CONDITIONS AND RESTRICTIONS FOR EDGEWATER SUBDIVISION (the "Third Supplemental Declaration") is made as of the 16th day of December, 2002, by M/I Schottenstein Homes, Inc., an Ohio corporation (hereinafter referred to as "Developer").

WHEREAS, on March 30, 2001 Developer filed that certain Declaration of Covenants, Easements, Conditions and Restrictions for Edgewater Subdivision recorded at Instrument Number 200103300065064 in the office of the Recorder, Franklin County, Ohio as supplemented by that certain First Supplemental Declaration of Covenants, Easements, Conditions and Restrictions for Edgewater Subdivision recorded at Instrument Number 200112100286518 in the office of the Recorder, Franklin County, Ohio as supplemented by that certain Second Supplemental Declaration of Covenants, Easements, Conditions and Restrictions for Edgewater Subdivision recorded at Instrument Number 200204170096892 in the office of the Recorder, Franklin County, Ohio (collectively the "Declaration");

WHEREAS, pursuant to the terms of Paragraph I A of the Declaration, Developer reserved the right to annex additional property and to submit any such property to the covenants, easements, conditions and restrictions, and provisions of the Declaration;

WHEREAS, the Developer is the owner of all the real property located in Franklin County, Ohio, more particularly described in Exhibit A attached hereto and incorporated herein by reference and desires to submit such property to the covenants, easements, conditions and restrictions, provisions of the Declaration; and

WHEREAS, the real property described in Exhibit A is part of the additional property;

NOW THEREFORE, pursuant to the powers reserved in Paragraph I A of the Declaration, Developer hereby declares that:

- 1. <u>Defined Words and Phrases</u>. Unless otherwise defined herein, capitalized words and phrases herein shall have the meaning assigned to such words and phrases in the Declaration.
- 2. Additional Property. All the real property described in Exhibit A shall be held, sold, conveyed, encumbered, leased, occupied and improved, subject to the covenants, easements, conditions and restrictions, and provisions of the Declaration as the same is supplemented and amended from time to time, which shall run with the real property described in Exhibit A and shall be binding upon, and inure to the benefit of, all parties now or hereafter having any right, title or interest in such property or any part thereof, and their heirs, personal and legal representatives, successors and assigns.

3. <u>Effect of Amendment</u>. In the case of conflict between the Declaration, and this Third Supplemental Declaration, the terms of this Third Supplemental Declaration shall control.
