ACTION PLAN FOR ASPIRATIONAL DISTRICTS IN TELANGANA

This report was prepared as part of a baseline survey of Aspirational Districts' Programme in Telangana State. The main objective of the report is to understand socio-economic and other factors that led to these districts being termed as aspirational and to suggest strategies for transforming the aspirational districts into well performing districts. Regarding health, it suggests that there is need to increase the strength of ASHA/ANMs to reach health services to each and every household.

The data on education details that there is need to take serious concentration on students from enrolling, continuous education, completion of high school and enrolment. The study found that there is more potential to increase cultivated area in these villages and institutional support system should be set up. With regard to financial inclusion, the flexible financial transactions must be encouraged through rural kiosks. Skills development being important policy framework plays crucial in the present global economic competition with local production linkages which require up-to-date skills. Regarding basic infrastructure, there is need to sanction and lay all-weather roads as some habitations found to be not evident however Individual Households Latrines (IHHLs) reported to be performing better while it is very low in terms of regular usage.

INTERIM REPORT ON TRAINING FOR ALL: INTENSIVE TRAINING PROGRAMME FOR TRIBAL WELFARE CONDUCTED BY MCRHRDI AS PART OF CONCURRENT EVALUATION OF TRAINING PROGRAMMES

The National Training Policy (NTP, 2012) stipulates training for all Civil Servants at the time of their entry into the service and at appropriate intervals during service to equip them to provide effective public service delivery, updated soft skills and customer orientation with a focus on the poor. As part of this, the Department of Personnel Training (DoPT), Government of India launched a special scheme of Training for All (TFA) to provide Intensive Training Programme (ITP) as a way of empowering of grass root level personnel for effective service delivery from citizen rights perspective. Responding to a notification by GoI to launch ITPs in identified

sectors and departments of the state, Dr. Marri Chenna Reddy Human Resource Development Institute of Telangana (MCR HRD IT) set a motion an ITPs in collaboration of Department of Tribal Welfare (DoTW), Government Telangana. As Scheduled Tribes population in the state accounts for 9.08 percent of total population improving the quality of service delivery to marginalised ST communities was aimed at enhancing access to social and economic infrastructure and thereby to social development among STs.

The interim report of the Intensive Training Programme under the TFA scheme was prepared by CSD based on desk review, records and documents; verification on process and procedures followed in training need assessment; identification target functionaries for training, identification of expert resource persons and resource persons for training design, modules and reading material preparation and for TOT; and implementation of training. Apart from these, the report prepared based on the interaction and focus group discussions with expert resource persons (10 members) and also with staff undergone training on basic skills in computers and IT applications (20 members) for a quick assessment of the review of process of training need assessment, training design, modules, and material preparation; and status of TOT and Base Level Training (BLT); and usefulness of training in the case of official under gone training in the basic skills in computers and IT application in terms of improvement of their efficiency in their work in the department and service delivery to the tribals.

The programme covered all functionaries in Tribal Welfare Department in the sectors of education, health, economic development, constitutional safeguards and research. In all the Interim Report observed the training needs to be provided for a target of 5476 personnel working in tribal areas of ITDA Utnoor, Bhadrachalam and Eturunagaram in Telangana state. An important expected outcome as stated in the approach paper to the ITP was development of replicable models for training and capacity building. The identification of Department of Tribal Welfare by MCR HRD IT is commendable given the marginality of tribal communities and their distance from social and economic infrastructure generally.

IMPACT OF MGNREGS ON RURAL EMPLOYMENT AND MIGRATION: A STUDY IN ANDHRA PRADESH

The Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA) is formulated as a right based social security scheme for the poor who depend on wage employment. This study was undertaken to assess the supply and demand side factors and their interplay with work, and the determinants of migration, especially distress migration among the workers in the sample villages.

In order to assess the direct and indirect benefits of MGNREGA, data was collected from 830 households—444 migrants households and 386 non-migrants households—in 27 Gram Panchayats across nine mandals in three Rayalaseema districts of Andhra Pradesh. The mandals and GPs were selected based on the criteria of migration intensity, and low, medium and high participation in terms of average days of employment provided under MGNREGS.

This study was an attempt to analyse the micro-level issues of the poor resulting in lower work participation and under-utilization of the scheme's entitlements, and determining the causative factors for migration in the context of different geographic regions and varied socio-economic backgrounds of the rural poor. Migration contributes significant income for the livelihood improvement of the poor. The implementation of MGNREGS, food security under PDS, social security measures and poverty alleviation schemes did not prevent the labouring poor from migrating. The income generation from all the government support measures and all own income sources together at the native place was much lesser than the income generated at the place of destination. The income from MGNREGS was an important source during lean agriculture seasons for the non-migrants for a substantially large number of households. There were many households that did not participate in wage employment in agriculture, but participated in MGNREGS which underlines its importance for livelihood improvement of the poor.

Migration is dependent on inter play of several push factors from the native place and full factor towards destination. In literature on labour migration, the main push factors associated with migration were lack of employment and income, food insecurity, poverty, depletion of natural resources, family catastrophe, loss of assets, and accumulation of debts, life threat due to community rivalry, and gender and social oppression. The pull factors towards destination on the other hand were identified as higher wages and income, skill up-gradation, contacts and public relations, and better social and economic infrastructure in the destination. It was observed in the study that the households' push towards migration was mainly to generate higher income in the destination to clear their debts and to improve savings and investments in majority of the cases and the migration due to distressed condition in terms of food insecurity and poverty were observed in the case of households dependent on seasonal migration, particularly for wage employment in agriculture and construction labour. The households that migrated to use better social infrastructure like health and education in urban areas were very limited. However, the households migrated with a view to earn more income to provide better and private sector education to their children was evident, particularly in gulf migrants.

TELANGANA SOCIAL DEVELOPMENT REPORT 2020 – REPORT ON EDUCATION AND HEALTH

Education and Health is based on a detailed empirical study on a final sample of around 10,000 cases for education and around 5000 cases for Health drawn from this census multi-stage sampling process completed which was completed over 2019. The final stage of fieldwork covered these around 15000 cases covering 33 districts in 2020-21. TSDR 2021 will be published in mid-2021 – the third consecutive report in this series. TSDR 2021 aims to identify barriers to attaining educational security for all in Telangana state and how health insecurities impede educational security. These are directly linked to attaining the Sustainable Development Goals 3 (Good Health and Well-being), 4 (Quality Education), 5 (Gender Equality) and 10 (Reduced Inequalities). This broad objective is schematised through a set of interrelated questions:

- First, whether and to what extent the right to education was denied or curtailed to children (6-16 years), either through lack of enrolment or drop out and why?
- Second, what are the motives and rationale behind parents' preference for private education, despite a fairly functional and effective education system in Telangana?
- Third, what factors underlie students' choice of courses in higher education?
- Fourth, what is the proportion of adolescent/adult girls (16-29) do not pursue higher education and why?

DYNAMICS OF PARENTAL CHOICE OF SCHOOLING IN RURAL AREAS: A STUDY IN TELANGANA

The main objective of the present study to understand the emergence of private schools and the extent to which this has influenced parental choice of schooling for their children across different socio economic groups. The study would also focus on the learning outcomes of children both in private and public schools. For the present study, both qualitative and quantitative methods are being used. For the present study, Sangareddy district is selected. Out of 27 mandals in the district, 10 rural mandals have been selected and one private and one government school in each mandal are selected to carry out the study using purposive sampling method. The sample for the study consists of teachers, parents and students. The quality of teaching is assessed by interacting with all stakeholders. Specific assessment test will be carried out by covering exclusively students through administering a set of questionnaire for 200 students from both government and private schools. So far, two chapters - Introduction and Review of literature have been completed. Status of District's Education and comparative data on Mandal level schools is completed.

STATISTICAL COMPENDIUM ON THE STATUS OF EDUCATION IN TELANGANA

CSD, Hyderabad produces Telangana Social Development Report (TSDR) for the Government of Telangana (TSDR 2017, TSDR 2018). Now it is under the preparation of TSDR 2020 by conducting a large-scale sample survey, intends broadly to study the educational situation in both rural and urban areas of all 33 districts of Telangana state for efficient planning and monitoring of the development targets at administrative units, such as district level in particular and state level in general. The survey for TSDR-2020 is aimed to explore the specific reasons for (1) children never enrolled in / dropped out of school in the age group of 6-16; (2) parents opting private institutions for their child education; (3) student's choice of courses in higher education; and (4) girls in the age group of 16-29 not in higher education (discontinued after Class X). Hence, the selection process of sample villages, mandals in rural; and towns/wards in urban areas to estimate the reasons mentioned under five themes at districts level is the major objective of the study.

The main objective of the compendium is to generate baseline information on the status of education for the 33 districts. As the size of households covered for the house-listing is considerably big, CSD in this regard proposed to analyse the information for the above 5 indicators and present it statistically for all the 33 districts. The main of the analysis is to help the state for longitudinal surveys on education status keeping the compendium as the base point.

A total of 67927 households from 33 districts covering 80 mandals, 197 villages and 67 wards were undertaken through the house-listing. Apart from this, secondary information was also

collected on different issues of education. The study adopted frequency distribution tools at different level – district, region, social category, etc. to categorize the information.

Finished the analysis of primary as well as the secondary information collected from all the 33 districts.

Map work is going on for the 33 districts. Once it is over, we will validate it once again to check the uniformity of data. Then it will be ready for distribution (electronic).

COVID-19 INDUCED VULNERABILITIES AND COPING STRATEGIES OF SMALL PRODUCERS: TWO CASE STUDIES FROM GUJARAT AND TELANGANA

This study focuses on the supply shocks suffered by agri and allied enterprises in the context of the COVID health pandemic focusing on two of highly perishable products viz., horticulture products from Gujarat and a seasonal food product 'Haleem' in Telangana. Both the products have suffered supply shocks resulting in loss of income and potential employment. This study attempts to understand the magnitude of the vulnerabilities of the stakeholders, coping strategies if any and the approaches to future that may be drawn from the experience of countries that have suffered COVID19 and other epidemics. The specific objectives include to: assess the impacts of the pandemic and preventive measures on demand, livelihoods, production, value addition and marketing of the chosen products; explore the opportunities to improve inputs required to make value added product or fresh products that are directly consumed; understand avenues of collective approach of producers both in production and marketing in the short and long term; assess pre-requirements for producers to shift to e-commerce and cashless transactions; and examine any shift in the preferences for the domestic or export market.

SUSTAINABLE DEVELOPMENT GOALS (SDGS): STATUS REPORT ON CHILD RELATED INDICATORS IN TELANGANA STATE

The 2030 Agenda which was adopted by world leaders in 2015 focuses on 17 Sustainable Development Goals (SDGs), which are in turn underpinned by 169 targets. The central theme of these goals is inclusiveness and the main mottos include: leaving no one behind as well as to improve development outcomes for nations and people through realisation of SDGs. Child rights and its realization are embedded in several of the SDGs. The proposed research aims to measure the distance Telangana state needs to travel to meet the 2030 Agenda goals and targets for children. This would help to identify the development outcomes and priorities of the state relating to the child specific SDGs and their implementation status. The main objectives of the present study are: To examine the status of the indicators identified under each focus areas of Sustainable Development Goals (SDGs) related to child (1, 2, 3, 4, 5, 6, 7, 8, 10, 11, 12, 13, 16 and 17) in Telangana with a special focus on gender, income group, minority, social category and disability against national level given the availability of data; to assess the progress made in each indicators since 2014 and project the outcomes for the next decade; to document all the programmes and schemes that are initiated to achieve the SDGs relating to children and their linkages to specific SDG goal in Telangana and highlight the performance of flagship programmes of the state Government; to prepare an action plan to suggest concrete steps to improve the performance of SDG indicators related to child by highlighting the comparative performances of districts of Telangana through documenting best practices; and to suggest way forward to align the strategies in line with achieving Sustainable Development Goals in Telangana. The study is purely based on the secondary data sources dealing with issues related to children contained in the SDGs.

The aim of the three-day online course is to enhance the knowledge, understanding and capacity of labour administrators on matters relevant to extreme climatic events and status of labour welfare. The specific objectives include sensitization of participants about the impact of extreme climate events on different segments of the labour force and their working conditions; to familiarize about the negative effects of climate instability and extreme weather events on employment vulnerability; and to acquaint the participants on various laws and other social security nets for the workers focusing on climate risk resilience, adaptation and labour security.

ASSESSING MULTI-DIMENSIONAL POVERTY IN INDIA FOR THE SUSTAINABLE DEVELOPMENT GOALS: ADAPTATION AND USE OF THE CONSENSUAL APPROACH IN SOUTH INDIA

This project tests the suitability of an internationally validated method of poverty assessment - the Consensual Approach - in the Indian context. The approach surveys a representative sample of the population, asking respondents what they consider it to be necessary for an acceptable standard of living. They are asked about the items related to material needs (such as food, housing), access to services (like education and healthcare), and also about activities relating to important elements of social participation. These broader aspects of everyday life are rarely incorporated in or considered by conventional measures of poverty despite forming the basis of internationally-agreed definitions of poverty.

The study intends to identify a set of socially perceived necessities, and whether the households lack such necessities primarily because of lack of resources or of personal choice.

The study seeks to validate the suitability and significance of the Consensual Approach to Poverty through a survey of about 5000 households spread across all the 13 districts of Telangana.

Primary survey of 4000 households has just been completed. The analysis of the data and results would be completed within next three months

WOMEN'S EMPLOYMENT, INTERSTATE VARIATIONS AND TIME-USE: A COMPARATIVE STUDY OF BIHAR AND TELANGANA

Azim Premji University, Bangalore – Project is being managed at BITS Pilani, Hyderabad)

Women's participation in labour force in India has historically been low. Recent years witnessed a further decline. This low and declining female labour force participation generated competing hypothesis and contesting claims. However, the debate ignored an important dimension: huge interstate variation in labour force participation of women. The study intends to examine the empirical validity of competing claims and employs multiple methods to assess women's participation in labour force in India.

The study examines three interrelated questions. First, why do labour force participation rates of women remain so low in India and why are inter-state variations huge and unchanging over the years? Second, whether such huge inter-state variations are primarily a product of, or utterly unrelated to, structural transformations and nature of economic growth? Third, can and to what extent time-use studies and alternative concepts of work capture the gamut of changing, intermittent and simultaneous but multiple jobs increasingly done by women in India?

The study employs multiple methods of data collection, such as a primary survey using NSSO methodology, activities-based assessment and a time-use survey. Intensive fieldwork was carried in a village each in Bihar and Telangana.

Lecture Series

K.G. Kannabiran Lectures on Law, Justice and Human Rights November 2020 to February 2021

Ten years after his death, a lecture series was organised in memory of civil liberties advocate KG Kannabiran to celebrate his spirit, his resistance and his constitutional insurgencies in courts and through courts and tribunals — in defence of dissent, personal liberty, associational freedoms, justice; speaking truth to power; calling for judicial accountability; and state accountability especially in the matter of repressive laws, custodial violence and extrajudicial murders — encounter killings; calling out entrenched practices of discrimination and structural violence; and setting out the basic structures of constitutional rule.

The lectures – the first series of its kind in India – were delivered on YouTube by lawyers, legal scholars and judges who knew him personally and worked with him on cases, campaigns and tribunals — to remember their collaborations with him and reflect on future pathways of this important slice of the history of lawyering for human rights and civil liberties — rooted in the Indian experience.

KG Kannabiran (1929-2010) lived and worked in the undivided state of Andhra Pradesh, in Hyderabad. He travelled across the country appearing in courts of trial and high courts and in peoples' tribunals and fact finding missions. From Kashmir, Assam and Manipur to Tamil Nadu, Chhattisgarh to Gujarat to Punjab to Karnataka and beyond; within Andhra every nook and corner, every forest and town bear his footprints. Practically every court of every jurisdiction in the state bears his imprint. In his untiring defence of the rule of law and the constitution, and in his quest for justice, no place was out of bounds.
