

**West Gardiner Rod and Gun Club  
Release and Assumption of Risk**

I voluntarily agreed to participate in the West Gardiner Rod and Gun Event on \_\_\_\_\_(date) and/or voluntarily agree to allow my child to participate in the West Gardiner Rod and Gun Club Event (Event) and voluntarily execute this "Release and Assumption of Risk" on behalf of myself, my heirs and next-of-kin, my personal representatives and my estate.

That the West Gardiner Rod and Gun Club (hereinafter referred to as WGR&GC) has informed me that there may be dangers and hazards inherent to myself or my child as a result of participating in the Event because of the activities involved, and that I personally recognize and appreciate that such dangers and hazards exist for myself or my child. I accept and assume full responsibility for all harm and injury, of every nature, including death, which may occur to myself or my child or which I/she/he may suffer or cause to others, and for all damages or loss to any personal property owned by me or damaged by myself or my child while participating in the Event and during all travel and transportation, and, in furtherance thereof, I agree to indemnify, hold harmless and release WGR&GC, it's volunteers and agents, from and against any and all claims, demands, actions or causes of action, on account of damage or loss to my personal property, my/my child's injury or death, or the bodily injury, death or damage to personal property of others caused by myself/my child which may occur or result directly or indirectly from my/my child's participation in the Event and not as a direct result of any negligent act of WGR&GC, it's volunteers or agents.

I understand that a WGR&GC member may require a fisherman or family member who is not listening to instructions or otherwise acting in an unsafe manner to leave the pond area until such time as the WGR&GC member feels that the safety requirements are being complied with.

I declare that myself/my child is able to physically withstand and cope with the indicated rigors of the Event with or without a reasonable accommodation. In complying with the letter and spirit of applicable laws and pursuing its own goals of diversity, WGR&GC does not discriminate on the grounds of race, color, religion, sex, sexual orientation, including transgender status and gender expression, national origin, citizenship status, age, disability, genetic information or veteran status in employment, education, and all other programs and activities. WGR&GC provides reasonable accommodations to qualified individuals with disabilities upon request. Any person with a disability who needs accommodations for this program should contact Richard Platt, WGR&GC President to discuss their needs at least [5] days in advance.

This "Release and Assumption of Risk" shall be construed and interpreted pursuant to the laws of the State of Maine, and if any portion thereof is held invalid, void, unenforceable or illegal, the remainder shall continue in full force and effect.

I declare that I completely understand and have fully informed myself of the terms and conditions of the release and assumption of risk by having read it, or having it read to me, before signing and I intend to be fully bound thereby.
