  - B. Acceptance of Director's Report
    - January activities- 3 local authors will be visiting the library to promote their recently published works. Have a 4<sup>th</sup> individual also looking to come do a reading.
    - Personnel- individual who ran Navigator program quit so it's on pause at the moment. Still distributing Dial-A-Ride tokens since over 45% of individuals who came in were looking for transportation aid. Looking for graduate student who can take this work on as a part time job. Only have 6 months remaining of funding until the current grant runs out.
    - Building Detection Security will start working on camera system shortly then will move on to the fire alarm. Aiming to have both projects completed by our next board meeting in February.
    - Worked with Charleston Police Dept after a bullet was left in the Book Drop. Reinforced need to add security cameras in the building which are coming soon.
  - C. Acceptance of Statistics Report
    - Circulation at 22% YoY increase. Updated 2023 recap and review showing 81k items circulated in 2023 which exceeded goal of 70. Nearly returning to pre-pandemic levels. Nearly doubled ecirculation since 2020
