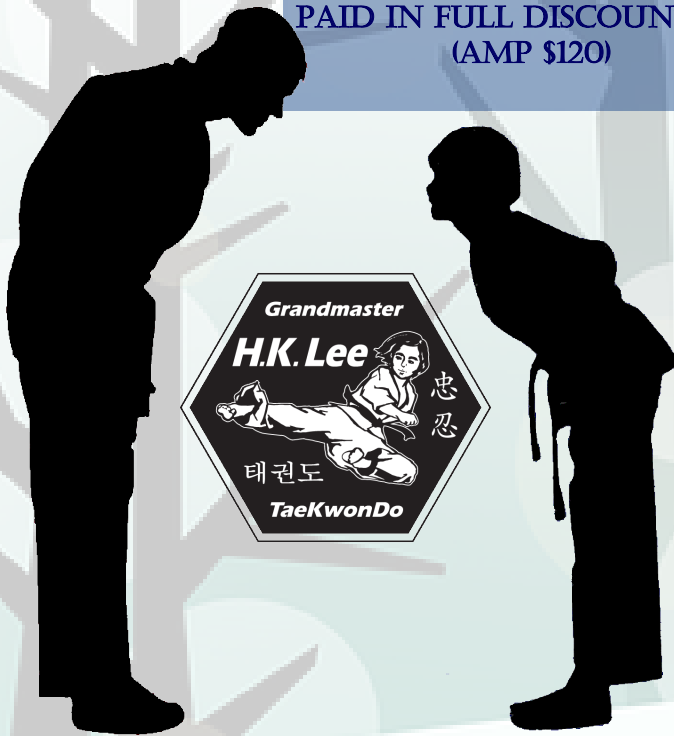

TERMS

Parties: This agreement is executed on the Registration Date shown above, by and between H.K. Lee Academy of TaeKwonDo, its successors, assigns and those acting under its authority, herein referred to as Academy, the Buyer, who’s signature is affixed hereto, herein known as Buyer and each Student listed above, herein referred to as Student for the purposes of attending H.K. Lee Academy of TaeKwonDo Winter Camp, hereinafter referred to as Camp.

Attendance: Academy agrees to provide martial art instruction to each Student during the schedule above, Buyer and each Student understand that it is the responsibility of each Student to attend Camp. Buyer understands that the entire Balance Due is payable according to this agreement, regardless of whether or not each Student attends Camp provided by Academy. Academy reserves the right to revoke this Agreement at any time.

Schedule: Buyer and each Student understand that the Field Trips provided by Academy are subject to change due to availability or weather. Camp will operate as scheduled with a minimum of 10 children registered by Dec. 10th.

Finance: All payments shall be presented to the bank on the date of receipt, the specified billing date or the last business day before the due date. If payment is not received prior to the close of the business day before due, it will be charged to your account on file. There will be a \$20.00 service fee for any returned checks, or decline debit/credit payment. If payment is not received on or before the due date, a \$20.00 late fee shall be assessed for the first three business days and \$5.00 for each day thereafter. Balance Due shall become immediately due in full if the Account is deemed in default by more than two weeks and may be submitted to a collection agency. Certifications shall not be issued unless all payments are current. Uniforms, seminars, exams, tournaments, etc. are not included in the tuition terms of this Agreement.

Liability: Buyer, hereby acknowledges the strenuous physical exercise involved in the participation of Camp given by Academy and that each Student attends Camp at their own risk. Buyer and each Student hereby consent to hold Academy, owner, staff and assigns free of any and all liability, claims, or actions whatsoever, arising from any injuries, accidents, illness, etc., due to Student’s attendance at Camp. Further, Buyer and each Student understand that Academy, owner, staff and assigns are not responsible for damaged, lost or stolen articles inside or outside Academy.

Media: Buyer and each Student, irrevocably authorize the Academy to copyright, use, publish for art, advertising, trade or any other lawful purpose whatsoever, photographic portraits, pictures and videotapes of Student and/or Buyer, included in whole or in part.

Force Majeure: Academy is not liable for failure to perform its obligations if failure results from “Acts of God”, including, but not limited to: fire, flood, earthquake, storm, hurricane or other natural disaster, government intervention, embargo, labor dispute, or failure of utility services.

Severability: Agreement provisions which are or become illegal, invalid or unenforceable shall not affect the validity or enforceability of other Agreement provisions.

Consumers’ Right of Cancellation: Buyer may cancel Agreement penalty free within three days of registration date, exclusive of holidays and weekends, upon mailing or delivering a written, certified notice of cancellation to Academy. However, Buyer’s right of cancellation is expressly waived once Student has engaged in Camp, or made use of the facility or equipment provided by the Academy.
