## Warranties

All warranty work is pro-rated. Warranties during the first full year (beginning at the point of delivery) will be covered 100%, including freight and/or delivery fee.

Every year after the first year will be pro-rated, with freight and/or delivery fee being paid by the claimant, to Nu Look Revinyling, Inc. and back.

### Frames Warranty

#### **Covers:**

- Aluminum (new Frames).
- Welds (unless previously discussed).
- Powder Coating.

#### **Time Period**

- 5 years against any defect in the application of powder coating, and weld breakage. Vandalism and acts of God are not covered. Normal wear and tear, or scratched surfaces are not covered.

### Straps Warranty

#### **Covers:**

- Virgin Vinyl Strapping.

#### **Time Period**

- 5 years against breakage only.
- 2 years against discoloration with normal care and maintenance. Strap replacement due to discoloration is at the vinyl supplier's discretion. Labor is not included.

## Table Tops Warranty

### **Covers:**

- Fiberglass.

### **Time Period**

- 3 years against bowing and warping.
- Acrylic tops have ***no warranty***

## Umbrella Warranty

### **Covers:**

- Recovers (see Sunbrella 5-year Limited Warranty)

### **Time Period**

- 1 year warranty against workmanship defects.

### **Covers:**

- New Umbrellas

### **Time Period**

- 1 year warranty against manufacturers defects.

## Sunbrella Fabrics (Sling and Cushion and Acrylic Umbrellas covers)

### Sunbrella Upholstery Fabrics\*

#### Sunbrella Sling

Sunbrella's 5-year limited warranty provides unsurpassed protection, guaranteeing against our fabrics becoming unserviceable due to:

- Loss of color
- Loss of strength
- Abrasion
- Pilling

from normal usage and exposure conditions, including sunlight, mildew, and atmospheric chemicals when used for appropriate applications.

**Note:** This warranty does not cover normal care and cleaning; damage from misuse or abuse; improper installation; or costs associated with replacement of the fabric, including labor and installation, except as noted in this warranty. Glen Raven's liability is expressly limited to this warranty. Glen Raven reserves the right to require proof of purchase and inspect any fabric submitted for claim. Claims requesting reimbursement for labor costs must include a detailed summary of those costs.

## Phifertex (Sling)

This warranty covers the fabric becoming non-functional because of loss of dimensional stability from exposure conditions including sunlight, mildew, rot and normal atmospheric conditions.

Abnormal or excessive discoloration and fading is covered. It does not cover discoloration from atmospheric pollution or other debris.

The warranty coverage runs for 3 years from the date of purchase.
