Therefore, the guest releases and forever discharges, and for his/her heirs, executors, administrators, personal representatives, successors, and assigns to hereby release and forever discharge the Outfitter (Powderkegg Wildlife Preserve) and his or her, their and its successors and assigns, heirs and executors, administrators, personal representatives, and all other persons, firms and businesses, of any claims, demands, rights, and causes of actions of whatsoever kind and nature, arising from, and by reason of any of all known and unknown, foreseen and unforeseen bodily and personal injuries, damage to property, and the consequences thereof, resulting, and the result, from the guest's horse ride on the dates written in this contract. Additionally, the guests agree to defend any or all individuals in civil court against injury, property or punitive damage caused by the guest while horse riding with the Outfitter. If I, the guest, sue any and all individuals in civil court and win a settlement, I, the guest, relinquish all rights to receive that settlement from any of the aforementioned individuals.
