EPRA / Brissa's Magical Moments Covid-19 Waiver Form

COVID-19 has been declared a global pandemic by the World Health Organization (WHO). COVID-19 is extremely contagious and is believed to spread mainly through person-to-person contact.

Therefore, local, provincial, and federal government authorities recommend various measures and prohibit various behaviors, all with the aim of reducing the spread of the virus.

EPRA/Brissa's Magical Moments commits to comply with all the requirements and recommendations of the Public Health of Quebec and other government authorities, and to put in place and adopt all the measures necessary for this purpose.

However, EPRA/Brissa's Magical Moments cannot guarantee that you (or your child, if the participant is a minor / or the person for whom you are the tutor or legal guardian) will not be infected with COVID-19. In addition, your participation in activities could increase your risk of contracting COVID-19, despite all the measures in place.

By signing this document,

- 1. I recognize the highly contagious nature of COVID-19 and I voluntarily assume the risk that I (or my child, if the participant is a minor / or the person for whom I am the guardian or legal representative) could be exposed or infected by COVID-19 through my (his/her) participation in EPRA's/Brissa's Magical Moments activities. Exposure to or infection with COVID-19 can cause injury, illness, or other conditions.
- 2. I declare that my participation (or that of my child, if the participant is a minor/ or the person of whom I am the tutor or legal guardian) in the activities of EPRA/Brissa's Magical Moments is voluntary.
- 3. I declare that neither I (or my child, if the participant is a minor / or the person for whom I am the tutor or legal guardian), nor anyone living under my roof, has shown symptoms of a cold or flu (Including fever, cough, sore throat, respiratory illness or difficulty breathing) in the past 14 days.
- 4. If I (or my child, if the participant is a minor / or the person of whom I am the guardian or legal guardian) experience symptoms of cold or flu after the signing of this declaration, I (or my child, if the participant is a minor / or the person for whom I am the tutor or legal representative) undertake not to present myself or participate in EPRA's /Brissa's Magical Moments activities for at least 14 days after the last manifestation of symptoms of colds or influenza.
- 5. I declare that neither I (or my child, if the participant is a minor / or the person for whom I am the tutor or legal guardian), nor any person living under my roof, has traveled or stopped over in the last 14 days in a region for which the provincial government or Quebec's public health authorities recommend a period of isolation upon return.
- 6. If I (or my child, if the participant is a minor / or the person of whom I am the tutor or legal guardian) travel to such a region after having signed this declaration, I (or my child, if the participant is a minor / or the person for whom I am the tutor or legal representative) undertake not to present myself or participate in EPRA's/Brissa's Magical Moments activities for at least 14 days after the return.

This document will remain in effect until EPRA/Brissa's Magical Moments receives instructions from the provincial government authorities and the Quebec Public Health, to the effect that the commitments contained in this declaration are no longer necessary.

In the event that I sign this document for myself, I hereby declare that I have fully understood and accepted the risks and conditions set out above and I waive my right to any claim against EPRA/Brissa's Magical Moments, its representatives and/or employees related to my practice of the activities. I would like to participate in the activities of EPRA/Brissa's Magical Moments.

If I sign this document for a minor or minors, I hereby declare that I am the legal guardian of the minor participant(s). I also declare that I have informed the minor participant(s) about the content of this acknowledgement and acceptance of risks and I confirm that they agree with its terms and conditions.

In the event that I sign this document for a minor or minors, I sign this acknowledgement and acceptance of risks of the minor participants) and on their behalf(ves), and I consent, with full knowledge of the risks and conditions outlined above, that the minor participant(s) participate(s) in the activities of EPRA/Brissa's Magical Moments.

Chalet Protocol - Ville de D.D.O.

- Wearing a mask is mandatory while walking around, for people over 12 years of age.
- When entering and leaving the chalet, each individual must wash hands or hand sanitize.
- Participants must respect the 1m (3 ft) social distance unless they live under the same roof or as per current Quebec Government guidelines.

Group Leader will:

- Keep an Attendance Registry
- Evaluate the physical condition of each participant and check any sick participant.
- Strictly enforce exclusion of all participants that have related COVID-19 or flu symptoms.
